Introduction

This pedigree is based on the pedigree on the family tree given on page 260 in Chapter 20 of 'Audley Pedigrees' by A. L. Reade. That original family tree contained 5 people. It has now been expanded to 33 people. All of the people in this family were born in Liverpool with the exception of {G2} Alexander Audley and his Wife Mary Monaghan, who were both born in Ireland. Alexander and Mary were married in 1854 in Liverpool. Neither Alexander Audley nor Mary Monaghan has been identified in the 1851 Census and therefore it is speculated that they emigrated from Ireland to England after 1851 and before 1854. There is no evidence as to from where in Ireland they came.

Origins of Audley Family 'G'

The earliest documented evidence we have of this family is on the 26th February 1854 when {G2} Alexander Audley married Mary Monaghan at St Peters Priory "Roman Catholic Church" in Seel Street, Liverpool. Both Alexander and Mary appear to have been illiterate as they both sign their Marriage Certificate with an **X** (*i.e their Mark*). Additionally both their witnesses also sign the official record with an **X**.

It is believed that both Alexander Audley and Mary Monaghan were Born in Ireland based on their places of Birth listed in the 1861, 1871, 1881 and 1891 Censuses of England. Unfortunately there is no evidence to indicate from which part of Ireland either of them came. It is interesting to note that in the 1861 Census of England their surname is recorded as Ordley and were living in at 52 New Bird Street, Liverpool. In fact they and their 4 children are the only people recorded with the Ordley surname in the 1861 Census of England. At the time of the 1861 Census they are living at the same address as a family with the surname Adderley. In the 1871 Census of England they were living at Britton Street, Liverpool and their Surname is recorded as Arderly. They are the only family in the 1871 Census of England recorded with the surname Arderly (Comment: There is 1 person in the 1871 Census of England with the surname Arderley, a Servant, living in Everton, Liverpool, England)

Alexander Audley's Father is recorded on his Marriage Certificate as Francis Audley and there is no evidence to suggest that Francis Audley ever came to England


Possible links to families in Ireland


- 1) Whilst there is no direct link to this family, it may be of interest that there is an Alick Adley aged 34, with a Son also called Alick Adley in the 1901 Census of Ireland Resident of a House 46.1 in Newmarket (Merchants Quay, Dublin)
- 2) In the 'Griffiths Valuation of Ireland' in the Town of Roscommon there are two references to a Francis Audley as follows:
 - The first is at the location referenced as 19 Church Street, Roscommon. Townland of Ardnanagh.

 The Occupier was Francis Audley. The Immediate Lessors was Thomas Hannan; The description of the Tenement was 'Forge and Yard'. No area was stated; The Rateable Annual Valuation of the building and the total Annual Valuation of the rateable property was £1 0s 0d.
 - The second is the location referenced as 24 Church Lane (off Church Street) Town of Roscommon Township of Ballyphesan. The occupier was Francis Audley; The immediate lessor Michael Shearn; The description of the tenement was 'House and small garden' No area was stated The Rateable Annual Valuation of the building and the total Annual Valuation of the rateable property was £1 15s 0d.

It is believed that both the above Francis Audley's are the same person. It should be noted that the boundary between the Townships of Ardnanach and Ballyphesan ran down the centre of Church Street.

At, 1 Court, Crump, Street, House No 3, a Porter in a Seed Warehouse in 1881; at 18 Crump Street, Liverpool, a Cotton Porter in 1891. Died Q1 in 1900, aged 60 at Liverpool. Married on the 26th February 1854, at St Peter's Priory "Roman Catholic" Church, Seel Street, Liverpool, to MARY MONAGHAN, and Daughter of Patrick Monaghan, a Labourer. Their marriage record indicates that they were living at New Bird Street. She Died on the 29th May 1887 aged 49, at 6 Court, Crump Street and was Buried on the 1st June 1887 at Ford "Roman Catholic" Cemetery, Litherland, Liverpool. They had issue,
 - 1. {G3} **BRIDGET (BADALIA) AUDLEY**, born on the 6th January 1855, at 12 Court, New Bird Street, Liverpool. Of, 52 New Bird Street, Liverpool, a Scholar in 1861. Of No 1 Court 3 Britton Street, Toxteth Park, Liverpool, a Charwoman in 1871. Of 24 Jordan Street, Liverpool (as Bridget Norris) in 1881; Of 3 House, 7 Court, Blundell Street, in 1891 (as Bridget Norris) in 1891; Of 192 Upper Frederick Street, (as Bridget Norris) in 1901. Married (as Badalia Audley), on 10th June 1878, at St Michael in the City, Liverpool, to GEORGE NORRIS. At the time of their Marriage she gave her address as 1 Court, Crump Street, Liverpool, and had issue
 - 2. {G4} MARY ANN AUDLEY born on the 22nd January 1857, at 18 Jamaica Street, Liverpool. Of 52 New Bird Street, Liverpool, a Scholar in 1861. Of No 1 Court, 3 Britton Street, Toxteth Park, Liverpool, a Charwoman in 1871. Of 42 New Hall Street. (as Mary A Early) in 1881. Of 20, Crump Street, Liverpool, (as Mary A Early), in1891. Of 141 Upper Frederick Street, Liverpool, (as Mary A Earley) in 1901. Of 24 Upper Pitt Street, Liverpool, (as Mary Ann Early), in 1911. She married on the 30th September 1878 at St Vincent de Paul, Liverpool, to SAMUEL PETER EARLEY. She died Q3 in 1913, aged 54(sic), at Liverpool. They had issue.
 - 3. {G5} **ELLEN AUDLEY**, born on the 31st March 1859, at 52 New Bird Street Liverpool. Of 52 New Bird Street, Liverpool, a Scholar in 1861. Of No 1 Court, 3 Britton Street, Toxteth Park Liverpool in 1871. Of, 1 Court, Crump Street, 3 House, Liverpool, Lancashire, England, a Warehouse Woman in 1881. Married (as Helen Audley according to the RC Parish Register; although the GRO Index refers to her as Ellen Audley) on the 23rd January 1882, at St Patrick RC Church, Liverpool, and also Toxteth Park Register Office, to RICHARD McKIVETT. (Comment: The Toxteth Park Register Office has the entry twice in its records as there is uncertainty as to whether the Groom's surname is McKevitt or McKivett:) She gave her address as 3 Crump Street, on her Marriage Certificate. (Comment: It would appear that {G5} and {G7} married Brothers and neither family can be identified in England in any of the 1891, 1901 or 1911 Censuses of England)
 - 4. {G6} FRANCIS (aka FRANK) AUDLEY. born in *1861, (Based on the 1851 Census of England) in the Parish of St Patrick's, Roman Catholic Church, Toxteth, at Liverpool. (Comment: The Birth registration or a record of his Christening for {G6} has not been identified however in the GRO Indexes there is the registration of the Birth Q1 in 1861, of a Francis Handsley There is also the record of the Baptism of a James Francis Hansley on 31st March 1861, Born on the 12th March 1861 at St Mary's Roman Catholic Church Liverpool. (The parents for this Christening are Edward Hansley and Mary Ann formerly Farrell). Of 52, New Bird Street, Liverpool, (as Francis Ordley) in 1861. Of No 1, Court, 3, Britton Street, Toxteth Park, Liverpool, in 1871 (as Francis Arderly). Of No 1 Court, Crump Street, 3 House, Liverpool, Lancashire, England, a Venetian Blind Maker, (as Frank Audley) in 1881. (He has not been identified in the 1891 Census) Of 23 Hyslop Street, a Shipyard Labourer, (as Frank Audley) in 1901. Of 21 Durham Place, Roscoe Lane, Liverpool, a Butcher at Birkenhead Abattoir (as Francis Audley) in 1911. He Enlisted in the British Army on a 4 years 'Territorial Attestation' Form on the 30th April 1909, at Liverpool, classed as 'Fit' for

The information in the Censuses of England for the ages of {G2} Alexander Audley (Head) and Mary Audley, his Wife does not tie in with their ages in their Marriage Certificate according to A. L. Reade

Territorial Forces, and joined the 8th (Irish) Battalion "The Kings" (Liverpool Regiment), Regimental No #1050. His occupation was a Dock Labourer with the Larrinaga Shipping Co, of Chapel Street, Liverpool, and aged 31 years, 9 months., (*age recorded 31 Years 9 Months, could he have underestimated his age in Army Records?) Home address was 3, Mount View, Rathbone Street, Liverpool, and his Wife named as 'Mary Anne'. His 'Territorial Army' Annual Training Record noted that he was located; at Caerwys, North Wales in August 1909, Halton, Lancashire in July1910, Conway, North Wales in September 1911, Cambridge in September 1912, and Denbigh, North Wales in July/August 1913. He was 'Embodied' in Full Time Army Service from August to the 17th December 1914. The Battalion landed at Le Havre on the 13th August with the 6th Brigade, 2nd Division, one of the original components of the British Expeditionary Force (BEF). He returned Home having been Discharged from Army Service on the 18th December 1914, at Canterbury Of, No 1, Court, 3, Britton Street, Toxteth Park, Liverpool, in 1871 (as Francis Arderly). Of No 1 Court, Crump Street, 3 House, Liverpool, Lancashire, England, a Venetian Blind Maker, (as Frank Audley) in 1881. (He has not been identified in the 1891 Census) Of 23 Hyslop Street, a Shipyard Labourer, (as Frank Audley) in 1901. Of 21 Durham Place, Roscoe Lane, Liverpool, a Butcher at Birkenhead Abattoir (as Francis Audley) in 1911. He was killed (with 2 other men) when the Warehouse, (located in the "Old Goree", Liverpool) he was working in there when it collapsed on Monday 1st April 1919. At the time of his Death he was aged 43 and living at 5 Duncan Street, and was Buried in Ford Cemetery, Litherland, Liverpool, on the 7th April 1919. (In his Death and Burial records they refer to him as Francis Audley). He married (as Francis Audley) on the 5th December 1896 Registrar attended at St Patrick's "Roman Catholic" Church, Chapel, Park Place, Toxteth Park, according to Roman Catholic Rites, to MARY ANN MURPHY. Mary Murphy, then 41 years old, Married 2nd as Mary Ann Audley, a Widow, on the 4th October 1919, at St Vincent de Paul's "Roman Catholic" Church, St James Street, Liverpool, according to Roman Catholic Rites and Ceremonies, to Christopher Carroll, a Boiler Scaler, and Son of Joseph Carroll, a Salt Heaver, (Deceased). Mary was living at 5, Duncan Street at the time of her 2nd Marriage.

(Comment: There would appear to be inconsistent data within the information for {G6} as follows: Three sources of information regarding his Death on the 1st April 1919 namely his Death registration; his Burial record and the report of his Death in the Guardian all give his age at the time of his Death as 43 years. If this is correct it would mean that he would have been born between April 1875 and March 1876. The 1861, 1871 & 1881 Census of England data proposes that his Birth was Q1 in 1861.) The following table records his age and calculated Birth year for the Censuses of England from 1861 to 1911 Marriage and Death information..

(Comment: It is therefore concluded that from his Marriage onwards he underestimated his age possibly because his Wife was significantly younger than him.)

- 5. {G7} ROSE ANN AUDLEY born in 1864 Liverpool. Of No1 Court, 3 Britton Street, Toxteth Park, Liverpool, in 1871. Of 1 Court, Crump Street, 3 House, Liverpool, Lancashire, England, "In Warehouse", noted as her occupation in 1881 Census. She Married on the 7th June 1889 to MICHAEL McKEVITT, son of Bernard McKevitt, at St Patrick's "Roman Catholic" Church, and at Toxteth Park Register Office. On her Marriage Certificate she gives her address as 48 Mann Street. Rose Audley had issue before her marriage:
 - (Comment: It would appear that $\{G5\}$ and $\{G7\}$ married Brothers and neither family can be identified in England in any of the 1891, 1901 or 1911 Censuses of England)
 - i) {G8} **ALEXANDER AUDLEY** born on the 5th January 1883, at 12 Crump Street, Liverpool, and Baptised on the 6th January 1883 at St Vincent de Paul "Roman Catholic" Church,

Liverpool. He Died Q1 in 1883 aged 3 weeks and was Buried at Walton Park Cemetery on the 23rd January 1883.

- 6 {G9} MARGARET AUDLEY born Q2 in 1868, at Liverpool. Birth registered in West Derby. Of No 1 Court, 3 Britton Street, Toxteth Park, Liverpool, in 1871. Died, Q2 in 1886 aged 18 in Liverpool. She was Buried on the 30th May 1886 at Ford "Roman Catholic" Cemetery, Litherland, Liverpool.
- 7. {G10} ALEXANDER AUDLEY born on the 4th April 1871 in Liverpool, and was Baptised on the 11th April 1871, at St Vincent de Paul "Roman Catholic" Church, Liverpool. He was living at 18 Crump Street, Liverpool, a Dock Labourer, in 1891. He was living at 1 in 11 Court, Wolfe Street, Toxteth Park; a Labourer at a Shipyard in 1901, his age was noted as 27. In 1908 he was described as a Builder's Labourer. Of Toxteth Park Workhouse, 126, Smithdown Road, Liverpool, a General Labourer in 1911. It has not, as yet been identified where he was living in the 1921 Census of England, although a record has been found for his Wife. He died at 147 Mill Road (West Derby Infirmary), and was interred in Ford "Roman Catholic" Cemetery, Litherland, Liverpool, in a "Public Plot" on the 7th July 1938, aged 66 years. Married on the 26th November 1892 at St Patrick's "Roman Catholic" Church, and also at Toxteth Park Register Office to BRIDGET ELWARD, She was Born Q4 in 1874, the Daughter of Nicholas Elward. In the 1921 Census of England, it is believed she was living at A Lodging House at 44 and 46a Everton Brow, a Washer Woman. The 1921 Census of England indicates that she is Married, living and working at the same address 'Todfing House' 46a Everton Brow at the time of her Death, Bridget Audley was living at 42, Belmont Road, Liverpool 6, in 1954. She was interred in Yew Tree "Roman Catholic" Cemetery, West Derby, Liverpool, on the 10th March 1954, aged 79 in a "Public Plot", and had issue:
 - I. {G11} THOMAS FRANCIS AUDLEY born on the 21st March 1893 at Toxteth Park, Liverpool and was Baptised on the 26th March 1893 at St Patrick, Liverpool. He was at 1 in 11 Court, Wolfe Street, Toxteth Park, in 1901. Of Rice Lane Workhouse, Walton on the Hill, West Derby, Liverpool, in 1911. It is believed that during WW1 he served (as Frank Audley) in the Mercantile as a Ship's Trimmer aboard 'RMS Andes' of the Royal Mail Lines Fleet. Of 34 New Henderson Street a Casual Labourer (Out of Work) in 1921. Of 34 Henderson Street, Liverpool C B in 1939. In the 1939 Registers he is described as Incapacitated (Blind). He was living at 12b Grey Street, Liverpool 8, in 1960, and was interred in the Ford "Roman Catholic" Cemetery, Litherland, Liverpool, on 5th October 1960, aged 67 years. He Married BRIDGET LUNT formerly Connor in Q4 in 1920, at Toxteth Park Registry Office. She was Born on the 7th June 1894, at Toxteth Park; she had previously Married, as Bridget Connor, to John T Lunt, on 7th December 1912, at St Patrick's Roman Catholic Church, Toxteth Park. John T Lunt Died in Q4 1915, aged 21, at Toxteth Park and was Buried on the 8th December 1915 at Allerton Cemetery. At the time of John Lunt's Burial he is described as a Labourer of 156 Upper Mann Street. Bridget had three Sons from her 1st Marriage, John Thomas Lunt, born Q1 1913 at Toxteth Park, and he was living with the Audley family in 1921; James Lunt born Q2 1914; at Toxteth Park and Died Q4 1914 at Toxteth Park; and Joseph Lunt born and died Q4 1915 at Toxteth Park. Bridget was living at 12 Thornton Place, Liverpool 8, in 1982, and was interred in the same grave as Thomas Audley on the 3rd March 1982, aged 87 years. Thomas Francis and Bridget had issue:
 - a) {G17} **THOMAS FRANCIS AUDLEY,** born on the 29th January 1921, at 34, New Henderson Street, Toxteth Park, Liverpool. Of 34, New Henderson Street in the 1921 Census of England. He was Buried aged 20 months at Ford "Roman Catholic" Cemetery, Litherland, Liverpool, on the 31st October 1922. At the time of his Death he was living at 34, Henderson Street, Liverpool.
 - b) {G18} **ROSE ANN AUDLEY**, born Q2 in 1922, and Buried aged 14 months at Ford "Roman Catholic" Cemetery, Litherland, Liverpool, on the 26th July 1923. At the time of her Death she was living at 34 New Henderson Street Liverpool
 - c) {G19} **EDWARD FRANCIS AUDLEY** born on the 9th June 1925 at Liverpool. In 1939 he was living at 34, Henderson Street, Liverpool C B, Lancashire described as 'at

She was Born on the 25th May 1917 and was previously the Wife of a Charles Hewitt. She was of 23e Caugh Gardens, Liverpool C B undertaking unpaid Domestic Duties in 1939, and she Died in January 1997, aged 79, at Knowsley, Liverpool.

- 1) {G26} **FRANCIS EDWARD AUDLEY**, born on the 10th October 1945, at Liverpool S, (Comment: But his Birth was not registered until Q3 in 1954. In the GRO Index his name is recorded as Frances but in the Liverpool Exchange Register Office his name is recorded as Francis) He Died in March 2004, at Liverpool. He Married 1st Q3 in 1969 to EILEEN M GALLAGHER in Liverpool and Married 2nd Q2 in 1980 to FRANCES COLLINS in Liverpool.
- 2) {G27} **MICHAEL AUDLEY**, born Q4 in 1945, at Liverpool S (But his Birth was not registered until Q3 in 1954). He married ANNE M SANDIFER Q2 in 1969, at St Gabriel's Church, Huyton Quarry, in Prescot, Merseyside. They had issue
 - I) {G29} **JOANNE HEATHER AUDLEY** born Q3 in 1970 at Liverpool and Married in April 2001 in Cheshire East to WILLIAM HALLSWORTH.
 - II) {G30} LORRAINE DENISE AUDLEY born Q3 in 1972 at Prescot.
 - III) {G31} ANGELA LOUISE AUDLEY born Q1 in 1976 at Knowsley
- 3) {G16} **PATRICIA AUDLEY** born Q4 in 1947, in Liverpool. S. She married Q4 in 1969 at Liverpool to THOMAS DYKES. They had issue.
- 4) {G25} THOMAS FRANCIS AUDLEY, born 7th July 1949 at Liverpool .S, and he Died in May 1988, aged 38 years, at Liverpool. He Married 1st Q3 in 1968 in Liverpool to JENNIFER MARY BROWN, and had issue. It would appear that he Divorced his 1st Wife as he Married 2nd Q3 in 1982 in Liverpool to MARIA O'BRIEN. His 1st Wife remarried, as Jennifer M Audley in December 1988 to Stephen P Crossan at Sefton. By both Wives he had issue,
 - I) {G28} LISA MARIA AUDLEY the daughter of {G25} by his 1st Wife. Born on the 2nd March 1969, in Liverpool North. Married 1st to DEXTER THOMAS RODNEY, in December 1993, at Liverpool. (Comment: There is a record of a marriage in October 2004 at St Austell, Cornwall, that may or may or may not be related to the above individual. That marriage is recorded as Volume Number 367; Page Number 517; Entry Number 008. In this Index the bride is recorded Lisa M Audley and Lisa M Surry. The Groom is recorded as Anthony Edward.)
 - II) {G32} **LEWIS PAUL AUDLEY**, the son of {G25} by his second wife. Born Q3 in 1986, in Liverpool.
- d) {G20} **VINCENT AUDLEY** born Q3 in 1926 at Liverpool and Buried aged 4 months at Ford "Roman Catholic" Cemetery, Litherland, Liverpool, on 24th December 1926. Living at 34 New Henderson Street at the time of his death.
- e) {G21} **PETER AUDLEY** born Q2 in 1928 at Liverpool and Buried aged 8 months at Ford "Roman Catholic" Cemetery, Litherland, Liverpool, on the 17th November 1928. He was living at 34 New Henderson Street at the time of his Death.

- ii) {G12} **RUTH ANN AUDLEY** born on the 15th April 1895, at 146, Wolfe Street, Liverpool, and was Baptised on the 22nd April 1895, at St Patrick's "Roman Catholic" Church, Liverpool. She died aged 8 months, and interred in Ford "Roman Catholic" Cemetery, Litherland, Liverpool, on the 3rd December 1895 in a "Public Plot".
- (G13) AGNES AUDLEY, born on the 24th August 1897, at Toxteth Park, Liverpool and baptised on the 29th August 1897 at St Patrick's "Roman Catholic" Church, Liverpool. She died in 1901 aged 3 years, and interred in Ford "Roman Catholic" Cemetery, Litherland, Liverpool, on the 20th March 1901 in a "Public Plot". She was living at 11 Court, Wolfe Street, at time of her Death.
- iv) {G14} **ROBERT AUDLEY** born in 1900 Liverpool, living at 11 Court, Wolfe Street, at time of Death. Died the same year aged 9 months, and interred in Ford "Roman Catholic" Cemetery, Litherland, Liverpool, on the 23rd October 1900, in a "Public Plot"
- VERONICA AUDLEY born on the 24th July 1902 at 215, Beaufort Street Toxteth Park, Liverpool and Baptised on the 27th July 1902 at St Patrick, Liverpool. Of St Elizabeth's "Roman Catholic" Institute for Girls, Breckfield Road South, Liverpool in 1911. Of St Anne's Roman Catholic School, Portobello Road, Kensington, London in 1921. 1939 Registers of England

The 1939 Register was created in 1939 for the issue of registration documents and ration books shortly after the commencement of World War 2. As they were produced after the start of the war they do not include people who were member of; conscripted into and volunteered for the Armed Services. Additionally After World War 2 these registers were used as the registration of people into the newly formed National Health Service. These registers were 'updated' by the National Health Service until 1991 when the National Health Service Registration was computerised. The updates made under the National Health Service typically include; changes of surname by Marriage, corrections to Christian names (for example changing initials to full names) and recording the Deaths of individuals listed in the registers. No changes of address are recorded are the Births of new individuals are not recorded.

The records of individuals are either open or closed. Open records can be viewed by the public and Closed records cannot be viewed by the public. Records are open if one of the following conditions applies:

- * The record is open if the person was born more than 100 years ago. This is the 100 year rule and means that progressively more records will be opened each year until they all become open in 2040.
- * The record is open if the person is deceased and the person's Death is recorded in the registers. In theory this means that the record for anyone listed in the registers and Died before 1991 should be open. However not all deaths before 1991 were recorded in the registers, and people who were in the Armed Forces in 1939 are not listed in the registers.

Records that are not open are closed. However members of the public can make requests to the National Archive at Kew to open closed records. To do this they must be able to supply a copy of a Death Certificate and the National Archives must be able to relate this Death Certificate to a particular individual in the 1939 Registers. For example the Death Certificate has the address where the individual died and the 1939 Registers have the address where the individual was living in 1939 so not all requests may be successful.
