Introduction

The goal of this study was to link the 'Audley-Charles' family of the 20th Century to another branch of the 'Audley Family'. This has been achieved and it is believed that this family is related to 'Family 1' in 'Audley Family B' of Birmingham, and in particular to {B17} Elizabeth Audley (1706? – 1779) who married John Jee, of 'Family 1' in 'Audley Family B' is also described in Chapter VIII of the 'Audley Pedigrees' by A. L. Reade that was published in the 1930s. A simplified tree of the link between Family 1 in Audley Family B' and 'Audley Family HC' is given below

The first person to have 'Audley' and 'Charles' in his name is {HC5} **Henry Edward Audley - Charles**, Born Q1 in 1871. Whether his Father {HC4} Abraham Charles intended his Son to make 'Audley-Charles' his surname or whether he was intending him to use the 'Audley' name as one of his forenames we may never know but {HC5} did use 'Audley-Charles' as his surname. Audley being the Maiden (*Birth name*) of one of his Great Grandmother's.

{HC5} Henry Edward Audley - Charles was Born Q1 in 1871. His Mother Hephzibah Jean Charles neé Chalmers Died Q1 in 1871 (Presumably as a result of the Birth of her Son). In the 1871 Census of England his Father is described as a Widower and the Infant {HC5} is not recorded as living at the same address as his Father. Similarly in the 1881 Census of England {HC5} Henry Edward Audley-Charles is not recorded as living at the same address as his Father. {HC5} has not been identified in either the 1871 or the 1881 Censuses of England. {HC5} seems to have moved location on many occasions. We have seen it recorded that he emigrated in 1908 to Canada, possibly leaving his Wife and family behind. We have identified his Wife and youngest child in the 1911 Census of England living with her elderly mother, but have not identified where the rest of his children were living in 1911.

(Comment: Tracing Births; Marriages and Death for the 'Audley - Charles' surname is not straightforward. The earliest reference to the 'Audley-Charles' surname in the GRO Indexes is 1933 prior to that date all 'Audley-Charles' Births, Marriages and Deaths are recorded in the GRO Indexes are listed as though the surname was Charles. After 1933 to 1989 (the last reference checked) the Births, Marriages and Deaths of individuals with the Audley-Charles surname are indexed twice; firstly as 'Audley-Charles' and secondly as though the surname was 'Charles'.)

Audley as a Hyphenated Surname or Forename

Within this family one branch has taken the Audley and name and hyphenated it with the Charles surname to form the hyphenated Audley-Charles surname. In this situation all member of the family have the Audley-Charles surname. In the other branch of the family all members of the family have the Charles surname, but some but not all have the name Audley as a forename.



Detailed Family Tree

{HC1} **THOMAS CHARLES** Born about 1786 (*Based on age in the 1841 Census of England*). Of Pelsall Hall, Wolverhampton, Walsall, Staffordshire in 1841. He married CATHERINE SMITH on the 20th December 1816 at King's Bromley. Of Pelsall Hall, Pelsall, Wolverhampton, a Widow and Annuitant in 1851. She was of Mousehill, Pelsall, a Widow, in 1861. She died on the 3rd March 1862, aged 74 at Walsall. Her Will was proved on the 1st September 1862, her Son {HC4} being the sole executor.

- 1.) {HC2} **HENRY CHARLES** Christened on the 29th August 1817, at Yoxall, Staffordshire. Of Pelsall Hall, Walsall, Staffordshire in 1841. Of Pelsall Hall, Pelsall, Wolverhampton, a Landed Proprietor in 1851. Of Mousehill, Pelsall, a Landed Proprietor, in 1861. He died Q1 in 1866 aged 48 at Walsall.
- 2.) {HC21} **ELIZABETH CHARLES** Christened on the 22nd January 1823, at Pelsall, Staffordshire Of Pelsall Hall, Pelsall, Wolverhampton, an Annuitant in 1851.
- 3.) {HC3} **SARAH CHARLES** Born about 1826 (*Based on age in the 1841 Census of England*) .Of Pelsall Hall, Wolverhampton, Walsall, Staffordshire in 1841. Of Pelsall Hall, Pelsall, Wolverhampton, an Annuitant in 1851. She died Q1 in 1856 aged 31 at Walsall.
- 4.) {HC4} **ABRAHAM CHARLES,** Born on the 28th April 1831 and Christened on the 8th November 1838 at Pelsall, Staffordshire. Of Pelsall Hall, Wolverhampton, Walsall, Staffordshire in 1841. Of High Street, Newport, Shropshire, a Chemists Apprentice in 1851. In 1851 he was Apprenticed to and was living with the Father of his future Wife. Of Mousehill, Pelsall, a Landed Proprietor, in 1861. Of Orgreave, Alrewas, Staffordshire, a Gentleman, in 1871. Of Orgreave, Lichfield, Staffordshire. A Landed Proprietor, in 1881. He died Q4 in 1883 at Lichfield, Staffordshire. He married HEPHZIBAH JEAN CHALMERS on the 18th October 1866, at Newport, Shropshire. She was Born Q4 in 1847, in Newport Shropshire, the Daughter of Henry Chalmers and Louisa

Strange (They married Q1 in 1847 at the Church of St Margaret, Westminster, London.(In the grounds of Westminster Abbey)). She died Q1 in1871 aged 23 at Lichfield.

- I. {HC5} HENRY EDWARD AUDLEY-CHARLES. He was Born Q1 in 1871 at Lichfield, Staffordshire. In 1871 Census of England he was living aged 10 weeks with the parents of his Mother at High Street, Newport, Shropshire. Of Llanbedr-y-Cennin, Caernarvonshire, Wales, living on own means, in 1891. Of Orgreave House, Alrewas, Staffordshire, a Veterinary Surgeon in 1901. It would appear that he was declared bankrupt in 1907; see the references to him in the London Gazette, and the Edinburgh Gazette, in the 'Supporting Information' section of this file. He emigrated to Canada alone arriving in Quebec on 23td July 1909, aboard the Empress of Ireland. Some but not all of his family emigrated to Canada over a number of years. In his Canadian Attestation papers for WW1, dated the 28th March 1917, he gives his next of kin as his Daughter, Muriel Jean Cruikshank. Also in his Attestation papers he indicates that he had served in the Scottish Yeomanry (Comment: Two of his children were recorded in the 1901 Census of England, as having been Born in Scotland.) He also sailed from Liverpool back to Canada via New York, arriving in New York on the 20th July 1918. On the passenger list he is described as a Soldier, and lists his Wife as Mrs K M Charles, of 95 St James Road, Brixton, London. The Probate Register for England and Wales for 1928, indicates that he Died on the 22nd April 1927, and is described as 'of Emo, Rainy River, Ontario Canada' and probate was granted at Lichfield on the 13th March 1928, to Charles Arthur Sangar Stockbroker. His effects were valued at £5. He married Q1 in 1892 at Lambeth, London to KATE MAUDE HINTON. She was of 95, St John's Road, Brixton SW London, in 1911. In 1911 she was living with her Widowed Mother and one of her Sons. She was of 45 Alexandra Road, Worthing, Sussex, living on Private means. She was of 11, Park Hill Road, Croydon, Surrey, under taking Home Duties. In 1921 she was living with her nephew and his family. In 1939 she was living at the same address as her Daughter in Law. She died (as Kate M Charles) Q4 in 1960 aged 94 in Worthing, West Sussex.
 - A. {HC6} MURIEL JEAN AUDLEY-CHARLES Born Q1 in 1893 in Lichfield. Of Orgreave House Alrewas, Staffordshire in 1901. She emigrated to Canada in 1908, and Married William Cruickshank. She is recorded as Muriel Jean Cruikshank of Stagsburn, Outaouais, Quebec, Canada in her Father's Canadian WW1 Attestation papers.
 - B. {HC7} **EDMOND ROY AUDLEY-CHARLES** Born on the 8th November 1894, in Lichfield. Of Orgreave House Alrewas, Staffordshire in 1901. He emigrated to Canada. He died on the 7th October 1986, at Vancouver, British Columbia, Canada aged 91. He Married 1st to NORAH TROTMAN COCHRANE She was Born on the 5th December 1896, and Died aged 63, on the 27th May 1960. He married 2nd to ELIZABETH HANNA OWEN neé Goodridge, She was Born on the 29th March 1891, in the USA and Died on the 15th May 1976, at Vancouver, British Columbia Canada.
 - C. {HC8} **JOHN KEITH AUDLEY-CHARLES** Born in 1895 to 96 in Scotland. Of Orgreave House Alrewas, Staffordshire in 1901. He emigrated to Canada and married JULIA ALEXANDER on the 9th December 1924 at Emo Village in the Rainy River District of Ontario, Canada.
 - D. {HC20} **HUGH C AUDLEY-CHARLES** Born 1896 97 in Scotland. Of Orgreave House Alrewas, Staffordshire in 1901.
 - E. {HC9} LAURENCE GEOFFREY AUDLEY- CHARLES He was Born on the 18th November 1902. He is listed in the UK Royal Navy Registers of Seaman's Services 1848 1939. It would appear that he served as a Royal Navy 'Boy', aboard HMS Furious (or HMS Ganges) and then signed up for 12 years from the 18th November 1920 (His 18th Birthday) for 12 years. Of the Battleship HMS AJAX, in Constantinople an Ordinary Seaman in 1921. In the 1939 Registers he is recorded as living at the Eccleston Hotel, 82-83, Eccleston Square, Belgravia, Westminster London, a Grocery & Provisions Man. A note in the Register indicates that he was a member of the Mercantile Marine and a partial War Service Registration number is visible. He died on the 18th

February 1941, when the 'MV Edwy R Brown' was torpedoed by a German U-Boat off the South West of Iceland. (For more details see the WWII pages on the Audley websites) He married Q2 in 1933, to ELSIE A USTONSON at Steyning, West Sussex. She was of 45, Alexandra Road, Worthing, Sussex, a Shop Manageress in 1939. In 1939 she was living at the same address as her Mother in Law. She married 2nd to John Dobson Q1 in 1959 at Wood Green, Haringey, London.

- a.) {HC10} **MICHAEL G AUDLEY CHARLES** Born Q1 in 1935 at Preston. He spent some time in Canada in that he departed Liverpool on the 9th July 1957, bound for Montreal aboard the 'Empress of Canada'. He married Q3 in 1965 at Kensington, London, to BRENDA. A. CORDEIRO, and had issue.
 - 1. {HC11} **HENRY EDWARD AUDLEY-CHARLES** Born Q3 in 1970 at Paddington, London.
 - 2. {HC12} **HELEN LOUISE AUDLEY-CHARLES** Born Q3 in 1973 at Paddington, London,
- b.) {HC13} **PHILIP E AUDLEY-CHARLES** Born Q1 in 1938 at Worthing, West Sussex. He Married Q2 in 1961, at Battle, East Sussex, to KYRA. M. FERRIER and had issue.
 - 1. HC14} CATHERINE H M AUDLEY-CHARLES Born Q2 in 1961, at Hammersmith, London, and Married RUSSELL. C. E. HARRIS in 1989 at St Albans, Hertfordshire.
 - 2. HC15} TERESA M C AUDLEY-CHARLES Born Q1 in 1962 in Hammersmith, she married, as Clare M T Audley-Charles in 1985 to JEAN MICHEL F BEC at St Albans, Hertfordshire.
 - 3. HC16} LAURENCE A M AUDLEY-CHARLES Born Q1 in 1963 At Saffron Walden, Essex, he Married to JANET M FOWLER in 1987 at Brent, London.
 - 4. {HC17} **SARAH J E AUDLEY-CHARLES** Born Q3 in 1965 at Braintree, Essex.
 - 5. HC22} EDWARD CHRISTIAN G AUDLEY-CHARLES. Born Q3 in 1965 at Braintree, Essex.
- F.) {HC18} **GERALD EDMOND AUDLEY-CHARLES** Born 1904-05 at Brighton, Sussex (*Based on the 1911 Census of England*). Of 95, St John's Road, Brixton S W London in 1911, living with his Mother and Grandmother. He either emigrated to Canada or spent some time there as he was the witness to the Marriage of his Brother {HC8} John in Ontario, Canada in 1924.
- 5.) {HC19} **JOHN SMITH CHARLES** Born on the 8th July 1833, and Christened at Pelsall on the 8th November 1838. Of Pelsall Hall, Wolverhampton, Walsall, Staffordshire in 1841. Of Pelsall Hall, Pelsall, Wolverhampton, in 1851. Of Mousehill Pelsall, a Landed Proprietor, in 1861. Of 43, Old Town Pelsall, a Landowner in 1871 & 1881. Of The Hall, Pelsall, Walsall, Living on own means in 1891. He died Q1 in 1901 aged 67 in Walsall. He married ANN SNOWDIN BROWN on 9th September 1862 at Holy Trinity Church, Ashby-de-la-Zouch, Leicestershire. They had issue:

- D.) {HC25} LAURA CHARLES She was Born Q3 in 1871 at Walsall and Christened on the 25th June 1868 at St Michael and All Angels, Pelsall. In her Christening record her abode is recorded as Pelsall Hall. Of Town, Pelsall, Walsall a Scholar in 1881.
- E.) {HC26} **JOHN ROGER CHARLES** He was Born Q3 in 1873 at Walsall and Christened on the 27th October 1872 at St Mark's Church, Great Wyrley, Staffordshire. Of Town, Pelsall, Walsall a Scholar in 1881. Of The Hall, Pelsall, Walsall, a Medical Student in 1891. Of 12, Victoria Square, Clifton, Bristol, a Consulting Physician in 1911. Of Churchill Court, Churchill, Axbridge, a Consulting Physician, in 1921. Married Q3 in 1901 to ALICE MARY GERTRUDE HODGSON at West Bromwich.
 - a.) {HC28} **JOYCE EVELYN MARY CHARLES** She was Born Q2 in 1902 at Walsall and Christened on the 21st May 1902 at St Michaels and All Angels, Pelsall, Staffordshire. Of 12, Victoria Square, Clifton, Bristol, in 1911. Of Churchill Court, Churchill, Axbridge, in 1921.
 - b.) {HC29} **JOHN HUGO AUDLEY CHARLES** (Audley as a Forename) He was Born Q1 in 1904 at Walsall Christened on the 16th February 1904 at St Michael and All Angels, Pelsall, Staffordshire. Of 12, Victoria Square, Clifton, Bristol, in 1911. He Died in April 1996, aged 92 in North Somerset. He married Q3 in 1938 at Canterbury to MILDRED F HARDCASTLE. Believe that he became a Vicar and had no children (Comment: there is an inconsistency here as his Death registration indicates he was Born on the 20th April 1904, whereas his Birth registration and Christening indicate an earlier date.)
 - c.) {HC30} BERNARD ROGER AUDLEY CHARLES. (Audley as a Forename) He was Born Q4 in 1909 at Walsall. Of 12, Victoria Square, Clifton, Bristol, in 1911. Of Churchill Court, Churchill, Axbridge, in full time education in 1921. He married Q4 in 1948 to PATIENCE M GREEN in Middlesex South. (Cpmment: There are a number of marriages between a male Charles and a Female Green which makes it difficult to identify their children)
- F.) {HC27} **MICHAEL CHARLES** He was Born Q1 in 1875 at Walsall. He was Christened on the 14th January 1875, at St Michael and All Angels, Pelsall, Staffordshire. Of Town, Pelsall, Walsall a Scholar in 1881.
