AUDLEY OF ST. IVES, CO. HUNTS.

The brief Harleian pedigree of 1566, of the Audleys of St. Ives, shews Thomas Audley, who was granted the Priory or Manor of St. Ives by Henry VIII in 1544, as son to an undefined Audley, "of Laver, Suffolk." But there is no Laver in Suffolk: the three parishes of the name are all in Essex, so that this ascribed origin must be regarded with some suspicion.

From 1544 the family continued to hold a good position in the town, till the death of the first Thomas's great-great-grandson Thomas Audley in 1681. He left no legitimate children, but his half-brothers, Robert and Mollineux, who removed from St. Ives, may have done so. Possibly Thomas Audley, who died in 1702 and ancestored the later Audleys of St. Ives, in the eighteenth century, was illegitimate son of Thomas Audley who died in 1681: his descendants used the distinctive name of Mollineux, which suggests kinship. Moreover, there was no other Audley family in St. Ives from which he could have come. Down to 1690 there are no entries in the St. Ives registers that do not find their place in the pedigree, except those of Mollineux in 1673 and Jane in 1677, children of Thomas Audley, physician, whom fuller knowledge would no doubt attach.

There is a puzzling burial in 1726, that of a Lewis Audley. We have Lewis Audleys in several other branches of the family (see *ante*, p. 47, and *post*, several references), but none, so far as is known, in that of St. Ives.

It will be noticed in the registers that there were no Audley baptisms between 1601 and 1636. This suggests that the younger children of Robert Audley (1567-1641), were baptized elsewhere, as they were all born within that period.

Hunts. ELIZABETH AUDLEY. Writ dated 2 May, 2 Eliz. (1560). Inquisition taken at St. Ives, co. Hunts., 15 May, 2 Eliz. (1560), before the Queen's Escheator there, to enquire after the death of *Elizabeth Audley* of St. Ives. The jurors (named) say on oath that the said *Elizabeth* was seised in her demesne, as of fee, of the house and site of the late Priory or Cell of St. Ives, now dissolved, late belonging to the Monastery of Ramsay in said co., and of all the houses, dove-cotes, pools, gardens, etc., thereunto belonging, and of a close of land next the Female Barn in St. Ives, and the lands called the Leys of about 15 acres in the common field in St. Ives, and a grove of an acre in St. Ives, and 2 acres of meadow in the Great Meadow of St. Ives, and the alders and osiers growing on and near the Little Eye as far as Stanton Lands in St. Ives, and all those lands whercon osiers grow; and a parcel of land called the Pole Yard in St. Ives, and in 3 pools there, and land called Poleyard next Huttone House in St. Ives, and arable land called Sudgarr lying in the common field in St. Ives, and the fishery and fishing in the river of St. Ives extending from Henhouxforth (?) Milles to Hallywell Stake in St. Ives, and in all the Little Eye and ditch adjoining in St. Ives, and advowson of the church of St. Ives, late belonging to said Priory, as well as the tithe barn there and all tithes of sheaves, grain, and hay, and all obventions and emoluments, and also of the messuage called Wekyne in the occupation of *Leonard Heddrington*, in Woodhurst, and the foldage there, and on the Hurste Heath as far as Lyme Hill, and the land called Lyme Hill, and a parcel of land called Nedingworthdoole, lands, etc., in Woodhurst, and lands called Oklewood and Oldehurst, all belonging formerly to said Priory, with all court leets, views of frankpledge, free warren, etc., and all other profits thereunto belonging. The said *Elizabeth* died at the town of St. Ives, 1 Apl. last past, and all the above descended to *Robert Audley*, esq., son and heir of the said *Elizabeth*, as by letters patent to *Henry Audley* (sc. *Thomas Audley*), esq., decd., and said *Elizabeth*, in tail male, granted 27 May, 36 Hen. VIII. (1544); the said *Robert* now dwelling at St. Ives, and at the time of his mother's death aged 21 years and more. (Tenures given). [Chancery Inq. P.M., Series 2, vol. 127, no. 9.]

Hunts. THOMAS AUDLEY, ESQ. Writ dated 16 Feb., 6 Charles I. (1630-1). Inquisition taken at Huntingdon, 29 July, 7 Charles I. (1631), before the King's Escheator there, to enquire after the death of *Thomas Audley*, esq. The jurors (named) say on oath that the said *Thomas Audley* was seised in fee tail male, and in default of his male issue to the heirs male of the bodies of *Thomas Audley*, decd., grandfather of said *Thomas*, and *Elizabeth* his wife, of the house and site of the late dissolved Priory of St. Ives, co. Hunts., late belonging to the late Monastery of Ramsey, co. Hunts., and of a close in St. Ives, and lands called the Leys in the common field of St. Ives, now enclosed with hedges and ditches, and of a tenement called the Little Holme in St. Ives containing one acre, and two acres of meadow in the Great Meadow of St. Ives, and of all osiers and willows growing on the Little Eye as far as Stanton Lands End in St. Ives and the land and soil on which they grow, and of a parcel of land called the Poleyard in St. Ives, and ponds there, and a parcel of arable land called the Sudger in the common field surrounded by hedges and ditches, and a parcel of the Leys of 2 acres in St. Ives in tenure of *Richard Dawson*, and of the fishery and fishing in the river of St. Ives from Hemingford Mills to Hallywell Stake in St. Ives, and the little Eye and ditch there, all situate in St. Ives and parcel of said Monastery. He was also seised of a capital messuage called Wecken *alias* Wiggen in Woodhurst, co. Hunts., late belonging to the Priory of St. Ives, and of the foldage and course for sheep there, and of two parcels of land called Lyme-hill and Nedingworth Dole, belonging to the said messuage, and a wood called Oackley Wood of 18 acres in St. Ives, late belonging to the said Priory, and of land and wood called Woldhurst, late belonging to said Priory. So being seised, by indenture bearing date 14 June, 14 James I. (1616), made between said *Thomas Audley* of one part, and *Wheathill Audley*, gent., his brother, the said *Thomas*, on payment

of £800, demised to *Wheathill Awdley* the said premises called *Weeken alias Wiggen*, to have and to hold for the lives of the said *Wheathill* and of *Thomas* and *Mullenax*, sons of *Robert Awdley*, gent., brother of said *Thomas* and *Wheathill*, at a yearly rent of £111. The said *Thomas Awdley* died 20 Jan. last past, and *Robert Awdley* is his brother and next heir, aged 60 years and more, and *Robert* is also heir male of *Thomas Awdley*, the grandfather, and *Elizabeth* his wife. The said *Wheathill Awdley* and *Thomas* and *Mullenax Awdley* still survive. (Tenures given). (Chancery Inq. P.M., Series 2, vol. 485, no. 72).

CHANCERY PROCEEDINGS

FREEMAN v. AUDLEY

9 Feb. 1617/8. Complaint by *Robert Freeman*, of Staunford, co. Northants., gent., eldest son of *Jane Freeman*, sister of *Paul Thompson*, parson of Whitton cum Houghton, Hunts., clerk, that he, the complainant, was brought up by his said uncle, who was to provide for him, and he surrendered to him a messuage called the White House in Whitton cum Houghton, and the same was done in court. But after, the steward, *Mr. Anger*, would not admit him. Afterwards *Paul Thompson*, without reason, took a dislike to complainant and, combining with *Robert Audeley*, esq., and *William Searle*, gent., dwelling in co. Hunts. and near neighbours, sent him far distant and took possession of his house, and *Paul Thompson* was again accepted tenant, and in Dec. last made another surrender of the premises to *Molyneux Audeley*, son of said *Robert*, a child of 8 years, to the great damage of complainant.

14 Feb. 1617/8. Answer of *Robert Audeley*, esq., that *Mr. Thompson* died in Jan. last past. Continues *re* said house: nothing further *re* Audley [C.P. before 1714, C.8, Mitford 25/21].

DRURY v. DRURY

(no date). Rejoinder of *Thomas Drury*, esq., to the replication of *Robert Drury*, complainant. He refers to statements already made concerning the estate of *Jeremy Drury*, grandfather of complainant. He denies that he has paid or promised an annuity to *William Drury*, father of the complainant, or has tried to procure *Wheatly Audley* or any other of the kin by the mother's side to undertake guardianship of complainant and his sister. One *Mr. Thomas Audley* (usually called *Major Audley*), *Molineux Audley*, since a prisoner in the Fleet, uncle of complainant on the mother's side, and *Benjamin Harrison*, a kin of the said *Audleys*, are conspiring with *William Drury*, who has spent all his estate, to get the legacies of complainant and his sister, and have several times approached this defendant in a "high vapouring and threatening manner." Defendant has often heard his father, *Thomas Drury*, say that *Jeremy Drury* often declared that the *Audleys* (whose sister *William Drury* had married without *Jeremy's* consent), would cause the said *William* to spend all his estate and that, if the money were left to him, he would not be worth a groat in seven years. Later references to *Wheatill (sic) Audley*. *Mrs. Martin* has declared, with tears, that she would rather have buried her daughter than have married her to complainant, who is stated to have lived several months at the house of one *Charlton*, an upholsterer in Southwark, and passed as "*Squire Smith*," and furthermore has borrowed, and not since returned, a horse for which the said *Charlton* had become responsible. *Thomas Drury* refers to his brothers, *Richard* and *William Drury* [C.P. Charles I., D.62/123; this abstract is derived from *The Genealogical Monthly*, I., No. 4, Sept. 1929].

EMBERSON v. AUDLEY

4 July 1650. Complaint by *Richard Emberson*, of Bluntsham, Hunts., gent., that *Thomas Audley*, of St. Ives, esq., decd., and *Molineux Audley*, his bror., together with *Edward Marbrow*, and *John Abbott*, of St. Ives, gents., about three years ago borrowed £50 of him and became bound in £100 for repayment of same. He had asked for re-payment, looking upon *Thomas Audley* in his lifetime as his principal security for his debt, and knowing him not well affected to the now Parliament, and perceiving the dangerous times, and likely sequestration of his estate, he might lose his money, and in 1647 land in Woodhirst, Hunts., called Oakley, was conveyed to him, and he entered into same and enjoyed it peaceably. *Thomas Audley* died in August last, and same descended to his bror. *Molineux*. The latter has got the bond into his hands, and refuses to deliver same to said complainant, or to allow him to enjoy the said land.

8 July 1650. Answer of *Mollinax Audley*, esq., denying he borrowed any money, but admitting *Thomas* did. His said elder bror. died at the time stated. Denies he has any bond or lease in his possession. He claims the premises by ancient entail from the Crown, for all his lands were granted by *Henry VIII.* to *Thomas Audley* and *Elizabeth* his wife, in tail male, and descended to *Thomas's* son *Robert*, who had sons *Thomas* and *Robert*. *Thomas* entered into same, and died without issue, and *Robert* succeeded him, and had issue the said *Thomas* and this defendant *Mollinax*. *Thomas* died without issue, and same descended to this defendant [C.P. before 1714, C.10, Whittington 5 50].

AUDLEY *v.* HARRISON

29 May 1651. Complaint by *Molineux Audley*, of St. Ives, Hunts., gent., that in July 1641 he became bound with his late bror., *Thomas Audeley*, then of St. Ives, esq., to *Benjamin Harrison*, of St. Clement Danes, co. M[']sex, gent., in £200 for payment of £104, and said *Thomas* entered into other bonds concerning borrowing of money. *Thomas Audeley* died 17 Aug. 1649. Continues *re* said bond.

3 Jan. 1651/2. Answer of *Benjamin Harrison* concerning said bond. Nothing further *re* Audley [C.P. before 1714, C.9, Reynardson 7/3].

MOUNTAGUE *v.* AUDELEY

(torn) 1653. Complaint by *George Mountague*, of Westminster, and of *Edward Mountague*, of Hinchbrook, Hunts., esq., *re* the composition made by *Thomas Awdley*, for the rectory or parsonage of St. Ives. After indentures made concerning his estate *Thomas* died, and *Molineux Awdley*, his bror. and heir, took out letters of admon. and possessed himself of his bror.'s estate.

— Nov. 1654. Answer of *Molineux Awdley*, that *Henry VIII.*, by letters patent in May, 36 Henry VIII. (1544), gave *Thomas Audeley*, of St. Ives, gent., and *Elizabeth* his wife, the site of the Priory or Cell of St. Ives, with the rectory and advowson, in tail male, to hold by the twentieth part of one Knight's fee, and same descended to their only son, *Robert Audeley*, who had sons *Thomas* and *Robert* and other children, and on his death same descended to his eldest son *Thomas*, who died without issue, and same descended to his bror. *Robert Audeley*, who had issue the said *Thomas*, decd., and this defendant *Molyneux*, and said premises ought to descend to him as of right, etc. [C.P. before 1714, C.7, Hamilton 408/9].

AUDELY *v.* CLARKE

22 June 1659. Complaint by *Thomas Audely*, of St. Ives, Hunts., esq., that *John Parnell*, late of St. Ives, brewer, decd., by his last will, dated 1645, among other things bequeathed to his dau., *Mary Parnell*, £400 at her age of 21 or on marriage, and made his wife *Margaret* and his son *John* exors., and died shortly after, *Margaret* alone proving the will. By indenture dated 31 Mch. 1652, made between said *Margaret* and *Thomas Clerke*, of Hemingford Grey, Hunts., gent., *Robert Harbach*, of Chancery Lane, M[']sex, gent., and the said *John Parnell*, the son, the said *Margaret* sold her goods, etc. (she being about to re-marry), to the said *Clerke*, *Harbach* and *Parnell*, to the use of her children, *Mary*, *Jeremy* and *Daniel Parnell*, to pay them the portions bequeathed by their father. Afterwards *Margaret* married *Anthony St. Leger*, esq. About two and a half years ago complainant married the said *Mary Parnell*. But now the said *Clerke* and *Parnell* (*Harbach* being dead) have possessed themselves of said estate, and have not paid and refuse to pay said legacy, and he desires they may be caused to appear and answer the premises.

24 June 1659. Answer of *John Parnell*, that on 2 Feb. 1656/7 he paid all the money he had received on *Mary's* account to complainant, the rest of the money being in said *Clerke's* hands. No answer of *Clerke* [C.P. before 1714, C.10, Whittington 52 '9].

AWDLEY *v.* GARDINER, etc.

— May 1664. Complaint by *Thomas Awdley*, of St. Ives, Hunts., esq., son and heir of *Molineux Awdley*, late of St. Ives, esq., that in 1655 the said *Molineux* was seised in his demesne as of fee of some estate of inheritance of 400 acres of land worth yearly £200, in Woodhurst, Hunts., called *Wekins alias Wiggin Farm*. So seised, being minded to make provision for his younger children, the said *Molineux* by deed in Nov. 1655 did grant and to farm let to *Humphry Gardiner*, of Histon, co. Camb., esq., *Thomas Kirkby*, of Solme, Isle of Ely, esq., *Francis Gardner*, of Wigg, in Woodhurst, gent., and *John Chard*, of Haughton, Hunts., gent., the said messuage, to have and to hold to them during the lives of complainant and his brors. *Robert* and *Molineux Awdley*, and complainant believes a good yearly rent was reserved to *Molineux* the father. The said defendants refuse to pay complainant any rent, and also refuse to let him see the deeds drawn up between his father and them, and he begs they may be ordered to answer his complaint [C.P. before 1714, C.7, Hamilton 15/156].

AWDLEY *v.* GARDNER

14 May 1664. Answer of *Humphrey Gardner*, *Thomas Kirkby* and *John Chard* that *Molineux Awdley* made his will 24 Dec. 1655, appointing them and *Francis Gardiner* exors., to pay to his eldest dau. *Mary Awdley* £25 a year, to his dau. *Elizabeth Awdley* £25 a year, to his daus. *Jane Awdley* and *Penelope Awdley* £25 each a year, and to his sister *Drury* £4 a year. They have paid as directed and deny the allegations made by complainant [C.P. before 1714, C.7, Hamilton 552/6].

22 June 1670. Complaint by *Thomas Audley*, of St. Ives, Hunts., gent., son and heir of *Molineux Audley*, esq., decd., that his said father in Jany. 1655 died leaving complainant, a minor aged 16, lands, etc., in St. Ives and Woodhurst of the yearly value of £350, and complainant, not understanding management of said estate, chose as his guardian *Thomas Kirkby*, of Soham, co. Camb., esq., his uncle by the marriage of complainant's father to his second wife, *Abigail*, sister of *Thomas Kirkby*. The latter entered into the estate, and took the rents, etc., and employed them to his own use, untruly alleging the lands lay under sequestration, and complainant had to borrow money to live. 14 July 1679. Complaint by *Thomas Audley*, of St. Ives, Hunts., esq., that in Dec. 1662 he borrowed of *Robert Dring*, citizen and merchant taylor of London, a certain sum of money, and being then a raw youth under age the said *Dring* took advantage of him and caused him to mortgage his estate to him, amounting to ten times the value of what was lent to him, he having paid back £1700, and the lands being worth £100 a year. He desires *Dring* may be caused to appear to answer the premises [C.P. before 1714, C.9, 422/1].

STEPHENS *v.* AUDLEY

24 Aug. 1680. Complaint by *Anthony Stephens*, of London, gent., that *Thomas Audley*, of St. Ives, Hunts., gent., *Robert Audley*, of Solme, co. Camb., gent., and *Molineux Audley*, of King Street, High Holborn, co. M'sex, gent., pretended they were seised of the site of the late Priory of St. Ives, and of the advowson of that vicarage, and the tithe barn, and the farm called Wicken *alias* Wiggin, in Woodhurst, Hunts., and of pasture in St. Ives, and of various fields (named) in St. Ives, and of the fishery in the river of St. Ives from Hemingford Mills to Hallywell Stake, and so pretending to be seised requested complainant to lend him, the said *Thomas*, £5000, upon the security of said premises, which he did. He now desires they may be summoned to answer what mortgages and encumbrances are on said premises.

30 Aug. 1680. Answer of *Thomas*, *Robert*, and *Molyneux Audley*, setting forth various mortgages and leases. Nothing further *re* Audley [C.P. before 1714, C.9, Reynardson 96/91].

AUDLEY *v.* PERRY

— May 1682. Complaint by *Robert Audley*, late of Fordham, co. Camb., gent., that his father, *Molineux Audley*, late of St. Ives, Hunts., esq., was seised in tail male of the messuage or farm of Wickes *alias* Wiggen, in Woodhurst, and the rectory of St. Ives and land in St. Ives, of the yearly value of £500, and *Molineux* died in Nov. 1655 seised thereof, leaving *Thomas*, *Mary* and *Elizabeth Audley*, his children by his first wife, and complainant and *Molineux* by his second wife. His father, by indenture dated 22 Nov. 1655, settled the estate of Wiggen on complainant and his bror. *Molineux*, but if *Thomas* died without male issue complainant was to have the estate at St. Ives, and *Molineux* the whole estate of Wiggen. After *Molineux* came of age, complainant paid him £400 for his moiety of Wiggen. Later *Thomas* mortgaged his estate to complainant. *Thomas* died in July last, and *John Perry* of London, vintner (who married *Mary*, sister of *Thomas*), and *John Parnell*, of St. Ives, son of *Daniel Parnell* and *Elizabeth* (formerly *Elizabeth Audley*), have entered upon the estate to complainant's damage, etc.

10 July 1682. Answer of *John Perry* and *Mary* his wife *re* same. No more genealogical details [C.P. before 1714, C.8, Mitford 305/4].

FISHER *v.* AUDLEY

7 June 1682. Complaint by *John Fisher*, of Gray's Inn, co. M'sex, esq., that *Thomas Audley*, late of St. Ives, Hunts., esq., decd., in 1678, was seised in tail male of the Priory or manor of St. Ives, and of the reversion of the farm of Wicken, in St. Ives, then in the tenure of his half bror., *Robert Audley*, and of other messuages and lands to the yearly value of £400 and upwards, which premises were granted to the ancestors of the said *Thomas Audley* by King *Henry VIII.*, in tail male, and *Robert Audley* was seised of said farm for the lives of said *Thomas*, himself and *Molineux Audley*, another half-bror. of said *Thomas*, the reversion pertaining to said *Thomas*, as son and heir of his decd. father, *Molineux Audley*, *Robert* being next heir male after his said bror. *Thomas's* decease. Wishing to settle jointures on their wives, and portions on their children, they approached complainant for advice and it was agreed *Thomas* should apply for letters patent for grant of the reversion, and he should pay *Robert* £2700, and the agreement was drawn up 15 Dec. 1678, and *Robert* was to pay complainant £10, and further on 1 Aug. 1679 *Thomas* and *Robert* agreed to pay complainant £25 on completion of a mortgage of said premises to *Robert Dring*. And indenture was made 25 Aug. 1680 between *Thomas Audley*, of St. Ives, esq., and *Robert Audley*, of Fordham, co. Camb., gent., concerning same. *Thomas* and *Robert* owed complainant various sums, but never paid. *Thomas Audley* died at St. Ives in July last past 1681, in possession of said lands, which descended to *John Perry* and *Mary*

PERRY v. AUDLEY

26 June 1682. Complaint by *John Perry*, of London, gent., and *Mary* his wife, one of the daus. of *Moullineux Audley*, late of St. Ives, Hunts., decd., by *Maudlyn* his first wife, and one of the sisters and co-heirs of *Thomas Audley*, late of St. Ives, gent., decd., who was son and heir of said *Moullineux*. *Elizabeth*, now decd., sister of said *Mary*, married *Daniel Parnell*, of St. Ives, gent., and has left a son, *John Parnell*, of St. Ives, aged 21 and more. That *Henry VIII.*, by letters patent dated 27 May, 36 year of his reign (1544), granted the Priory of St. Ives to *Thomas Audley*, gent., and *Elizabeth* his wife, in tail male, and they had issue *Thomas* and *Robert*. *Thomas* died without issue, and *Robert* had issue *Mullineux*, who married *Maudlyn Malborrow*, and had issue *Thomas Audley*, since dead, without issue, the said *Mary Perry*, and *Elizabeth Parnell*, decd., who had issue the said *John Parnell*. After *Maudlyn's* death, *Mullineux* married *Abigail Kirby*, by whom he had issue *Robert* and *Mullineux Audley*. By agreement dated 15 Dec. 1678 *Thomas Audley* agreed to pay to his half-brors., *Robert* and *Mullineux Audley*, £2700 to obtain from the Crown the reversion in fee simple, and the now King, on 8 July, 31st year of his reign (1679), by letters patent granted the reversion of said Priory to *Thomas Audley*, and afterwards the latter mortgaged same to *John Hoheworthy* for £4000, and he mortgaged same to *Anthony Stephens*, of London, gent., for £5000. *Thomas Audley* being dead without issue, the said lands should descend to said *Mary Perry* and her husband, *John Perry*, and to *John Parnell* in right of his mother *Elizabeth*, *Mary* and *Elizabeth* being of the whole blood of *Thomas*. *John Parnell* has agreed to convey all his right therein to *John Perry*. *John Perry* has paid off the mortgage to *Robert Audley*, but now *Robert* and *Mollineux Audley* combine and pretend the Priory ought by right to come to said *Robert*, as bror. and heir of *Thomas*. They therefore desire *Robert* and *Mollineux Audley* may be summoned to answer the premises [C.P. before 1714, C.8, Mitford 337.232].

PERRY v. AUDLEY

No bill of complaint.

1 Aug. 1682. Answer of *Mollineux Audley*, gent., to the bill of complaint of *John Perry*, of London, gent., and *Mary* his wife. He says he agreed with his bror. *Thomas Audley*, decd., for £250, distinct from £2700 to be paid to *Robert Audley*, this defendant then being in Berwick-on-Tweed in the King's service, and understanding that *Thomas* and *Robert* were to procure the reversion of the Priory lands and premises to the heirs male of *Molineux*, his father, and he being one of the heirs male, entrusted *Henry Cooke*, gent., to enter a caveat against same, and afterwards caused same to be withdrawn on *Cooke's* agreement with *Thomas Audley* for £250, which he hopes the Court will compel complainant or *Robert Audley* to pay him.

Answer of *Robert Audley*, gent., saying his father *Molineux*, by *Maudline*, his first wife, left issue *Thomas*, *Mary* and *Elizabeth*, and by his second wife said *Robert* and *Mollineux*. *John Perry*, complainant, married said *Mary*, and *Daniel Parnell* married *Elizabeth*, who is dead, and had a son, *John Parnell*. *Henry VIII.* granted the Priory to his ancestors, in tail male, with reservation to the Crown in default of such issue, and same descended to his father *Molineux*, and by indenture of 22 Nov. 1655 the latter conveyed Wicken *alias* Wiggen farm, in Woodhurst, Hunts., to *Henry Gardner* and others, for the lives of *Thomas*, the said *Robert* and *Molineux*, his sons, at a yearly rental of £11, and further, that if *Thomas* died without male issue this defendant was to have his estate of St. Ives and *Molineux* the whole of Wicken. Continues as in *NEUDICKE v. AUDLEY*, see *post*, p. 146 [C.P. before 1714, C.8, Mitford 302.125].

PERRY v. AUDLEY

12 Dec. 1682. Complaint by *John Perry*, of Southwark, co. Surrey, merchant, and *Mary* his wife, dau. of *Molineux Audley*, late of St. Ives, Hunts., gent., decd., by *Maudlin*, his first wife, and sister and coheir of *Thomas Audley*, late of St. Ives, gent., decd., son and heir of said *Molyneux* by said *Maudlin*, *Elizabeth*, her sister, having

Complaint by *John Perry*, of St. Saviour's, Southwark, citizen and vintner of London, that on 24 Jan. 1681/2 certain indentures were made between *John Parnell*, citizen and butcher of London, son and heir of *Daniel Parnell*, of St. Ives, Hunts., brewer, by *Elizabeth* his wife, sister and coheir of *Thomas Audley*, of St. Ives, esq., decd., of one part, and said *John Perry* and *Mary* his wife, another sister and coheir of said *Thomas*, of the other, that *Thomas* was seised of the Priory of St. Ives, and manor of *Wiggon alias Wickin*, and lands in St. Ives and Woodhurst, Hunts., and other lands (quotes mortgages, as in *PERRY v. AUDLEY*, 26 June 1682, see above), by which indenture *John Parnell* made over his right in same to said *John Perry* for £480, but now *John Parnell* has demised part of the premises to *John Dean*, of St. Ives, gent., for 9 years, and has combined with *Daniel Parnell* and others to defeat the object of said indenture, and therefore he begs they may be summoned to answer the premises [C.P. before 1714, C.8, Mitford 337/245].

PERRY v. AUDLEY

27 May 1685. Complaint by *John Perry*, citizen and vintner of London, and *Mary* his wife, that by indenture dated 7 Aug., 34 Charles II. (1682), made between *John Dryden*, of Chesterton, Hunts., esq., of the first part, said *Perry* of second, and *Robert Audley*, gent., of third, that said *Dryden* bought the Priory and Cell of St. Ives, Hunts., of said *Perry* and *Audley* and others, for £8000, whereof he paid £6500, and *Robert Audley* claims the residue of £1500. *Robert Audley* kept a shop and became bankrupt, was alleged by *Dryden*; but he never kept a shop, but owed money. Complainant claims the rest of purchase money instead of said *Robert*, and desires the latter, *John Dryden* and *Humphry Neudick*, of whom *Robert* borrowed money, may be summoned to appear and answer the premises [C.P. before 1714, C.8, Mitford 345/54].

HAMPSON v. AUDLEY

11 May 1688. Answer of *Robert Audley* to bill of complaint (not here on file) of *Robert Hampson*, esq., sergeant at law, and *Margaret Perry*, widow, concerning a sale of manors and lands, whereby £1500 was left in the hands of *John Dreyden*, another defendant, and this defendant (*Robert Audley*) proposed to assign his share therein to *Humphrey Neudick*. Continues *re* said money; nothing very definite, as the real matter deals with what has been presented in the bill.

10 May 1688. Answer of *Humphrey Neudick*, that *Thomas Audley* could not mortgage the Priory of St. Ives without consent of *Robert*, and he mortgaged same, together with *Robert* and *Molineux Audley* his bror., and he does not know if the late *John Perry*, citizen and vintner of London, could sell the premises without consent of his wife *Mary*. *Robert Audley* took upon him the trade of pawnbroker, and wanting money for his trade and to support his wife and children borrowed several sums on bond of this defendant. Afterwards *Robert Audley* became bankrupt. Continues *re* debts [C.P. before 1714, C.8, Mitford 406/2].

NEUDICKE v. AUDLEY

5 June 1696. Answer of *Robert Audley* to the bill of complaint of *Humphry Neudick*, that *Thomas Audley* was seised in tail male of the manor or priory, and the rectory, parsonage, lands, etc., mentioned in the bill, and *Molineux Audley*, father of said *Thomas*, had issue by his second wife *Abigail*, this defendant, and *Molineux*, and granted estate in trust for his two younger children, which came wholly to defendant, and on 15 Dec. 1678 *Thomas Audley* entered into articles with this defendant and obtained a grant from *Charles II.* of said manor, etc., for £2000. *Thomas* lived only a short time after obtaining the grant, and had only paid a small part of the said £2000, partly to take off encumbrances of *Wiggen alias Wicken Farm*. *Thomas* died without issue, and *Mary*, his sister of the whole blood, wife of *John Perry*, inherited his lands, etc., and had it not been for said grant the said manor, etc., would have descended to defendant, as heir male of *Molineux* his father. He gave his consent to sale of said manor, in order to obtain his £2700, and same was sold to *Mr. John Dreydon*. Not having received his money, he took up the trade of pawnbroker, and being in want of money to support his wife and children borrowed sums of various people, including complainant. Continues *re* re-payment of said money [C.P. before 1714, C.8, Mitford 618.6].

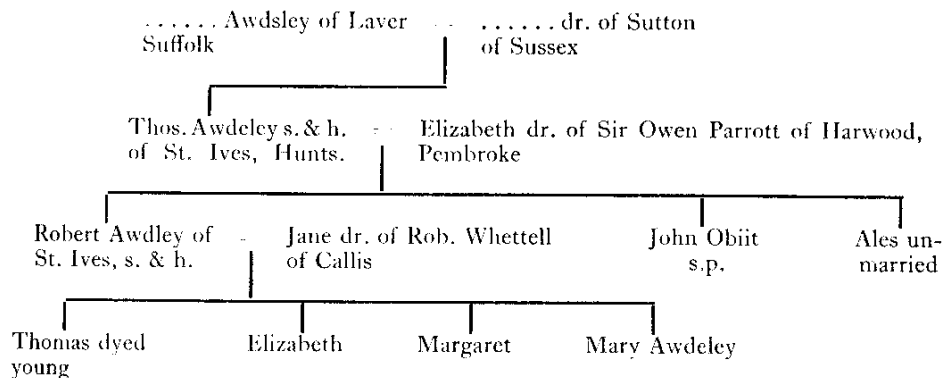

The Visitations of Norfolk in 1563-1613 shew Humfrey Gardener, of Histon, co. Camb., eldest son of Thomas Gardener, of Cokesforth, co. Norfolk, gent., as married to "Elizabeth, da. of Robert Audley of St. Ives in co. Huntingdon," with issue not enumerated (*Harleian Soc.*, XXXII., 124). And the Visitation of Cambridge (1575 and 1619 combined) gives "Elizabeth d. of Rob. Audley of St. Ives in Com. Hunt," as the wife of Humfrey Gardiner, of Histon, co. Camb., in 1619, son of Thomas Gardiner, of Cockforth, by Ann his wife, daughter and heir of William Callibut, of Cockforth, and shews their issue (*ibid.*, XLI., 65).

MISCELLANEOUS EVIDENCES

Canon Noble sent me the following extract from the list of incumbents of All Saints, St. Ives :

- 1546. John Maydew was presented by Thomas Audley.
- 1558. Morice Burnell was presented by Elizabeth Awdeley, widow.
- 1604. William Lowfield, M.A., was presented by Thomas Awdeley.
- 1666. John Meriton, S.T.B., was presented by Thomas Awdeley.

He also gave me particulars of some depositions that he inspected at the office of Mr. S. I. Ladds, at Huntingdon :

The first in the bundle has no date of signing, but Thomas Audley deposed that Jone Bond, of Fenstanton, at the time she made her will, now contested, sent for him. He came, not with Ezra Purcas but immediately after him. When he came into the room the said Ezra Purcas was writing the will, so he left the room, though Jone asked him to stay. Afterwards he went back to the room with his wife Elizabeth, and asked what was to be done as to paying her husband's debts and legacies. Jone said she had not more than £3 in the house, but her husband's debts and legacies were to be paid out of her estate. She admitted this was her last will, on Easter Day 30 Mch. 1673. (This is the only date given, but the next case, No. 2, is dated 1672).

Deposition as to the will of John Stoughton, of St. Ives, made 2 Jan. 1682. One deponent is Thomas Awdeley, of St. Ives, where he lived 14 years. He is 55 years of age. He states that John Stoughton, being of sound mind, memory and understanding, made his last will nuncupative, in the presence and hearing of this deponent and Ri: Wynd, Edwd. Young, in his residence at St. Ives.

(signed) THO. AUDLEY.

Canon Noble also sent me a note of the will of Henry Roberts, of St. Ives, yeoman, dated 9 July 1551 and proved 30 Sept. 1551 in the Archdey. Court of Hunts., in which "Mr. Thomas Awdeley" is mentioned; and of the will of Margaret Chilvers, of St. Ives, dated 14 Dec. 1597 and proved 31 Jan. 1597-8 as before, a witness to which was Jane Audley.

The will of Jeremy Drury, of Rampton, co. Camb., citizen and grocer of London, was dated 22 Feb. 1639-40, and proved 20 Apl. 1640, in P.C.C. (Coventry 44). He leaves £300 apiece to Robert, William and Jeremy, sons of his son William, and £200 to his daughter Elizabeth Drury, all at their ages of 21. He also makes the four children of his son his residuary legatees. Apparently he had but this one son, William, who married Elizabeth, daughter of Robert Audley, of St. Ives. On 23 Nov. 1648 administration *de bonis non* was granted to Thomas Audley, esq., uncle and guardian to the grandchildren, Robert and Elizabeth Drury, during their minority.

Venn's *Alumni Cantabrigienses* has "AUDLEY, MOLINEUX. Adm. at Corpus Christi, 1672. Of Hunts."

A pedigree of "TORKINGTON," compiled by Everard Green, shews "Jane, da. of Molineux Audley of St. Ives, co. Hunts. (*sic.*), died s.p.," as first wife of Lawrence Torkington, of the borough of Huntingdon, silk mercer, aged 45 in 1684 when he entered and signed his pedigree at the Visitation; he married, secondly, Catharine, daughter of John Price, of co. Norfolk, and had issue by her (*Miscellanea Genealogica et Heraldica*, Ser. 4, vol. 4, p. 330).

Canon Noble told me that Mary, daughter of John Parnell, was baptized 4 August 1639 at St. Ives.

Mr. J. B. King, of Lincoln, sent me the following extract from *East Anglia and the Civil War*, 1897, p. 301 :

Wheathill Audley, of Woodhurst, near St. Ives, Hunts, on the eve of the War had the curiosity to go with the crowd along the Huntingdon Road towards Cambridge to see the University plate carried off for the King, and though he pleaded he only went with the Sheriff to the edge of the county, he was fined £223.

The Genealogical Society's MS. index gives the apprenticeship of John, son of Gerard Audley, of St. Neots, co. Hunts., gent., to Benjamin White, of St. Ives, draper, on 9 Jan. 1732 : consideration, £60.

The following are extracts from the *Reports of the Historical MSS. Commission* :—

5th Report, Part i., 1876, p. 125, footnote. "Protestations" pursuant to order of House of Commons on 30 July 1641, under Ramsey parish, Huntingdon:—

O. CROMWELL. Wheatthall Awdley Esq., being in London about paying in the pole money when the protestation was taken, he came and took it before us at Ramsey, the 24th of H. CROMWELL. February 1641[2].

6th Report, 1877, p. 44. House of Lords MSS. Petition from divers inhabitants of St. Ives, 24 Jan. 1644/5, *re* tithes : reason for petition, "the impropiator, Thomas Audley, is a notoriously wicked man, and has been in actual war against Parliament."

Just as this is ready to go to the printer I am able to add an extract from an account of the Priory Manor at St. Ives, by Lilian J. Redstone, B.A., contributed to vol. ii. of the *Victoria County History of Huntingdonshire*, 1932 (pp. 219-20) :

After the suppression of the monastery, the site of the priory was occupied by Thomas Audley, then the king's serjeant.¹ In March 1514 he took from the crown a twenty-one years' lease of the priory,² and in the following May he received a grant of it to himself and his wife Elizabeth in tail male, in respect of his services in the household of Henry VIII. He was then resident at the priory.³ His widow died seized of it, 1 April 1560, and their son Robert Audley of St. Ives had livery of it in the following June.⁴

Thomas Audley, grandson of Thomas and Elizabeth, died childless in 1631, when the priory descended from him to his brother Robert, then aged 60.⁵ Robert's son and heir, Thomas,⁶ was a Royalist, whom the Parliamentary inhabitants of St. Ives branded as a murderer and a "notorious wicked man."⁷ In 1673, he was still in possession of the priory, and without legitimate issue. An attempt then made to vest in Robert, Earl of Manchester, lord of the manor of St. Ives, the remainder of the Priory, contingent upon Thomas Audley's death,⁸ failed, since Thomas's brothers Robert and Mullineux survived.⁹ A new grant made by the crown in 1680 to Thomas Audley in fee simple¹⁰ apparently enabled him and the remainder men (Robert and Mullineux) to sell.

The property at this time became divided. In 1679 Thomas Audley conveyed his manor of St. Ives to Robert Drury,¹¹ and in 1682 Robert and Mullineux Audley with others conveyed it with the advowson to John Dryden¹², an attorney, apparently the son of Sir John Dryden, bart., of West Farndon in Woodford¹³

Miss Redstone has omitted a generation in this record of the ownership of the Priory Manor, for Thomas Audley, in possession in 1673, was not Thomas Audley the Royalist, but his nephew, as my pedigree will shew.

Camb., Aug. 1680; took up trade of pawnbroker, but became bankrupt before 10 May 1688; living 5 June 1696. By his wife (name unknown), who was living 22 Mch. 1680/1, he had issue,

- III. Mollineux Audley; living 22 Nov. 1655; admitted at Corpus Christi Coll., Camb., 1672; of King Street, High Holborn, co. M^xsex, gent., Aug. 1680; in Berwick-on-Tweed, in King's service, in 1681 or earlier; living 10 Feb. 1682/3.
- III. Jane Audley, bapt. 2 Feb. 1640/1 at St. Ives; under father's will of 24 Dec. 1655 to be apprenticed to a seamstress; mard. Lawrence Torkington, of Stamford, co. Lincs., gent., and afterwards of Huntingdon, silk mercer, who was born *circa* 1639. She died without issue, and admon. of her estate was granted 27 Feb. 1664/5, in Archdey. Court of Hitchin. He, who was living 1684, was mard. again to Catherine, dau. of John Price, of co. Norfolk, and had issue by her.
- IV. Penelope Audley, living unmard. 24 Dec. 1655.

The registers shew that there were Audleys at St. Ives all through the eighteenth century. From the Christian names they used, particularly the distinctive one of "Mollineux," one would conclude they were descended from the preceding family, but if so they must have come down in the world. They left no wills, and the following tentative pedigree is constructed entirely from the register entries, and so must be accepted with proper reserve:

It is doubtful if Gerard Audley, who was connected with St. Ives, as shewn in the little pedigree that follows, had any connexion with the preceding family:—

GERARD AUDLEY, of Wintringham, in par. of St. Neots, co. Hunts., farmer. Will dated 2 Dec. 1742, proved 26 Apl. 1745 in P.C.C. He mard. 1stly — — — dau. of — — —, and had issue,

John Audley, apprenticed 9 Jan. 1732 to Benjamin White, of St. Ives, co. Hunts., draper, and was alive on 2 Dec. 1742.

Sarah Audley, mard. John Inkersole, and was alive with him and a son John Inkersole on 2 Dec. 1742.

Gerard Audley mard. 2ndly 6 July 1731, at St. Ives, Sarah, dau. of — — — — — Rule. She died at St. Ives, apparently without issue of her own, and was burd. there 13 Dec. 1768; will dated 11 Dec. 1761, admon. granted 4 Nov. 1773 in Archdey. Court of Hunts.

Very likely the John Audley who married Elizabeth Lee at St. Ives on 29 Sept. 1740 was the above John, who would then be out of his apprenticeship. There is much confusion between the two John Audleys of that period each with a wife Elizabeth, the evidence being insufficient to disentangle their families. It will be noticed that there are recorded the burials of "Sarah, dau. of John and Elizabeth Audley," on 4 July 1746, 6 Mch. 1746/7, and 7 Mch. 1749/50, and that admon. of the estate of Sarah Audley, of St. Ives, was granted on 6 Sept. 1749 to John Audley, her father; while "Elizabeth, widow of John Audley," was buried on — Feb. 1776.
