AUDLEY OF WILTSHIRE, AND OF SWAFFHAM,
CO. NORFOLK

Sir Humphrey Audley, who is given as the ancestor of the Audleys of Swaffham, is an elusive figure, and my evidences include no contemporary reference to him. The pedigrees state that he was slain at the Battle of Tewkesbury in 1471. In *The Paston Letters* (ed. James Gairdner, 1895), iii, 9, is printed a contemporary list of those killed at this battle, on 4 May 1471, and among "men that were heveded" (*i.e.*, beheaded) occurs "Mr. Awdeley," whom a footnote identifies as "Sir Humphrey Audeley." But if he were a knight, why should a contemporary scribe call him "Mr." ? There is no Sir Humphrey Audley recorded in Shaw's *Knights of England*, which aims at completeness.

But if there is some question as to Humphrey and his knighthood, there is no room for doubt that the Audleys of Swaffham descend from the second marriage of James Tuchet, 5th Lord Audley, to Eleanor Holland ; that is, from a brother of Edmund Audley, Bishop of Salisbury, and Thomas Audley, of Maiden Bradley, who are known to have been sons of that marriage. The visitation pedigree is supported by the fact that the Bishop, in his will, in 1523, leaves property to Sir John Audley (his nephew), first of Swaffham, and Sir John's son Thomas ; while Sir John's son Robert Audley, Archdeacon of Berkshire, in his will in 1545, asks to be burd. at Sarum, by his "uncle." Sir John's grandson was named Edmund (or Edmond), whose grandson again was similarly christened.

The only point, therefore, for which we lack independent evidence, is whether the Bishop's eldest brother of the whole blood, from whom the Swaffham family descends, was named Humphrey, and for that we must, for the present, accept the evidence of the Visitation and other pedigrees.

It will be noticed that all these children of Lord Audley's second marriage reverted to the name of Audley, though their real patronymic was Tuchet.

Apparently this branch of the Audley family definitely died out in the male line on the death of Edmund Audley some time about 1600.

I forgive *Sir Giles Strangweish*, knt., what he owes me, also my cousin, *Thomas Baskett*. To *Lady Lynde*, wife of *Sir Thomas Lynde*, 100*s*. -, and to his son and heir *George Lynde*, 100*s*. -, and to his other son *Thomas* 100*s*. -, and to his dau., 40*s*. - each. Staffs. THOMAS AUDELEY, ESQ. Writ dated — July, 22 Hen. VII. (1507). Inquisition taken at Norbury, co. Staffs., 3 Nov., 23 Hen. VII. (1507), to enquire after the death of *Thomas Audeley*, esq. The jurors (named) say on oath that a certain *John Nedeham*, and *Philip More*, parson of Macworth church, were seised of two parts of the lands in Horton Hey, and of the moiety of the manor of Norton upon le Moor, in said co., and so being seised gave same to *James Lord de Audeley*, for life, with remainder to said *Thomas Audeley* and the heirs of his body. *James* was seised of same, and on his death *Thomas* entered into same, and so being seised enfeoffed *Edmund*, Bishop of Salisbury, *Christopher Twyncho*, clerk, canon of Salisbury Cathedral, *James Bromwiche*, clerk, canon of said Cathedral, *Thomas de la Linde*, knt., and *Thomas Barrett*, of Selvyngton, thereof, and afterwards *Thomas Barrett* relinquished all his right therein. Afterwards, in Michaelmas Term, 22 Hen. VII. (1506), *John Woodrof*, clerk, *Thomas Chafyn*, *John Talbot*, and *William Potton*, recovered the said premises against said Bishop and others, and by indenture granted same to said *Thomas* and *Katherine* his wife, for their lives, with remainder to *George Twyncho*, of Cayford, co. The jurors (named) say on oath that a certain *John Nedeham*, and *Philip More*, parson of Macworth church, were seised of the moiety of the manor of Newport, and of the third part of the manor of Eggemondon, and of a messuage in Little Halys, in their demesne, as of fee, and so being seised demised same to *James Lord de Audeley*, with remainder to *Thomas Audeley* and his issue. Afterwards *James* aforesaid enfeoffed *Edmund*, Bishop of Salisbury, *Christopher Twyncho*, clerk, canon of Salisbury Cathedral, and others of the same, and in Michaelmas Term, 22 Hen. VII. (1506), a recovery was had to *John Woodrof*, and others, who granted same to said *Thomas Audeley* and *Katherine* his wife, for their lives, and the longer liver of them, with remainder to *George Twyncho*, of Cayford, co. Somerset, gent., and *Anne* his wife, dau. and heir of said *Thomas*, and the heirs of their bodies. *Thomas* died, and *Katherine* survived him and still survives. The said *Thomas* died on Tuesday after Corpus Christi last past, and said *Anne*, wife of *George Twyncho*, is his dau. and heir, aged 17 years and more. (Tenures and values given). (Chancery Inq. P.M., Series 2, vol. 21, no. 31.)

The jurors (named) say on oath that a certain *Thomas de la Hay*, sen., esq., and others (named), were seised of a messuage in Monyton upon Wey, and of 2 messuages in Staundon, and a messuage in Byford, and 8 messuages, a water mill, 100 acres of land, 40 acres of meadow, 6 ——— (illegible), and a messuage in Bewall, and one in Dylwyn, and one in le Were, and by deed of 20 Feb., 22 Hen. (Tenures given). *Sir John* died 18 Apl., 21 Hen. VIII. (1529), and *John Awdeley*, esq., is his next of kin and heir as is aforesaid, and is aged 16 years and more. (Escheators' Inq. P.M. Series 2, file 633, no. 5. Taken thence instead of from Chancery Inq. P.M., 52 8, which is mostly illegible).

Suffolk. JOHN AUDELEY, KNT. Inquisition taken at Ipswich, 19 Jan. 37 Hen. VIII. (1545/6). The jurors (named) say on oath that was seised in his demesne, as of fee, of the manor of Cokfeld, to use of *John Audeley*, knt. a certain *Elizabeth Blake*, widow of *Thomas Blake*, esq., to be had and solemnised After *Elizabeth's* death to remain to *Anthony Wingfield* and others, and by deed of 27 Jan., 23 Hen. VII. (1507/8), and *Elizabeth* survived, and with others held same to use of *John Awdeley*, knt., and his heirs for ever. After *John* died and to wit, son of *Richard Awdeley*, esq., decd., and next heir of *John Awdeley*, knt. After the death of *John Awdeley*, esq., the manor descended to *Edmund Awdeley*, esq., as his brother and next heir. *Sir John* was also seised of the manor of Witlesham, and the advowson of that church, and in consideration of a marriage to be had between him and said *Elizabeth*, the said *Elizabeth*, *Edward Howard*, knt., and others (named), were encoffed of same to use of said *Elizabeth* and after her death to said *Sir John Awdeley*, knt., and afterwards *Sir John* married *Elizabeth*, and she was seised of same, and he of the reversion, and same descends to *John Awdeley*, esq., as next of kin of *Sir John*, to wit, son of *Richard*, decd., son and heir of *Sir John*, and after death of *John Awdeley*, esq., to *Edmund Awdeley* as his brother and heir. Pledges of prosecution, *John Salter*, of London, gent., and *John Somner*, of same, yeoman [Early C.P., C.1, 43, 28].

DEVEREUX *v.* AUDELEY

(1473-5). Complaint made to the Bishop of Durham, Chancellor of England, by *John Devereux*, knt., that *Hugh Shelwyke* was seised of 6 messuages acres of meadow, 28 acres of pasture, and 30 acres of wood in Luyde Godfray, co. Hereford, and thereof enfeofed *Edmund Audeley*, clerk, *Richard Pede*, clerk, *Thomas Audeley*, gent., *John H*, and *Walter ap Huze*, chaplain, to the use of himself, and his heirs, and left a will that his exors. should settle same on his extrix., *Ankarett Barre*, who, after *Hugh's* death, sold same to complainant for a certain sum agreed. Although often demanded, said feoffees have always refused to make an estate to complainant, and he desires said *Edmund* may be caused to appear to answer the premises. Pledges of prosecution, *Walter Enderby*, of London, gent., and *Roger Gibbes*, of London, yeoman.

Answer of *Edmund Audeley*, clerk, confirming the truth of the bill and enlarging on will of said *Hugh*, and that he is ready to make an estate of said premises.

Replication of *John Devereux*, knt., *re same* [Early C.P., C.1, 48/252].

TYMPERLEY *v.* AUDLEY

(1486-93). Complaint made to the Archbishop of Canterbury, Chancellor of England, by *William Tymperley*, that his father, *John Tymperley*, esq., was seised of the manor called Mansers, with lands and tenements, and a water-mill called Aldham Mill, and all lands thereunto belonging, in Hadleigh and Aldham, co. Suffolk, and a close called Caleyces, and land at Dedegrom, and a tenement called Hadleys in Hadley, and another tenement in Hyntlesham called Hilles Place, sometimes Whetherellys, now in farm of *Thomas Podde*, and so being seised enfeofed *Edmond* [*Audley*, in Calendar], Bishop of Rochester, *Henry Wentworth*, knt., *John Paston*, knt., *Thomas Fastolf*, esq., and others, in trust to the use of him, said *John Tymperley*, and to the uses of his will, and by said will he bequeathed said manor and premises to complainant in tail male, with reversion in default of male issue to *William*, son of *Nicholas Tymperley*, in tail male. Although the trustees have been notified of said bequest, they refuse to make estate to complainant. Pledges of prosecution, *Richard Harries*, of Westminster, tailor, and *Humfrey Hert*, of same, yeoman.

The answer of *Edmond, Bishop of Rochester*, and the other trustees, that they were enfeofed of same manor, etc., but know nothing of *John's* will, and as *John Tymperley*, son and heir of said *John*, claims same, they desire he may be sent for to make answer.

Answer of *John Tymperley re same* (about *Tymperley* family; no more of *Audley*) [Early C.P., C.1, 110/98].

STANLEY *v.* AUDELEY

(1486-93). Complaint made to the Archbishop of Canterbury by *William Stanley*, knt., that by Parliament held [blank] Jan., IV. Henry VII. [1488/9], and prorogued 14 Oct. then following, it was ordained that the said *Sir William* and his heirs should enjoy the manors of Pykhill, Sesewyke and Bedewall, the moiety of the manors of Iston, Hewlyngton, Totham, Isham, Wrexham, Burton ngton, Estlufham, Eglofeild, Ruyabon, Abybury, Morton fabrorum, Dymill Minere, Oshaston, Soxford, Oseleston, the moiety of the Castle, lordship and manor of Dyn ran Castle, castle, lordship and town of Hone *alias* Holte, and of the lordships, manors, and lands of Howelyngton, Bramfeld, Yale, Wrexham and Almore, and the advowson of the moiety of the church of Gresford in Wales, and March of Wales to co. Shropshire, and whereas *Edmund* [*Audeley*, in Calendar], Bishop of Rochester, and *Master John Gunthorp*, clerk, were enfeofed of all said manors, etc., to the use of *Edward IV.*, late King of England, and his heirs, although often requested, they have utterly refused to make an estate of same to said complainant. Pledges of prosecution, *Wilham Yong*, of London, yeoman, and *John Saynton*, of same, yeoman.

Answer of *John Gunthorp*, clerk, that, with consent of the present *Queen*, and *Ladies Cecyll, Anne, Katherine and Bridget*, her sisters [in-law], daughters of *Edward IV.*, and his heirs, he is willing to make such estate.

Answer of *Edmond, Bishop of Rochester*, to like effect [Early C.P., C1, 108/98].

AUDLEY v. AXSTELL

[died 1492], named complainant as one of his exors., and he was at his funeral, and held divine service to the laud of god and the honour of said Marquess, but now one *Henry Axstell*, draper of London, has commenced an action of debt against complainant and the other exors., in London, to recover money due from the Marquess, and whereas complainant is far from London, has not intermeddled with the Marquess's goods, and is a lord of the Parliament, he desires a writ may be issued to said *Axstell* to appear and answer the premises. Pledges of prosecution, *Henry Moton*, gent., and *John Talbot*, gent. [Early C.P., C.1, 205/97].

AUDLEY v. LEGHTON

(1493-1500). Complaint made to *John, Cardinal Archbishop of Canterbury*, Chancellor of England, by *Edmond [Audley, in Calendar]*, Bishop of Hereford, that by Act of Parliament made in the 12th year of the present King [12 Henry VII., 1496-7] it was enacted that all persons having lands above £10 in value should pay a certain aid or subsidy, that notwithstanding one *Thomas Leghton*, knt., *Piers Newton* and *Thomas Acton*, commissioners in co. Salop for said aid, have assessed complainant at 3s 4/4 for his lands in said county, although the same have always been taxed in the diocese of Hereford and province of Canterbury, and which he has already paid in said diocese, and so is doubly taxed. He desires the commissioners may be caused to appear to answer the premises. Pledges of prosecution, *John Dore*, of London, yeoman, and *William More*, of same, yeoman [Early C.P., C.1, 205/50].

AUDELEY v. EYRE

(1504-15). Complaint made to *William, Archbishop of Canterbury*, Chancellor of England, by *Sir John Audeley*, knt., *Elizabeth* his wife, and *Roger Towneshend*, esq., that said *Elizabeth* and *Roger* are exors. of *Thomas Blake*, esq., lately decd., and sometime husband of the said *Elizabeth*, that in his lifetime the said *Thomas* lent *William Eyre*, gent., £10, and he dying made his wife, *Elizabeth Eyre*, extrix., and although demanded divers times to pay same the said *Elizabeth Eyre* has always refused; as no bond was made for same they cannot recover at the common law, and they beg said *Elizabeth Eyre* may be caused to appear to answer same. Pledges of prosecution, *John Roos*, of London, yeoman, and *Thomas Smyth*, of same, yeoman. Endorsed:—In Octaves of St. Martin, 24 Henry VII. [1508]. [Early C.P., C.1, 276/24.]

TOWNSEND AND AUDELEY v. ENGLOSSE

(1518-29). Complaint made to *Thomas, Lord Legate, Cardinal Archbishop of York, Chancellor of England*, by *Sir Roger Townsend* and *Sir John Audley*, knts., that they and *Sir Robert Brandon*, knt., lately decd., were bound to *Sir Thomas Lovell*, *Sir Thomas Englesfeld*, and *Sir John Husee*, knts., in £100, to pay £40 to the Treasury for the King's use on behalf of said *Sir Robert Brandon*. Lands of the latter have come into the hands of *John Englosse* and *Dame Katherine* his wife, late wife and sole extrix. of *Sir Robert*, and they ought to pay the said money, but refuse to do so.

Answer of *John Inglosse* and *Dame Katherine* re same.

Replication of complainants re same (nothing further re *Audley*) [Early C.P., C.1, 585/42].

HAWE v. AUDELEY

(1518-29). Complaint by *John, Prior of Pentney*, that formerly there was dissension between his predecessor, *Walter, Prior of Pentney*, and *Robert, Abbot of Sawtre*, concerning lands in Naxford, co. Norfolk; by deed of 7 Oct., 10 Henry IV. [1408], the lands were demised to said *Walter*, then *Prior of Pentney*, to have and to hold to him and his successors for 99 years at C.s. a year rental. Now *Sir John Audeley*, knt., has obtained from *Robert Walton*, *Abbot of Sawtre*, a lease of the premises for 80 years, at £7 a year, and strife grew between complainant and *Sir John*, and for peace's sake the *Prior* bought his interest in the premises of him for £40, and *Sir John* conveyed same to *Roger Townsend* and *John Spelman*, to complainant's use, and the latter built a watermill thereon, and occupied same with his sheep, etc., until August last past, when *Sir John*, with two of his servants, riotously entered into his pasture at Swaffham, parcel of the said farm, when 800 sheep were pasturing on 500 acres there, and threatened the *Prior's* servant, *Thomas Maltman*, to cut off his ears unless he removed said sheep, and neither complainant nor his shepherd could keep the sheep there, for fear of *Sir John*, and said sheep were like to have famished for lack of pasture. He brought a suit concerning same, and the Court gave order *Sir John* was not to intermeddle until divers gentlemen of Norfolk had discussed the matter. But *Sir John*, disobeying said order, has

entered same, and threatened his tenants, etc., and he desires he may be restrained from doing so. Pledges of prosecution, *Robert Howson*, of London, yeoman, and *William Norton*, of same, shereman [Early C.P., C.1, 559/49].

AUDELEY v. CONGHURST

(1518-29). Complaint made to *Thomas*, Lord Cardinal, *Archbishop of York*, Primate and Chancellor of England, by *John Audeley*, knt., and *Dame Elizabeth* his wife, *Dame Margaret Carew*, widow, and *Thomas Marow*, esq., that *John Colt*, esq., and others, were seised of the manor of Rumbolds, and messuages, lands, etc., in Stepney and Hackney, co. M^{sex}, and of two messuages in par. of St. Anthony Buggerowe, London, and two messuages in Aldermary in Watling Street, and a messuage in Old Change, St. Giles without Cripplegate, London, and two cottages in Legg Alley there, to use of complainants, that is to use of *John*, *Elizabeth* and *Margaret* for the term of their lives, and to the heirs of the bodies of *Elizabeth*, *Margaret* and *Joan Marowe*, mother of said *Thomas*. The evidences have come into the hands of *George Congherst* and *Margaret* his wife, late wife of *Nicholas Chadworth*, gent., bror. of said *Elizabeth*, *Margaret* and *Joan*, and although often required they have refused and still refuse to deliver same.

Answer of *George Congherst*, that he and his wife were peacefully seised of said premises before *John Colt* was supposed to have held same, until in the 6th year of the King that now is [6 Henry VIII., 1514-15] *Sir John* forcibly entered, and afterwards to establish her right *Margaret* (*Congherst's* wife) entered into a messuage in London, and *Sir John* kept her prisoner there 14 or 15 weeks, so that food could only be conveyed to her on a pole from the street to the window of her chamber, and they were so worried and vexed that, by the advice of friends, they came to an agreement with complainants that the latter should enjoy the said manor and premises at a yearly rental of £20, but the said money has not been paid, and they claim the same, or said premises.

Replication of *Sir John Audeley*, knt., and the other complainants, that *Sir Thomas Frowick*, knt., and others, were seised of the premises long before *George Congherst* and his wife had any estate therein, and *Sir Thomas* gave same to said *Elizabeth*, *Margaret* and *Joan*, and *Joan* dying her third part descended to her son, *Thomas Marrow*, and so held same until *George Congherst* and his wife disseised them.

Rejoinder of *George Congherst* and *Margaret* his wife, re-affirming their answer [Early C.P., C.1, 459/6].

VEYSEY v. AWDELEY

4 Nov. 1560. Complaint by *Henry Veysey*, of Badburgham, co. Camb., gent., that *Alan Chapman*, of same, gent., was seised of the manor of Brusard [? Bruisyard, co. Suffolk], and about 13 years ago conveyed same to *Peter Chapman*, in trust for himself (*Alan*) and *Margaret* his wife, for life, and after to their son, *John Chapman*, and *Jane* his wife, and their heirs. Afterwards the manor came into the possession of various persons; no mention of *Awdley*.

Another complaint by same *re* manor of MonkPELLERS, in Badburgham, which *Alan Chapman* held in like manner, and which passed into the hands of *Edmund Awdley*, of Pallgrave, co. Norfolk, and others.

Answer of *Edmund Awdley*; no genealogical details [C.P., Series 2, C.3, 184/4].

AWDLEY v. BAXTER

31 Jan. 1600-1. Complaint by *Edward Coke*, esq., Attorney General, and *Philip Awdley*, esq., that the latter was seised in demesne of the manor of Little Dunham, co. Norfolk, and mortgaged a moiety of same to *Thomas Baxter*, of Norfolk, gent., and after said *Edward Coke* bought same of *Thomas Baxter*, and it was agreed that *Philip Awdley's* indenture made with *Baxter* should be delivered up to him and *Edward Coke*. But *Thomas Baxter* has not delivered same and refuses to do so. They beg he may be commended to appear to answer the premises [C.P. Elizabeth, C.2, A. 6/5].

LONDON v. LONDON

21 May 1601. Complaint by *Samuel London*, of Alsford, co. Essex, yeoman, son and heir of *Roger London*, late of Much Tey, yeoman, decd., that his father in his lifetime was seised of the manor or chief messuage called Overhall, in Colne Engayne, and lands there, all of which were held of *Philip Awdley*, esq., as of his manor of Whitnesam, in Whitnesam, co. Suffolk, by the one and twentieth part of one knight's fee, and *Roger*, by his will dated 6 Apl. 1570, bequeathed same to his wife *Joan*, with remainder to *Roger*, younger bror. of *Samuel*. *Samuel* was entitled to a third part as eldest son and heir, and at 15 he was taken as a ward by *Mr. Awdley*. The proceedings concern a dispute between the *Londons*, and *Awdley* is not further concerned [C.P. Elizabeth, C.2, L. 8/59].

P. 142. Thomas Guybon, of Kings Lynn, in co. Norf., esq., mard., as the third of his four wives, "Ele [Ella], widow of Thomas Derham & da. to Sir John Awdeley of Swaffham Market in co. Norf., knight."

The Tyrell pedigree recorded at the Visitation of Essex in 1558 shews "Anne, ux. Edmond Audeley," as daughter of Sir Thomas Tyrell, of Heron, knt., with a sister, also Anne, married to John Darcy, and a sister Elizabeth married to Robert Darcy (*Harleian Soc.*, XIII., 113).

The Visitation of Shropshire, 1623, shews "Richardus Grey miles de Powisia Inq. 6 E. 4" as husband of "Margareta filia Jacobi de Audeley renupta Do [minus] Berkley et 3^o Henricus Dom. Roos." (*Harleian Soc.*, xxviii., 105). Elsewhere it shews "Richard Gray" as husband of "Margaret da. to James Lord Audley," with a child "Elizabeth da. to Richard Gray Lord Powis," married to "Johannes Ludlowe" (*ibid.*, xxix., 342).

MISCELLANEOUS EVIDENCE

In Blomefield's *Norfolk*, under "Swaffham," is given the following account of the family (vi., 209-10) :—

At the upper end of this aisle lies a large gray marble stone, with the portraiture of a person in complete armour, on his surcoat are the arms of TOUCHET and AUDLEY, quarterly, viz. in 1st and 4th ermine a chevron *gul.* in 2d and 3d *gul.* a frett *or.* by which we are asured that it is in memory of Sir JOHN AUDLEY of this town, who lived and died in the reign of King Henry VIII. and the same shield is painted on the glass in the window of the *parlour* in the *vicar's* house; the nobility and gentry in ancient days, wore over their armour, rich surecoats of silk and satin embroidery, as the *heralds* do at this day, whereon was curiously wrought the arms of their house and family in their proper colours, &c. and such a coat the renowned Lord AUDLEY wore at the battle of *Poitiers* in *France*; this stone had also the portraiture of his lady, and several shields in brass, &c. all which are reaved except part of one at the foot of the stone, and on the left side, which seems, being almost obscure, to be only the impalement of his lady, the other part being covered by a pew, viz.

Quarterly in 1st quarter, quarterly a chevron, a fess indented, &c. between three lions heads erased, and as many plates in 1st and 4th, in 2d and 3d quarter lozengy, the 4th as the 1st.

This Sir JOHN was of a noble family, being descended from Sir JOHN TOUCHET of *Marketon*, who by *Jane*, sister and heir of *Nicholas* Lord *Audley*, had

JAMES TOUCHET Lord AUDLEY, who had two wives; by his first wife, *Margaret*, daughter of *Thomas* Lord *Roos* of *Hamlake*, he had Sir JOHN TOUCHET Lord *Audley*, and by *Eleanor* his second wife, two daughters; *Anne*, married to *Richard Delabere*, and *Margaret* to *Grey* Lord *Powis*, and three sons: *Thomas* the youngest, *Edmund* the second was Bishop of *Rochester*, *Hereford* and *Salisbury*;

Sir HUMPHRY AUDLEY, Knt. the eldest son, married *Elizabeth*, daughter of Sir *Philip Courtney*, Knt. relict of Sir *Thomas Lutterell*, and had two daughters, the youngest married *Stewkley* of *Devonshire*; and the eldest *John Hadley* of *Somersetshire*; but their son,

Sir JOHN AWDLEY, lived at *Swaffham* in 1526, and had two wives; *Elizabeth*, his second wife, and *Muriel*, daughter of Sir *Thomas Breese* of *Wenham* in *Suffolk*, by whom he had

RICHARD AWDLEY of *Swaffham*, Esq.² who married *Catharine*, daughter of *Richard*, younger son of the Lord *Scroop* of *Bolton*, and had

PHILIP, his eldest son, married *Margaret*, daughter and coheir of *John Calibut* of *Castleacre* in *Norfolk*, Esq. and had ANNE, a sole daughter and heiress,⁴ who married *Christopher Paston* of *Oxnead* in *Norfolk*,

His second son was JAMES AWDELEY ; and his third,

THOMAS AWDELEY of *Attlebridge*,* who married *Catharine*, daughter of *Reginald Knatchbull*, whose daughter and coheir, *Catherine*, married to *Richard Butler* of *Cullam* in *Ireland*.

"1534, Master *Robert Audeley*, Archdeacon of *Berkshire*, who resigned his college, with all its revenues to the King, it being then valued at 52*l.* 15*s.* 7*d.* ob. ; *Nicholas Marwell* and others were fellows, and signed the supremacy" (dissolution of the monasteries). vi., 228. Swaffham. "In the *parlour* of the *vicarage-house* are these arms painted in glass, TOUCHET and AUDLEY (as before) quarterly, *sab.* three martlets arg."

viii., 363. Castleacre. Stone in church, on floor of chancel. "In memory of *Audley*, with his arms, *gules*, a fret or. From the "Scrope of Bolton" chart in Foster's *Yorkshire Pedigrees* it appears that Richard Audley, of Swaffham, co. Norfolk, esq., married Katherine (unmarried Aug. 1498, living Oct. 1521 as Mrs. Audley), daughter and coheir of Richard Scrope, of Bentley and Little Weeton, parish of Rowley, co. York, and of Langley Castle, co. Durham (second son of Henry, fourth Baron Scrope of Bolton), by Eleanor his wife, daughter of Norman Washbourne, of co. Worc. (and see *Genealogist*, New Series, XV., 164).

G.E.C.'s *Complete Peerage*, under "Cobham," gives Edward Brooke, 6th Lord Cobham, M.P. for Somerset 1442, and died 1464, before 8 Nov., as married to Elizabeth, daughter of James Tuchet, Lord Audley (by his second wife, Eleanor Holland), by whom he left issue. And under "Grey de Powis" Sir Richard Grey, 1st Lord Powis (born 5 Nov. 1436, bapt. at Pontesbury, died 17 Dec. 1466, aged 30), is shewn as married before 12 Jan. 1458/9 to Margaret, widow of Sir Roger Vaughan, knt., and daughter of James Tuchet, Lord Audley, by his second wife, Eleanor Holland—she dying before 2 Feb. 1480/1.

Collinson's *Somerset*, ii., 48, shews Richard Hadley, of Withycombe, son of John Hadley and Joan his wife, daughter of Richard Stawel, as married to Philippa, daughter of Sir Humphrey Audley, knt., and having issue by her.

The "Twinyhoe of Turnworth" pedigree in Hutchins's *Dorset*, iii., 468, shews George Twinyhoe, of Kayford, aged 26 and more 31 Oct., 13 Henry VII. (1497), son of John Twinyhoe, of Kayford, as married to Elizabeth (*sic*), daughter of Thomas Audeley, brother to James, Lord Audeley, and having issue.

Edmund Awdeley, of Palgrave Magna, co. Norfolk, 1563, married Mary, who died before 1557, daughter of Sir Philip Parys, of Linton, co. Camb., knt., by Margaret his wife, daughter of John Bowes, citizen and mercer of London, and had "two daughters" (*Miscellanea Genealogica et Heraldica*, Series 5, vol. 2, p. 124).

Jones's *Fasti Sarisburiensis*, p. 152, says that Robert Audley was Prebendary of Ramsbury, in Salisbury Cathedral, 1514, and was collated by his uncle, Edmund Audley, the Bishop, on 14 Feb. 1522, to the Archdeaconry of Berkshire, on death of W. Grey.

In the "Victoria County History," *Hertfordshire*, vol. iii., p. 356, is record of a projected Audley marriage that seemingly did not take place:—

(Manor called Sotes or Sutes, in Standon, conveyed in 1427/8 to certain feoffees). The feoffees probably held in trust for Nicholas Ellerbek, as he died seised in 1472.¹ His daughter and heir Margaret married William Tendring, and they with Margaret's mother Ann, who after Ellerbek's death married John Digges, conveyed the manor in 1493 to Henry Marney and others,² probably for a settlement on William and Margaret. This Margaret survived a second husband,³ and at the age of fifty-seven, as Margaret Marzen, widow, seems to have intended a marriage with Richard son of Sir John Audley, kt.,⁴ of Swaffham, co. Norfolk, but apparently the marriage never took place. William Tendring, who died about 1500, left two daughters, one of whom, Margaret, wife of Robert Forster, of Little Birch, co. Essex,⁵ seems to have inherited the whole of Sutes.

Walter Rye, in his *Norfolk Families*, 1913, p. 11, tells us that Philip Audley subscribed £25 to the defence of the country in 1588.

From two Star Chamber cases of 1528 and 1538 it appears that the Audley lords of the manor of Horton, in Staffordshire, were represented at the time of a lease mentioned in the first case by George Twynceoo and Anne his wife, in right of said Anne; and that by 1538 she had married Richard "Inketepen" (Josiah Wedgwood's *History of Wedgwood Family*, 1908, pp. 10-11; and his *Wedgwood Pedigrees*, 1925, p. 51).

Mr. Raymond Tinne Berthon, of Selsey, near Chichester, tells me that the will of Robert Rolfe, of Sporle, co. Norfolk, husbandman, dated 20 Jan. 1558/9 and proved 10 Oct. 1559 at Norwich, was witnessed by "Edmdd. Audleye." He also says that John Dethick, of Wormegay, and later of Fincham, both in co. Norfolk (whose will, dated 1556, was proved 27 Jan. 1558/9 in P.C.C. (28 Welles), who married Elizabeth Chamberlain and had by her an eldest son Edmund Dethick), had a second wife "Anne," who survived him. He suggests that this was Ann Tyrrell, who became second wife of Edmond Audley (whose first wife died before 1557), and that her children, John Dethick under 20 in 1556, and Elizabeth Dethick her father's "youngest daughter" in 1556, were the John Dethick, and Elizabeth Dethick "my daughter in law" (i.e., step-daughter), mentioned in Edmond Audley's will in 1585. As Edmond Audley mentions his "daughter Dethick," immediately after John Dethick, Mr. Berthon suggests further that this John married one of Edmond's own daughters.

G.E.C.'s *Complete Peerage*, under "Audley of Helleigh," shews James Tuchet, 5th Lord Audley, son of John Tuchet, 4th Lord Audley, as aged 10 at his father's death in 1408; Chief Justice of South Wales, 17 Nov. 1423; Chamberlain of South Wales, 11 Feb. 1438/9, and again 24 Oct. 1441; had chief command of some forces in war with France, 1430; defeated and slain by Yorkists at Battle of Blore Heath, Salop, 23 Sept. 1459, aged about 61; Sir Roger Kynaston, of Hordley, co. Salop, who actually slew him, took his arms. He married, 1stly, Margaret, daughter of William Roos, Lord Roos, by Margaret, daughter of John Arundel, Lord Arundel; she, who got a Papal Dispensation in March 1415, was living Sept. 1423, and her son John succeeded as 6th Lord Audley. The 5th Lord married, 2ndly, Eleanor, illegitimate daughter of Thomas Holland, Earl of Kent, by Constance, daughter of Edmund, Duke of York. Two children only of this second marriage are mentioned: (1) "Sir Humphrey Audley, slain at Tewkesbury 1471, said to be ancestor of Audleys of Norfolk"; and (2) Edmund Audley, the Bishop of Salisbury.

The pedigree of Audley in Hoare's *Modern Wiltshire*, I., ii. (1824), 227, shews as children of the second marriage of James, Lord Audley, to Eleanor Holland:—Sir Humphrey, slain at Tewkesbury; Edmund, Bishop of Salisbury, ob. 1524; Thomas, s.p.; Margaret, wife of "Hen. Grey, Lord Powis"; Elizabeth, wife of Edward Brooke, Lord Cobham; and Constance, wife of Sir Robert Whitney.

The statement already quoted from the Shropshire Visitation of 1613 (*ante*, p. 166) that Margaret (Audley), widowed by Richard Grey, Lord Powis, in 1466, was remarried to Lord Berkeley, and again (3rdly) to Henry, Lord Roos, finds no support in G.E.C.'s *Complete Peerage*. James, 1st Lord Berkeley, died in 1463, and his son, William (1426-92), 2nd Lord Berkeley, created Viscount Berkeley in 1481, Earl of Nottingham in 1483, and Marquess of Berkeley in 1489, married three times, in 1466, 1468 and *circa* 1486, but none of the ladies was Lord Powis's widow. From the Chancery suit of *circa* 1493 (see *ante*, p. 163), however, we learn that Margaret's brother, Edmund Audley, then Bishop of Hereford, was an executor of the Marquess of Berkeley, and officiated at his funeral in 1492, which indicates some personal relationship. Henry, Lord Roos, I do not identify: Thomas (1427-64), 10th Lord Roos, was succeeded by his son Edmund (1446-1508), 11th Lord Roos, who died unmarried.

William A. Shaw's *Knights of England*, vol. ii., p. 30, gives "John Awdeley, of Suffolk" (at the Bridge Foot, on King's entering London after Battle of Blackheath, which was on 17 June), among the Knights Bachelor of 1497.

James Gairdner's *Paston Letters*, 1895, vol. iii., p. 350, includes a letter of 10 Feb. 1489, from Mrs. Margery Paston, daughter of Sir Thomas Brews, to Sir John Paston, in which she says that "ther be apoyntyd serteyn captens at thys season," the list including "myn broder Awdley." He, of course, was the future Sir John Audley, already married to another daughter of Sir Thomas Brews.

It will have been noticed that Blomefield at two references says that Christopher Paston married Anne, daughter and heir of Philip Audley. But it is Philip's father, Edmond Audley, who in his will in 1585 mentions "my daughter Paston." The dates, too, make it more probable that Ann was Edmond's sister rather than his daughter, and became his heir on the death without issue of his son Edmond. The Visitation of 1563 shews but one daughter of Edmond Audley, Elizabeth, so presumably, if he had other daughters, Mrs. Dethick and Mrs. Paston, they were born after 1563.

Professor James Gairdner contributed the following account of Bishop Audley to the *Dict. Nat. Biog.* : —

AUDLEY, EDMUND (*d.* 1524), bishop of Rochester, was the son of James, Lord Audley, by Eleanor his wife. He was educated at Lincoln College, Oxford, and took the degree of B.A. in 1463. It is presumed, though no record is found of the fact, that he afterwards took the degree of M.A. also. In 1464 he was collated to the prebend of Colwall in Hereford Cathedral, and three years later to that of Iwern in Salisbury. In 1472 he was made a canon of Windsor. In the same year he received the prebend of Farrendon in Lincoln Cathedral, in 1474 that of Gaia Minor in Hereford, and in 1475 that of Codeworth in Wells. On Christmas day in the same year he was made archdeacon of the East Riding of Yorkshire, and in 1479 archdeacon of Essex. These substantial preferments he does not seem to have found at all incompatible with each other, and though we find that he resigned the rectory of Bursted Parva in Essex on 9 April 1471, he had no difficulty in accepting another prebend, that of Gevendale in York, on 18 Oct. 1478. In 1480 he was made bishop of Rochester, when he resigned his two archdeaconries and most of his other preferments. In 1492 he was translated to Hereford, and in 1502 to Salisbury. About the time of this last preferment he was also made Chancellor of the order of the Garter — an office which in the sixteenth century Dr. Seth Ward endeavoured to unite, or, as he put it, to restore, to the see of Salisbury, for which he maintained it was intended when given to Bishop Audley.

This Catalogue of his honours and church preferments really comprises almost all we know about the man; and it may be remarked that whereas his two last bishoprics are supposed to have been given him for the fidelity of his family to the house of Lancaster, all his previous benefices, including the bishopric of Rochester, were bestowed upon him during the reign of Edward IV. It will be asked, what then was his claim to distinction? The answer is that although not an author he was a patron of letters, and was complimented as such by the university of Oxford for having bestowed a prebend in Salisbury on Dr. Edward Powell (afterwards a martyr at Smithfield for denying Henry VIII's supremacy) who had written a book against Luther. He was a benefactor to Lincoln College, Oxford, to which he gave, in 1518, 400*l.* to purchase lands. He also bestowed upon it the patronage of a chantry in Salisbury Cathedral. He seems, moreover, to have been a contributor to the erection of a stone pulpit in St. Mary's Church at Oxford, at the bottom of which, according to Wood, his arms were seen carved along with those of Cardinal Morton and FitzJames, bishop of London. But of this pulpit even Anthony à Wood, writing in the seventeenth century, speaks in the past sense, and what became of it we are not informed. Godwin says that Bishop Audley also gave the organs to St. Mary's Church; but this is doubted by Anthony à Wood. In 1509 he gave a donation of 200 marks to Chichele's chest at Oxford, which had been robbed. It further appears that he was a legatee and executor of Henry VII., and one of the trustees for the foundation of the Savoy Hospital (*Calendar of Henry VIII.*, i. 776, 3292); that in 1516 he obtained from Henry VIII a license to found and endow two chantries, one in his own cathedral and one in Hereford (*ib.* ii. 2660); and that in 1521 he suppressed the nunnery of Bromehall in his diocese on account of the misconduct of its inmates, for which he received a letter of thanks from the king (*ibid.*, iii. 1863). He died at Ramsbury in Wilts on 23 Aug. 1524, and was buried in a chapel erected by himself in his own cathedral of Salisbury in honour of the Assumption of the Virgin Mary. (Wood's *Athenæ*, ed.
