This is a pedigree which begins "in the air," with two brothers, John and Edward, whose parentage has not been traced. And it is by no means complete for the few generations to which it extends. Most of its members have their careers yet to be traced, including the children in the last generation, who seem to have left Beccles.

The Chancery suit of 13 Jan. 1686/7 states that Edward Audley was married to Anne Stretchley, at St. Pancras church, about 1672: unfortunately the clerk there made note of the marriages round about that date on slips, which he lost before he could enter them up in the register.

From an indenture of apprenticeship at the Record Office (Ine. 1/49.89), we learn that Edward Audley, son of Mary Audley, of Beccles, was apprenticed to Henry Ray, of Diss, co. Norfolk, grocer and chandler, on 10 Jan. 1727/8.

A difficulty arises at one point in the pedigree, for the Chancery suit of 6 July 1725 defines Mary Audley, the mother of Edward, as then a widow, whereas Edward Audley the elder, her husband, was not buried at Beccles until 5 Sept. 1727, four days before his will was proved.

The will of Thomas Stretchley, in 1678, uncle of Anne Stretchley who married Edward Audley about 1672, gives such an extraordinary amount of genealogical information (quite gratuitously), that a detailed pedigree can be constructed from it. And the will of his niece Sarah Stretchley, who married Thomas Bambrigg, adds more information. Thomas Bambrigg, of Gray's Inn, esq., bachelor, aged 28, was licenced to marry Sarah Stretchley, spinster, aged 17, daughter of Edward Stretchley, of St. Mary le Bow, London, citizen and scrivener, who alleged, on 11 July 1662, for Chigwell, co. Essex (*Harleian Soc.*, vol. 24, p. 62, where the name is spelt "Bainbrigg"). A pedigree of the Croleys was recorded at the Visitation of London, 1634 (*Harleian Soc.*, vol. 15, p. 206), which can be extended by reference to the "Baronetages," to Venn's *Alumni Cantabrigienses*, etc. "Edward Stretchley," born 2 Nov. 1610, who entered Merchant Taylors' School in 1619 (*Register*, ed. Charles J. Robinson, 1882, I., 99), was no doubt the father-in-law of Edward Audley.

Another apprenticeship at the Record Office (Inc. 1/50.48), of Ann Audley, daughter of Mary Audley, to Martha Harris, of Norwich, mantua maker, on 1 May 1741, may very likely be that of Edward and Mary's youngest daughter, born in 1722.

WILLS AND ADMINISTRATIONS

THOMAS STRETCHLEY, of London, gentleman. Will dated 6 Aug. 1678. I was born 1 Mch. 1612/13 in Pannyer Street *alias* Pannyer Alley, London, in the White Lion, next to that stone which has an inscription on that it is the highest ground in London, in the parish of Christchurch, and baptised in that church 7 Mch. in the same year. I desire to be burd. near my father and mother, who are burd. in said church, in the North aisle, called the New Church, under the Gallery. To my kinsman, *John Stretchley*, my kinswomen, *Mrs. Sarah Bambridge*, *Ann Stretchley* now *Audley*, children of my eldest and only (*sic*) bror., *Mr. Edward Stretchley*, decd., by my father, *Mr. Thomas Stretchley* and *Jone Cropley*, his wife, both long since dead (*Joan Cropley* having been born in Soham, co. Camb., and sister to *Edward Cropley*, citizen and mercer of London, Master of Mercers' Company, Sheriff and Alderman of London, burd. in St. Michael in the Querne, London, about 1648, whose only son was *Sir John Cropley*, knt. and bart., lately decd. at his dwelling house at Fryon Barnett by Coney Hatch, co. M'sex, and burd. in Clerkenwell Church near his son, *Sir Edward Cropley*), I give £7 each. To *Thomas Bambridge*, son of said *Sarah*, £5. To my kinswoman, *Sarah*, dau. of my sister, *Sarah Speare*, decd., dau. of my father and my stepmother, *Grace Whaley* (niece of *Nicholas Askew*, citizen and mercer of London, of said par. of Christchurch, and interred in Hackney Church, co. M'sex), £7. To my sister, *Mrs. Deborah Glover* (sister of *Mrs. Spear*), and her sons, *John* and *Joseph Glover*, £7 each. To my sister *Mrs. Mary Robson*, now wife of *Mr. Thomas Robson*, and formerly of my half-bror., *Mr. William Stretchley*, £7, and to her said husband, £5. To *Mr. John Cropley*, son of *Sir John*, and to his wife, £10, and to his sister, *Mrs. Anne Holt*, and her husband, *Mr. John Holt*, £10. To *Mrs. Elizabeth Bradshaw*, granddau. of my uncle, *Edward Cropley*, and her dau. *Elizabeth*, £10. To *Lady Elizabeth Cropley*, widow of *Sir John*, decd., and her sons, *John* and *Benjamin Cropley*, her dau., *Mrs. Sarah Cropley*, and grandson, *Sir John Cropley*, and granddau., *Martha Cropley* (both children of *Sir Edward*, decd.), to my kinswoman, *Mrs. Priscilla Drewery*, dau. of *Mr. Robert Claphorne*, and "to my kinsman *Mr. Edward Wiffin* son to my aunt *Wiffin* that was my uncle *Edward Cropley Esquire* and my mother's sister," £5 each for rings. To my kinsman, *John Stretchley*, and his sisters, *Mrs. Sarah Bambridge* and *An Stretchley*, now *Audley*, my kinswoman, *Mrs. Jarman*, and her dau., *Mrs. Mary Pitts*, my kinsman, *William Cole, esq.*, counsellor at law, of Gray's Inn, living in Leather Lane, *Thomas Smith, esq.*, counsellor at law, of Essex Court, Temple, *Thomas Harris, esq.*, town clerk of Worcester, *Mrs. Elizabeth Flower*, my landlady when I lodged in Wood Street, during the plague and the dreadful fire, her dau. *Rose Flower*, *Dr. Richard Raynes*, Dr. of Civil Law, whose mother I take to be a *Stretchley*, my relatives, *Sir Robert Jeffereys*, of Lime Street, and his decd. wife's brother, *Mr. Luke Cropley*, of Broad Street, *Mr. Lawrence Veyer*, milliner at Fleur de Luce, Savoy, Strand, my bror., *Mr. Edward Nurse*, brasier at the George, Cornhill, and my sister his wife, and his son, *Mr. Luke Nurse*, and others (not relatives), to each a ring worth 20s. To 70 poor men and women in Christchurch par., 2s. 6d. each. My manors and lands in cos. Worcester and Hereford, and Isle of Ely, co. Camb., to Christ's Hospital, London, the Bluecoat Boys, and £5200 for the use of that school, they paying *John Stretchley*, son of my bror. *Edward*, decd., £50 a year for life, to my kinswoman, his sister, *Mrs. Sarah Bambridge*, £50 a year for life, to my kinswoman, their sister, *Ann Stretchley*, now I think *Audley*, £50 a year for life, to *Thomas Bambridge*, son of said *Sarah*, £10 a year for life, to my said sister, *Mrs. Mary Robson*, £30 a year for life, to her husband, *Mr. Thomas Robson*, £10 a year for life (and other annuities to people already named). Legacies to various Hospitals, etc. To *Samuel Stretchley*, whose father makes belts in the Round Court near the New Exchange, £10. I forgive the debts owing me by my bror., *Mr. Edward Stretchley*, decd., his wife, decd., his son-in-law, *Thomas Bambridge, esq.*, decd., and his son, *John Stretchley*, and by *Anne Stretchley*, now I think *Anne Audley*. To the Company of Salters, whereof my bror., *Edward Stretchley*, was once a clerk, £100. Bequests to Universities, Christchurch par., etc. My silver tankard, marked *W.S.*, given me by my uncle, *Mr. William Stretchley*, I give to *Mrs. Sarah Bambridge*. To my sister, *Deborah Glover*, a child's spoon marked *D.S.*, and other spoons. Resid. legatees and exors., *Thomas Smith, esq.*, counsellor at law, *William Cole, esq.*, counsellor at law, *Richard Rayne, esq.*, Dr. of Civil Law, and *Thomas Robson*, gent. I have hereunto set my seal, engraven with a blackamore's head. Signed, *Tho: Stretchley*. Wits., *William Searle*, *Dennis Wise*, *Edmund Searle*, *Andrew Yarranton* and *John Redmayne*. Proved 17 Oct. 1681, in P.C.C. (North, 146), by the exors. named, excepting *Thomas Smith*, who is dead.

EDWARD AUDLEY, late of the par. of St. Giles, Cripplegate, co. M'sex, decd. Admon. granted 4 Sept. 1696, in P.C.C., to *Anne Audley*, the relict (Admon. Act Book, f. 162).

SARAH BAMBRIGG, of Kensington, co. M[']sex, widow. Will dated 18 Apl. 1724. All my lands and tenements in Cottingham, co. Camb., which I hold by lease from the Masters and Fellows of Christ College, Camb., to my nephews, *Dr. Thomas Lynford* and *Mr. John Welbere, sen.*, on the death of either of them to my nephew, *Mr. Samuel Herring*, son of *Mr. Gerrard Herring* and *Mary* his wife, sister to *Dr. Lynford*; if the said *Samuel* die without issue, then same to his bror., *Mr. William Herring*, and his heirs. To my sister's son, *Mr. Edward Audley*, £500, and to his son, *Mr. Edward Audley, jun.*, £300, and to his dau., *Mary Audley*, £300, the latter two at their ages of 21. To my said nephew, *Mr. Samuel Herring*, £100, and my six spoons marked *T.M.B.* To my nephew, *Mr. Thomas Lardner*, £50, and to his sister, *Mrs. Mary Lardner*, my gold watch and chain. To my godson, *Mr. Thomas Herring*, my silver coffee pot. To *Mrs. Audley*, wife of *Mr. Edward Audley*, a pair of silver salvers and two silver salts. To my cousin, *Mrs. Eliza Glover*, £50, and to her son, *Mr. Thomas Glover*, £50, and to her dau., *Mrs. Sarah Glover*, £50. To *Mrs. Susanna Welbore*, dau. of my nephew, *Mr. Philip Welbore*, £50. To *Mrs. Margaret Whittle*, £2, and to *Mrs. Letitia Tompkins* a silver cup. Whatever *Mrs. Margaret* and her sister, *Mrs. Deborah Trumbell*, owe me, I forgive them. To my servants, *John Muckley* and *Elizabeth Shenton*, £50 each. Resid. legatee and exor., my nephew, *Mr. Samuel Herring*. Signed, *Sarah Bambrigg*. Wits., *Ro: Pountney*, *Thos. Duncumb* and *Rupt. Clarke*. Codicil of same date:—To nephew, *Dr. Wm. Herring*, and his bror. *Samuel*, a silver salver. Proved 7 Jan. 1724/5, in P.C.C. (Romney, 1), by the exor.

EDWARD AUDLEY of Beccles. Will dated 17 Feb. 1725/6. All estates to wife *Mary* for life, with remainder to children. To my son *Edward*, estate bought of *Mr. Solley*, at Barsham. My eldest son, *Edward Audley*; my second son, *Thomas Audley*; my eldest dau., *Mary Audley*; my youngest dau., *Anna Audley*. Extrix., my wife *Mary*, who is to pay £3 to her mother. Wits., *John Arlington*, *Mary Knights* and *Jane Dearing*. Proved 9 Sept. 1727, at Ipswich [Bk. 1723-27, Beccles, fol. 243].

CHANCERY PROCEEDINGS

HASLEWOOD *v.* AWDLEY

18 Jan. 1682/3. Complaint by *Cuthbert Haslewood*, citizen and draper of London, that his late brother, *John Haslewood*, of Dorchester County, Maryland, in parts beyond the sea, was entitled to goods and credits of *John Avery*, late of Dorchester County, gent., decd., having mard. *Ann*, widow of said *Avery*. After his brother's death, *Ann* came over and lodged in complainant's house, and he lent her money, and afterwards *Ann* took a shop to sell the commodities she had brought over with her, and one *Edward Awdley*, of St. Andrew Holborn, broker, insinuated himself into her acquaintance and borrowed money of her and gave her a bond for the same. *Ann Haslewood* died 1 May last, and complainant became possessed of her goods, including said bond, and desires to come to an account with said *Awdley*, who alleges he is entitled to the said goods, without exhibiting any bonds, etc.

27 Jan. 1682/3. Answer of *Edward Awdley*, that *Ann* was indebted to him in £39, and he believed her a single woman without relatives; he is willing to abide by the decree of this Court [C.P. before 1714, C.8, Mitford 309/121].

HASLEWOOD *v.* AWDLEY

3 Mch. 1682/3. Further answer of *Edward Awdley* to the bill of complaint of *Cuthbert Haslewood*. He believes *Anne Haslewood* was the widow of *John Haslewood*, but does not know for certain, nor does he know if complainant was brother-in-law of *Anne*. He borrowed £10 of her, but never gave a bond for same ——— no *Awdley* names or relationships appear [C.P. before 1714, C.7, Hamilton 598/60].

AUDLEY *v.* MOORE

15 Apl. 1686. Complaint by *John Audley*, gent., and *Anne* his wife, one of the daus. of *Edward Stretchley*, late citizen and salter of London, decd., that in 1678 *Thomas Stretchley*, of London, gent., bror. of said *Edward*, made his will on 6 Aug., and gave to Christ's Hospital, or the Blue Coat Boys, in the city of London, and their successors, for ever, all his manors and lands in cos. Worc. and Hereford, bought of *Mr. Vintner*, bringing in £380 a year, and to pay to said *Anne* £50 a year. In 1683 complainant's bror., *Edward Audley*, was outlawed at the suit of *Derry Witheridge*, since decd., and complainant being indebted to his said bror., *Sir John Moore*, and *Nathaniel Hawes*, esq., Masters of the said School, hesitate to pay said annuity, contending it was part of the debt, etc.

8 June 1686. *Sir John Moore* and *Nathaniel Hawes* answer *re* said annuity ——— no further *Audley* details [C.P. before 1714, C.8, Mitford 383/3].

JORDAN v. RAY AND AUDLEY

13 Dec. 1686. Complaint by *Edward Jordan*, of St. Andrew's Holborn, co. M'sex, gent., and *Susan* his wife, extrix. of last will of *George Witharidge*, late of St. Andrew's Holborn, oilman, decd., that *Edward Audley*, late of said par., broker, being indebted to said *Witharidge*, by a bond bearing date 6 Nov., 35 Charles II. (1683) in £100, was prosecuted upon the said bond in the Court of Common Pleas, and outlawed in London on Monday before St. Mark the Evangelist, 36 Charles II. (Apl. 1684). Also *Thomas Stretchley*, by his will bearing date 6 Aug. 1678, bequeathed all his manors and lands in cos. Worc. and Hereford to Christ's Hospital in trust to pay £380 and other rents, etc., to *Anne Stretchley*, now wife of said *Edward Audley*, and £50 yearly; and *William Cole, esq.*, *Richard Raynes, esq.*, and *Thomas Robson* were exors. *Edward Audley* was also indebted to *Judith Ray*, and, after failing in his business, he became bankrupt, and a commission of bankruptcy was obtained against him by said *Judith Ray* without the knowledge of the other creditors. The said *Judith* has confederated with said *Edward* and *Anne Audley* and a certain *John Audley*, and it is now pretended that the said *Anne* was never lawfully mard. to *Edward*, although complainants well know that *Edward* and *Anne* were lawfully mard. according to the laws of the Church of England, and lived together over 14 years, and had nine or ten children, and *Edward* received the said money from Christ's Hospital in right of his wife. They desire that *Edward* and *Anne* and *John Audley*, *Judith Ray* and others, may be summoned to answer the premises [C.P. before 1714, C.10, Whittington 509/8].

JORDAN v. AUDLEY

13 Jan. 1686/7. Answer of *Edward Audley* to the bill of complaint of *Edward Jordan* and *Susan* his wife, saying it is true he became bound to *George Witharidge* in a bond of £100 to pay £50, who became bound with him to *John Comes* for payment of £25, at the request of *Anne Audley*, this defendant's wife, for her use. Since, by various causes, he has become bankrupt, and his wife, prevailed upon by *Judith Ray*, has not only forsaken him in his adversity, but denies her marriage with him and pretends she is mard. to *John Audley*, after she had been wife to and cohabited with defendant above 14 years and had children by him. He has an annuity, which through the machinations of *Judith Ray*, the said *Anne*, and *John*, is not paid him. He was lawfully mard. to *Anne* at the par. church of St. Pancras, M'sex, about 1672, in the presence of creditable wits. [C.P. before 1714, C.5, Bridges 169/53].

AUDLEY v. ELLIS

28 Nov. 1702. Complaint by *Edward Audley*, of London, gent., clerk and steward on H.M.S. (of War) the *Bonetta*, Capt. *Thomas Smith*, commander, that *John Stretchley*, late of co. Lancaster, Rappahannock River in Virginia, complainant's late uncle, decd., was a considerable planter and dealer in Virginia tobacco, and employed *Thomas Ellis*, of London, merchant, as his agent and factor in England, and from time to time sent over his tobaccos to him. *John Stretchley* died 8 Dec. 1698, and made his will 6 Dec. 1698, making *Alice* his wife his extrix., bequeathing to complainant (in the name of his "cousin, *Edward Audley*"), £100. *Alice Stretchley* proved the said will 19 May 1699, in Lancaster County Court, Virginia, and directed said *Ellis* to pay complainant said legacy, which he has never done. *Alice Stretchley* died, having first made her will, appointing her son, *Rawleigh Chinn*, her exor., who on 8 Oct. 1701 proved her will. He desires that *Thomas Ellis* and *Rawleigh Chinn* may be summoned to answer the premises [C.P. before 1714, C.9, Reynardson 441/5].

AUDLEY v. ELLIS

22 Jan. 1702/3. Answer of *Thomas Ellis*, one of the defendants, to the bill of complaint of *Edward Audley*, gent. Believes it is true that *John Stretchley*, complainant's late uncle, of co. Lancaster, upon Napahanach River in Virginia, a considerable planter of tobacco in Virginia, and a trader of same, was in his lifetime dealer in same between Virginia and England, and this defendant was his agent and factor in England. He believes *John Stretchley* died about 8 Dec. 1698, and made his will dated 6 Dec. 1698, appointing his wife, *Alice Stretchley*, sole extrix., and bequeathing (among other bequests) £100 to complainant. *Alice Stretchley* proved the will 19 May 1699, in Lancaster County Court, Virginia, but never ordered this defendant to pay the said legacy. The said *Alice Stretchley* died in Virginia, as he has heard, and made her son, *Rawleigh Chinn*, of Lancaster County, her exor., who proved her will 8 Oct. 1701. He is ready to account for what remains in his hands [C.P. before 1714, C.9, Reynardson 301/18].

BONHAM v. AUDLEY, ETC.

Northampton, 11 Oct. 4 Anne (1705). Answer of *Edward Audley* and *Daniel Goode* to the bill of complaint of *Dorothy* and *Anne Bonham*, infants, by *Thomas Landall*, their next friend. They believe complainant's father died seized of a lease from *Thomas Browne*, but do not know the worth. They believe *Edward Paine* came to an agreement with *Richard Bonham's* surviving exors. They know nothing more *re* the lease and stock at Buckworth [C.P. before 1714, C.6, Collins 380/23].

HAWKINS *v.* AUDLEY

25 Apl. 1713. Complaint by *John Hawkins*, citizen and gunmaker of London, that *Abraham Houlditch* and *Robert Brooke*, of London, linendrapers, together with *John Goodwin*, of London, merchant, were bound by bond dated 14 Nov. 1710 to *Edward Audley* in £400 for payment of £200. Continues *re* said bond.

6 May 1713. Answer of *Edward Audley re* same (nothing *re Audley* family) [C.P. before 1714, C.9, Reynardson 379/5].

AUDLEY *v.* HERRING

6 July 1725. Complaint by *Edward Audley*, the younger, of Beccles, co. Suffolk, gent., and *Mary Audley*, of same, spinster, children of *Edward Audley*, of Beccles, gent., both under 21, by *Mary Audley*, widow, their mother, that *Sarah Bambrigg*, late of Kensington, co. M^xsex, widow, great-aunt to complainants, now decd., was seised of a great personal estate and leases amounting to £5,000, and on 18 Apl. 1724 made her will, bequeathing to *Edward Audley* £300, and to *Mary Audley* £300, to be paid to their father for their benefit. She appointed her nephew, *Samuel Herring*, of Lombard Street, London, woollendraper, her exor., and residuary legatee. She died shortly after, and said *Herring* proved her will in the Prerogative Court of Canterbury, but has never paid said legacies as he ought long since to have done.

20 Nov. 1725. Answer of *Samuel Herring*, saying that said *Sarah Bambrigg* made her will as alleged, bequeathing to her sister's son, *Mr. Edward Audley*, £500, and to his children, *Edward* and *Mary Audley*, £300 each. The said *Sarah* died in Jan. last, and defendant proved the will, but says he is not liable to pay the said legacies until a year after the death of *Sarah*, and that will not be till Jan. next [C.P. 1714-1758, C.11, 2011/3].

again, in London, Apl. 1684 ; became bankrupt before Jan. 1686/7, when his wife left him to live with his bror. John ; probably Edward Audley, of par. of St. Giles', Cripplegate, admon. of whose estate was granted 4 Sept. 1696, in P.C.C., to Ann the relict. Mard. about 1672, at St. Pancras, M'sex, to Anne, dau. of Edward Stretchley, of St. Mary le Bow, London, citizen and scrivener, clerk to the Company of Salters, and granddau. of Thomas Stretchley, of London, by Joan his first wife, sister of Edward Cropley, esq., Master of the Mercers' Company, and Sheriff and Alderman of London. She is said to have lived with him over 14 years, and had by him 9 or 10 children, but on 13 Jan. 1686/7 she was living with his brother John, to whom she pretended to be mard. Of Edward and Anne Audley's children we have record of four,

- A. George Audley, born in Liquorpond Street ; bapt. 12 Nov. 1678, at St. Andrew's, Holborn.
- B. Sarah Audley, born near the Hat and Feather, in High Holborn ; bapt. 3 Dec. 1680, at St. Andrew's, Holborn.
- C. Grace Audley, born in High Holborn ; bapt. 27 Dec. 1681, at St. Andrew's, Holborn.
- D. **EDWARD AUDLEY**, of whom presently.

EDWARD AUDLEY, son of Edward Audley preceding and Anne Stretchley his wife ; of London, gent. ; clerk and steward on H.M.S. of War *Bonetta* (Capt. Thomas Smith, commander), 28 Nov. 1702 ; latterly of Beccles, co. Suffolk, schoolmaster ; burd. 5 Sept. 1727, at Beccles. Will dated 17 Feb. 1725/6, proved 9 Sept. 1727, at Ipswich. Mard. Mary, dau. of....., who was burd. 8 May 1768, at Beccles, and by her had issue,

- I. **EDWARD AUDLEY**, of whom presently.
- II. Thomas Audley, bapt. 12 Dec. 1722, at Beccles ; burd. there, unmard., 20 Feb. 1742/3.
- I. Sarah Audley, bapt. 29 Oct. 1710, at Beccles ; died before 17 Feb. 1725/6.
- II. Mary Audley, bapt. 12 Feb. 1716/17, at Beccles ; living there 6 July 1725, and 17 Feb. 1725. 6.
- III. Sarah Audley, bapt. 28 Feb. 1719/20, at Beccles ; probably died before 17 Feb. 1725/6.
- IV. Anne Audley, bapt. 12 Dec. 1722, at Beccles ; living as youngest dau. on 17 Feb. 1725/6 ; perhaps apprenticed 1 May 1741 to Martha Harris, of Norwich, mantua maker.

EDWARD AUDLEY, elder son of Edward Audley preceding and Mary his wife ; bapt. 15 July 1712, at Beccles ; apprenticed 10 Jan. 1727/8, to Henry Ray, of Diss, co. Norfolk, grocer and chandler ; of Beccles, and burd. there 27 Oct. 1751. Mard. Elizabeth, dau. of....., and by her, who was living a widow 23 July 1752, had issue,

- B. Edward Audley, bapt. 23 Aug. 1742, at Beccles.
- C. Mary Audley, burd. 23 July 1752, at Beccles.
