### **CHANCERY PROCEEDINGS**

### WOOLNOUGH v. AUDLEY

14 Apl. 1714. Complaint by Francis Woolnough, of Wenhaston, co. Suffolk, gent., that he was seised of messuages and lands in the manor of Leiston, and on 27 Dec. 1711 made an agreement with Matthew Audley, of Leiston, co. Suffolk, clerk, to convey same to said Matthew for £114.15.0, to be paid by Matthew. The latter has got the said premises, but has not paid all the said money, and refuses to do so.

Answer of Matthew Audley re same —— no genealogical details [C.P. before 1714, C.7, Hamilton 383/47].

### WOOLNOUGH v. AUDLEY

Friday, 1 Feb. 1716/7. Depositions of witnesses taken at the dwelling house of Daniel Budd, called the Three Tuns, in Halesworth, co. Suffolk, in a suit between Francis Woolnough, complainant, against Mathew Audley, clerk, and another, defendants. Thomas Dawson, of Sibton, co. Suffolk, gent., aged 30, deposes he knows complainant and defendant very well, and has done so for five years last past, and has viewed the paper writing marked A., bearing date 27 Dec. 1711, purporting to be an agreement between complainant and defendant touching the latter's purchase of the messuages and lands therein mentioned, and he saw said Mathew Audley sign same, and he, deponent, was a witness thereunto. John Lay, of Middleton cum Fordley, co. Suffolk, yeoman, aged 60, deposes that he knows complainant and defendant. He does not depose as to how long he has known the copyhold estate in question, held of the manor of Leiston, co. Suffolk, which complainant agreed to convey to Audley.

He says that Audley was arrested by him at the suit of complainant, on 21 Mch. 1713/4, by virtue of a process which he believes issued out of the Court of Common Pleas at Westminster, upon an action of £120, and for avoiding going to gaol Audley requested deponent to be kept in his custody, and accordingly was kept until 18 Apr. following, at which time he was discharged by a writ of Supersedeas out of the said Court of Common Pleas

Robert Wytchingham, of Thwerton, co. Suffolk, aged 60, deposes he was accidentally present in company with the complainants and the defendants, Mathew Audley and Philip Thomas, on 6 Nov. 1712, at the King's Head in Saxmundham, and there were also present Mr. John Goodwyn and Mr. Benjamin Taylor, both of Leiston, at which time a note in writing laid loose upon the table, which deponent believes to have been an agreement between complainant and defendant Audley, and afterwards deponent delivered same to said Thomas, but does not know what it contained.

John Moore, of Yoxford, co. Suffolk, glover, aged 40, deposes that on 8 Nov. 1712, or thereabouts, at the house of Henry Eyres, in Yoxford, Audley paid the said defendant, Philip Thomas, Lio for the use of complainant, and a receipt was given by Thomas to Audley, to which deponent set his hand as witness.

John Goodwyn, of Leiston, co. Suffolk, gent., aged 40, deposes that about four years ago he was desired by Mr. John Dawson, solicitor to Audley, to go to the King's Head at Saxmundham, to help settle a compromise between complainant and Audley, where an agreement was made, and Philip Thomas drew a note for the payment of fio to complainant, which the latter refused and insisted on 108/- more, whereupon the 108/- was interlined, and that on Audley paying the said sum he was to be released of the bargain. He does not remember that the note was signed by anyone, but remembers complainant insisted on having his wood tithe free for 5 or 7 years.

Benjamin Taylor, of Leiston, co. Suffolk, gent., aged 40, deposes as John Goodwyn did, and further cannot depose. 22 June 1717. Another set of depositions taken in same suit. Robert Bence, of Sibton, co. Suffolk, aged 40, deposes that he believes Mathew Audley entered into possession of said premises the Michaelmas following the agreement, and that he has enjoyed them ever since; the premises have become very ruinous. Some time after the said agreement he was employed by Audley to acquaint Woolnough that, owing to the failure of a person in London, from whom Audley was to have money, he was rendered incapable to pay, and an agreement was made that if Audley paid £24 on 1 Nov. 1712, and £15 on 1 May 1713, and £15 on 1 Nov. 1713, then Woolnough would convey the premises to said Audley, on condition he paid the rest of the purchase money with interest.

Elizabeth Collins, of Walbeswick, co. Suffolk, widow, aged 68, deposes -- nothing re Audley [C.P. C.12, Bndle, 1462].

#### HOPE v. AUDLEY

18 May 1768. Answer of Lough Carleton, gent., one of the defendants to the bill of complaint of Margaret Hope, relict of John Hope, gent., decd., a lunatic, by John Hope, her only son and "committee" of the person and estate of said Margaret and of John Hope and Thomas Hope, grandchildren of said John Hope, decd., and children of John, son of Margaret and John, infants, that he believes it to be true that John Hope, decd., made his will as declared by complainant, and that he died 8 June 1764, and admits that after Hope's death the said defendant and the other defendants, Matthew Audley and Thomas Hill, the exors, named in Hope's will, proved the said will in the Prerogative Court of Canterbury, but he did not intermeddle with the administration of said estate, which he believes was left entirely to *Thomas Hill*. He believes *John Hope*, dccd., had two freehold houses in Prince's Street, Rotherhithe (continues re Hope: nothing further re Audley) [C.P. 1758-1800, C.12, Bndle. 1604].

The Duties and Offices of Friendship a Sermon preached at St. Pauls Deptford on the twenty third of June 1739 before a select number of gentlemen who stile themselves Ubiquarians Lond. 1739. 4<sup>to</sup> on 15 Sam. xx. v. 19 dedicated by the author to his Brethren of the Right worthy and amicable order.

From the Merchant Taylors' School Register, ed. Rev. Charles J. Robinson, 1883, vol. ii., p. 59, we learn that these two names occur together therein, as admitted in 1722:—

Matthew Audley.

Thomas Audley, b. 14 Apr. 1711.

A footnote on the former says:—"prob. son of Rev. Matt. A. Curate of St. Laurence Pountney, 1705, and afterwards IId.-M. of Christ's Hospital, who died 1725. One of the name was Rector of Rotherhithe and died 1790." It seems probable that Thomas would be a younger brother of Matthew.

Edward Arber's Term Catalogues, iii., 425, has this publication entered under Nov.

In 1926 I received the following note from Mr. William Lempriere, who has done so much to elucidate the records of Christ's Hospital:—

The following is the information I have about the Rev. Matthew Audley. He was son of Richard Audley, Citizen and Cutler, decd. before the boy entered the School: baptd. 13 Apr. 1679; admd. into C.H. from St. Peter the Poor on presentation of Sir John Chapman: discharged & preferred to Trin. Coll., Oxon., 8 Feb. 1696. B.A. 1700. M.A. (St. Alban Hall) 1703. He was Vicar of Leiston, Suffolk, 1707-19. Upper Grammar Master of C.H. 1719 till his death in 1725. Curate of St. Mary Abchurch & St. Lawrence Pountney, London, 1710. Curate & Lecturer of Rotherhithe, Surrey. (His son, Matthew Audley, who was educated under his father in the Grammar School, was entered at Trin. Coll. Oxon. in 1725).

As Upper Grammar Master Audley was not a success. He was "complained of" several times to the Governors, for severity to a boy, for "divers neglects and irregularities in his conduct and duty," etc. And as Dr. Pearce, Bishop of Worcester, says in his *Annals of Christ's Hospital* (1st ed., p. 87), "probably, from the point of view of the Governors, nothing in Audley's life became him like the leaving of it the same year [i.e. in 1725, when he had been complained of for another "great irregularity"], when death saved him from dismissal."

In answer to a further enquiry from me, Mr. Lempriere wrote as follows:-

I have delayed replying to your letter until a further examination of the Christ's Hospital Minute Books enabled me to judge whether Matthew Audley, Jun., could have been at Merchant Taylors' School in 1722. On reading the Minutes I find that this was quite feasible. He was not on the Foundation of C.H., but a private pupil and that apparently only of his father, for the words "who was educated under his father in the Grammar School of Christ's Hospital" are from a letter written by his mother Mary Audley early in Feb. 1725-6. On the father's application a small Exhibition of £3.6.8 a year had been granted in 1725, tenable at Trin. Coll. Oxon. This was not restricted to Blues. After the father's death two others, also not restricted to Blues, were granted in consideration of the mother's circumstances.

As Upper Grammar Master — there was no Head Master in those days — the father was preparing boys for the University, so probably preferred teaching his son to leaving him at Merchant Taylors' or any other School. Each Master was allowed until quite modern times to take a certain number of private pupils in his class. Unfortunately no record was ever kept of their names.

My note that the father was Curate, &c., at Rotherhithe was taken from Foster. In the circumstances you mention, I have transferred it to the son.

The Rector of Rotherhithe kindly informed me that the name of M. Audley, Curate, first occurs i June 1733, and his writing continues to 1764. He occurs in the Baptisms and Burnals till June 1784, and in the Marriages till 28 March 1784. He was also Afternoon Lecturer, and his handwriting is stated to be beautiful.
