AUDLEY OF ST. DUNSTAN'S-IN-THE-EAST,
AND OF STEPNEY

There is no evidence to suggest the origin of Thomas Audley, of St. Dunstan's-in-the-East, who heads this pedigree. But he and his family were evidently people of some substance. As there were a number of other Audleys contemporary with him in the parish, as the registers testify, he was probably not the first to settle there. The fact of his son John being of Stepney, not far away, may lend some significance to the following Chancery suit, of *AUDELEY v. BARBOR* :—

27 Jan. 1562/3. Bill of complaint of *Thomas Audeley*, of (illegible), co. Essex, esq., that being seised of a capital messuage called Oldeford, in Stepney, co. M'sex, the evidences, etc., have come into the hands of *Thomas Barbor, esq.*, and others, to the great damage of the complainant. He desires that the said *Barbor* may be summoned to answer the premises [C.P. Series 2, C.3, 1/2].

This Thomas Audley, esq., would probably be either Thomas Audley, of Berechurch, Essex, who died in 1572, nephew of Lord Chancellor Audley, or his younger brother of the same name, who was of Gosbecks, Essex, and died in 1584 (see *ante*, AUDLEY OF BERECHURCH, CO. ESSEX, pp. 133-4). But Thomas Audley, of St. Dunstan's-in-the-East, does not seem to fit into the Berechurch pedigree, and I do not attach much importance to the clue.

The connexion of Thomas's son John with Stepney, and the continuance in use there of the name Edward, make it seem very probable that the second part of my pedigree might be linked up with the earlier part, if more information were available. Perhaps a complete search through the registers of St. Dunstan's, Stepney, would throw more light upon the family during the first half of the 17th century, when the break in continuity occurs, and supply the missing links, if such really exist. But what this search would involve may be estimated from the fact that it took a skilled and rapid searcher two days to cover the period 1630-1650 in the baptisms and burials. There, as at St. Dunstan's-in-the-East, we are confronted with a large proportion of entries relating to Audleys who cannot be connected with the pedigree, yet who were probably many of them akin.

To *John*, son of my bror.-in-law, *John Grene*, of London, scrivener, and of *Suzan* his wife, £50. To *Elizabeth*, wife of my bror., *Thomas Awdley*, £20, and to his servant, *Rachel Allen*, £5. To *Elizabeth Heywood*, servant to *Sir Edward Osborne*, knt., 40s/-. Resid. legatees and exors., my brors., *John* and *Thomas Awdley*. Overseer, my friend, *Anthony Bate*, of London, merchant. CHRISTOPHER AWDLEY, of St. Dunstan's in the East, city of London, decd. Admon. granted 7 Aug. 1593 to *Suzan Greene*, sister of decd. (P.C.C. Admon. Act Book, f. 64).

THOMAS AWDLEY, citizen and mercer of London. Will dated 8 Feb. 1599/1600. To be burd. in the parish church of St. Dunstan in the East, where I am now a parishioner. To my bror.-in-law, *John Greene*, of London, scrivener, 40s/-, and to his wife *Susan*, £10. To my sister *Alice*, wife of *Richard Hoo*, esq., a ring. To my friend, *Thomas Fitch*, of London, scrivener, £6, and to his wife 40s/-. To Christ's Hospital, London, £4. To *William Borne*, 20s/- and to his wife, 40s/-. To my wife *Elizabeth*, the occupation of my dwelling house in Thames Street, and if she marry again the same to be sold and she to have one moiety, the other to be divided between my son *William* and my bror., *John Awdeley*, merchant. JOHN AWDLEY, of Stepney, co. M'sex, gent. Will dated 27 Aug. 1613. A third part of my goods, in three divided, to my sister, *Mrs. Alice Hoo*, wife of *Richard Hoo*, esq., and another third to my friend *Henry Campion*, esq., in whose house I now remain. The other third to my bror.-in-law, *John Greene*, citizen and salter (sic), of London, and my sister *Suzan*, his wife. Exor., said *John Greene*. Signed, *John Audeley*. Wits., *Phillippe Stone* and *Richard Chaundler*. Proved 4 Apl. 1615, in P.C.C. (Rudd 118), by the exor.

EDWARD AUDLEY, of Limehouse, Stepney, co. M'sex, cooper. Will dated 19 Feb. 1650/1. To my son *Thomas*, my two boarded houses in Limehouse, in Nightingale Lane, and 20s/-. To my dau. *Elizabeth*, wife of *Thomas Grigg*, my two store houses and kitchen. MISCELLANEOUS EVIDENCE

The following Chancery suit, "LOCKYER *v.* AUDLEY," refers to Edward Audley, of Nightingale Lane, who died soon after:—

29 Jan. 1650/1. Complaint by *John Lockyer*, of Limehouse, co. M'sex, mariner, that in Aug. and Sept. 1649, having accepted of conditions to take a voyage as master in the ship *The Virginia Merchant*, to the port of James River, Virginia, in America, to transport servants and others for the plantations there, and having to supply food and drink for so many people during so long a voyage, for beer, cider, etc., he went to *Edward Audley*, a cooper, to buy casks for the same, and ordered "forty odd tun," or thereabouts, at 21^s/- a tun. The same were delivered, and filled with 22 tuns of beer, 4 of cider and vinegar, and 16 of water, 200 persons being on board, and they set sail in Aug., together with 4 or 5 other ships. After ten days at sea, he found all or $\frac{3}{4}$ of the casks were leaking, to the hazard of the persons aboard, had he not, to his great cost and risk, left the company of the other ships and put in at Foyall to buy fresh casks, at a very dear rate, and to patch up the others, to his damage of £1000 or more. He desires the said *Audley* may be summoned to answer the premises.

7 Feb. 1650/1. Answer of *Edward Audley*, that he delivered such casks as were ordered, and the same were in good condition when delivered, and may have been damaged by complainant's ill-usage after delivery — continues to justify himself as to the good condition of the casks [C.P. before 1714, C.5, Bridges 10/36].

The Protestant Oath Roll, for Middlesex, 1641/2, contains the names of Edward Audley, Limehouse, and Thomas Audley, Limehouse.

From the "HOO" pedigree in Blomefield's *Norfolk* (X., 40), it appears that Thomas Hoo, esq., of Scarning, *temp. Eliz.*, married Margaret, daughter of Clement Pagrave, of Northwood Berningham, co. Norfolk (she remarried John Ferrou, of Gressenhall), and had a son, Richard Hoo, of Scarning, esq., who died 6 Charles I. (1630-31), and who married Alice, daughter of Thomas Audley, gent., of London, and had issue.

On 31 July 1571 a licence was issued by the Bishop of London for the marriage of Thomas Awdeley and Elizabeth Herde, of City of London, widow (*Harleian Soc.*, XXV., 49). This Thomas might be the earliest figure in my pedigree, or his son Thomas, both of whom had wives named Elizabeth.

Mr. C. H. Harrison, of Algars Manor, Iron Acton, co. Glouc., has most kindly supplied me with information from the Court Rolls of the manor of Stepney, which begin in 1654, the earlier volumes having been destroyed in the Fire of London. On 24 April 1655 Thomas Audley and Anne his wife were admitted on the surrender of William Whyunny and Rachael his wife (sister to the said Thomas). The following are abstracts of later entries:—

17 June 1665. Also at this Court presented on oath that *Thomas Audley*, late of Little Hadham, co. Herts., sailor, late one of the customary tenants of the said manor, who held to him and his heirs all those several customary messuages situated in Nightingale Lane, in Lymehouse, within said manor, surrendered at the Court Baron held 1 Jan. 1655/6 to the use of his last will the said premises, and afterwards, on 26 Oct. 1664, made his said will bequeathing to *Anne*, his wife, for life, his corner brick messuage, with two several tenements in Nightingale Lane, with remainder, after her death, to his son, *Edward Audley*; should the latter die before 21, then to the said *Anne* and her heirs for ever. Afterwards *Thomas* died, and now *Anne Audley* appears in Court and is admitted tenant, and *Edward* appears by his mother and guardian, and is admitted tenant in reversion.

At the same Court the homage presented as above, concerning another brick messuage in Nightingale Lane, in tenure of *Mrs. Edge*, and which he bequeathed to said *Anne* for life, with remainder to his dau., *Hannah Audley*, and her heirs; the same admitted (as above).
