Canon Noble sends me an extract from the Rev. A. J. Edmonds's *History of Great Gransden in the County of Huntingdon*, in which is given the following translation of a Latin inscription on a tombstone in the churchyard of All Saints, Huntingdon:—

Beneath sleepeth in certain hope of rising again at the Last Day, Edward Audley, second son of Edward Audley, late Alderman of this Town, sprung from the noble family of the Audleys of Great Gransden in Huntingdonshire. Who received life on the Twenty-second day of the month of December, 1682, and unwedded departed from this light on the fourth day of the month of February

In the Year { of (our) Salvation, 1758
 { of (his) Age, 75 and 14 days.

Roxton, where lived Edward Audley, great grandfather of the above Edward, is only some eight miles west of Great Gransden, but I have no evidence of his connexion with the family settled at the latter place [see *ante*, p. 29, AUDLEY OF GREAT GRANSDEN AND HOUGHTON CONQUEST]. It is clear, however, that his family was not native to Roxton, for, apart from his own children, there are no Audleys mentioned in the register there except for one William Audley, who was churchwarden in 1618/19.

Sandy, where Edward Audley married his wife, Mary Bromsall, on 23 July 1610, is the adjoining parish to Roxton. The Rector, while admitting his lack of expertness in reading the early registers, has searched from their commencement in 1538 down to 1660 without finding another entry relating to the name, except the marriage on 3 Feb. 1554 of a Joan Audoli to a man whose name he cannot read. He tells me that the Bromsalls were gentry throughout the earlier years of the registers, with frequent entries under their name. He certainly missed the baptism of William Audley in 1611.

There seems little doubt that the descendants of Edward Audley of Roxton became extinct in the male line on the death of his great-grandson abovementioned in 1758.

WILLS AND ADMINISTRATIONS

THOMAS AUDLEY, of par. of All Saints, Huntingdon, yeoman. Dated 26 Feb. 1638. Sick in body, but of good and perfect mind. To be burd. at discretion of exor. All my lands, arable and pasture, in par. of "Rockstone," co. Bedf., containing 17 acres more or less which descended to me by last will and testament of my father *Edward Audley*, decd., to bro. *John Audley*, gent., of Huntingdon, his heirs and assigns for ever. To eldest sister, *Mary Audley*, £10 at her age of 21 or marriage. To second sister, *Elizabeth Audley*, £10 as afsd. To youngest sister *Annes Audley*, £10 as afsd. To sd. bro. *John*, all my house, barns, stables, orchards, gardens and appurtenances in par. of "Rockstone" (the tenure thereof being *in capite*) and to his heirs and assigns for ever on condition that if he shall quietly and peaceably enjoy sd. house, etc. (which I doubt not anything to the contrary) he shall pay to each of my sisters £10 each over and above legacies. Rest of goods, after payment of debts and funeral expenses, to sd. bro. *John*, and make him exor. Signed, *Thomas Audley*. Wits., *Jo. Phage*, not. pub., *Thomas Ashton*. Proved 3 Nov. 1641 in Archdcy. of Hunts. [at Peterborough], before *John Tomlinson*, surrogate of *John Farmer*, LL.D.

JOHN AUDLEY, late of Huntingdon, co Hunts., decd. Admon. granted 31 Jany. 1654, in P.C.C. [Admon. Act Book, f. 19], to *Elizabeth Ashton*, grandmother and guardian of *John*, *Edward*, *Elizabeth* and *Mary Audley*, minors, children of sd. decd.

MARY AUDLEY, of Huntingdon. Dated 7 Nov. 1690. Infirm of body but of good and disposing mind and memory. To be burd. at discretion of extrix. To loving son *John Audley*, of London, clerk, £40 which he oweth me, with all interest due. To *Elizabeth* his wife, a guinea for a ring. To loving son *Edward Audley*, of Huntingdon, draper, £10 which he oweth me, with all interest due. To *Hannah* his wife, a guinea for a ring. To grand dau. *Elizabeth Audley*, dau. of son *John*, a guinea for a ring. To grandsons, *John Audley*, *Edward Audley*, and *James Audley*, sons of sd. son *Edward Audley*, a guinea each for a ring. Rest of goods, after debts, etc., paid, to loving dau. *Mary Audley*, of Huntingdon, spinster, whom I make extrix. Wits., *Henry Laurence*, *Elizabeth Kid* her mark, *Tho. Andrews*. Proved 16 Mch. 1691 in Archdcy. of Hunts. [at Peterborough], before *John Sturges*, clerk, surrogate of Ven. *George Barnardiston*, M.A.

ELIZABETH AUDLEY, alias **FRAMPTON**, late of St. Catherine's Creechurch, London, decd. Admon. granted 9 July 1700, in P.C.C. [Admon. Act Book], to *John Audley*, clerk, husband of decd.

JOHN AUDLEY, clerk, late of St. Catherine's Creechurch, London, widower, decd. Admon. granted 2 Jany. 1705 in P.C.C. [Admon. Act Book, f. 15] to *Thomas Martyn*, guardian of *Elizabeth Audley*, dau of decd., for her minority. Further admon. granted in P.C.C. [do. do. f. 239] 14 Dec. 1714, to *Elizabeth Aylief* alias *Audley*, wife of *Abraham Aylief*, dau. of *John Audley*, clerk, decd., she being now of age.

MARY AUDLEY, of Huntingdon. Dated 16 Apl. 1707. Uncertainty of this life; perfect memory and understanding. To be burd. in chancel of par. church of All Saints', Huntingdon. To niece *Elizabeth Audley*, of London, one guinea for a ring. 50s/- to be disposed of to poor. Loving brother *Edward Audley* to be sole exor. and have residue. Signed, *Mary Audley*. Wits., *John Sherard*, *John Abell*, *Mary Browning*. Proved 30 Sept. 1709, in Archdcy. of Hunts., before *Hugh Mapletoft*, clerk, surrogate of Ven. *George Newell*, LL.B., Vicar-General, by *Edward Audley*, bro. and exor. of decd. [will at Peterborough].

EDWARD AUDLEY, the elder, of Huntingdon, gent. Dated 18 Aug. 1721. To beloved wife *Hannah Audley*, £40 per ann. for life, to be paid by eldest son *John Audley*, Doctor of Laws, out of estate devised by me to him, and all household goods in house wherein I dwell in Huntingdon. To sd. eldest son, mess. with gardens, orchards, etc., commonly called the Friery, Huntingdon, except house now or late in occ. of *Mr. Houghton*, and house and garden now or late in occ. of *Mr. Robinson*, to him and his heirs for ever, on condition that he pay his mother £40 per ann. To second son *Edward Audley*, all my closes of pasture in St. John's par., Huntingdon, formerly called Haynes Closes, now or late in tenure of *Robert Woodward* and *John Hardley*, for ever; also £300 in money. To youngest son *James Audley* £300, to be paid six months after my decease out of land and estate at Ellington and two leases from Trinity Coll. and St. Peter's Coll., Camb., by sd. son *John Audley*. To sd. youngest son *James*, the house now or late in occ. of *Mr. Houghton* and garden now or late in occ. of *Mr. Robinson*, free from all incumbrances. These legacies are made in full satisfaction of marriage agreement and all shares given by late father-in-law, *Mr. Moses Holloway*, to sd. wife and children. To poor of Huntingdon £5, to be distributed at discretion of exors., sd. sons, *John*, *Edward* and *James Audley*, who are to have residue. Wits., *Charles Heron*, *Elizabeth Stevens*, *Martha Collier*. Proved 28 Mch. 1722, by exors., in Archdcy. of Hunts. [at Peterborough].

JOHN AUDLEY, Dr. of Laws, Chancellor of York. Dated Doctors' Commons, 28 June, 1746. To friend *Sir Clement Cottrill Dornor*, £10-10-0. To friend *Edward Greenly*, esq., and his wife, £10-10-0 each, and to their dau. *Mrs. Mary Greenly*, my prints of heads published by *Knapton*, and the few prospects of places I have, published by *Buck*, and £5-5-0. To sd. friend *Greenly*, my chariot. To friend *Matthew Robinson*, esq., late of

Mount Morris in Kent, my gold watch with chain lately bought of *Mr. Duhamel*, but seal with my coat of arms to bro. *Edward*. To servant, *William Oastler*, £52-10-0. To servant *Mary Dobb*, a year's wages. Books to be sold as a whole if possible—perhaps my *Lord Sandwich* would purchase them. Notes, books and MSS. in the way of my profession I give to friend *Dr. Simpson*, to burn or not at his discretion. I forgive bro. *James* what he owes me. Resid. legatees and exors., brothers *Edward* and *James*. Signed, *Joh: Audley*. No wits. *Joseph Hinson*, of St. Bride's, London, gent., and *Lewis Morgan*, of St. Nicholas, Cole Abbey, London, gent., appeared personally 28 Apl. 1747, and swore to handwriting of decd. Proved 14 Apl. 1747 by *Edward* and *James Audley*, the exors., in P.C.C. [Potter 87].

JAMES AUDLEY, of Buckworth. Dated 15 May 1749; apparently addressed to his bro. *Edward*. "Dear Brother, as my £500 part of the gift of my good brother *Doctor*, will if I die without settling my affairs fall into your power, I hope you will by no means make it your own. I will that 10 guineas be given to *Mr. John Newton*, of Hamerton, 2 months after my decease. 2 guineas to *Alice Church* 2 months after my decease. £50 to each of the 3 children of the late *Arthur Case*, of Buckworth, as they come to the age of 21 years. The interest of this £150 to yourself, till time of payment. The interest of the other 300 and odd pounds to yourself for life. After your decease to the said three children or the survivor of them for their lives. After the decease of the said three children the interest of the said 300 and odd pounds (the principal never to be transferred) to be paid for ever to the poor inhabitants of Huntingdon such as have no pension from the parish; and if either of the said three children should die before coming to the age of 21 the money unpaid shall lye with the 300 and odd pounds to be disposed of along with it, your loving brother, if you would perform my will I would be buried at Buckworth and leave directions with *Arthur Case*, take nothing from hence but part of my Books and my Papers to burn." No admon., but next will after (in Archdy. of Hunts., at Peterborough) was proved 30 Jany. 1750.

EDWARD AUDLEY, of Huntingdon, gent. Dated 12 Sept. 1757. Best seal ring and £5-5-0 to eldest son of cousin *Mrs. Elizabeth Stocker*, of Reading, Berks. To each grandchild of honoured uncle *John Audley*, late of London and Minister of Creed Church there, £5-5-0. To late faithful servant *Thos. Lawrence*, of Huntingdon, draper, £5-5-0; if dead to his dau. *Elizabeth Lawrence*. To friend *Rev. John Cross*, Minister of Stow, £5-5-0, and another £5-5-0 for mourning. To *Rev. Mr. John Pennington*, Rector of united pars. of All Saints and St John's, Huntingdon, 12 several vols., he to choose them out of my library; and to *Mr. Edward Ferrar*, of Huntingdon, 24 vols., viz. 12 in law and 12 in any other science, out of my library, at his choice, and £10-10-0 and my silver cup, and all my china plates and china ware to his dau. and my god-dau. *Emilia Ferrar*; and to *Dr. George Raitt*, of Huntingdon, 12 vols. as he shall choose, rest of silver household goods except my embossed silver cup, which I give to the Mayor of Huntingdon for time being, in memory of dear brother *James Audley*, decd.; all to be delivered within 12 months of decease. To careful servant, *Alice Church*, two years wages more than will be due at my decease, and an annuity of £10, free of all taxes and charges, to be paid quarterly; also my little tenement at back of the Great Maltin, now in occ. of *Saml. Woolstone*, for life, she to let it to *Samuel Woolston* and *Elizabeth* his wife for their lives, if *Alice Church* so long live, at 15/- per ann., they to have it after her death. All my estate land, tenements, etc., in Ellington, to *Hannah Case* of Buckworth, Hunts., widow, her heirs and assigns, she paying £90 thereout to her son *Arthur Case*, and £90 each to her daus. *Hannah* and *Elizabeth Case*, to be paid within twelve months after decease. Also to sd. *Arthur, Hannah* and *Elizabeth Case*, in addition, £20 each within a year after decease or 20s/- a year till they are paid, each of them to give my exor. a general discharge of all gifts given under a memorandum under the hand of my brother *James Audley*, otherwise gifts void. To sd. friends *John Pennington, Edward Ferrar* and *George Raitt*, Dr. of Physick, all those messes. and cottages in par. of St. John, now or late in tenure of *Henry Blain* or his father-in-law, *Tho. Hayward*, of the Victualling Office in London, *Mr. Wm. Peacock, Saml. Woolstone*, and sd. *Edward Audley*, the testator, with all buildings, stables, fish and other ponds, fences, etc., which sd. premises are contiguous to each other and bounded on South and North by a common drain, and on West by the common street or highway into the North and are commonly called the Friery and were formerly part of a Convent of Augustin Friars, and also that close of pasture in par. of St. John's, near a bridge called Nunson Baulmshold Bridge, known as St. Andrew's Close, containing 2 acres more or less, in occ. of *Edward Ross* as under-tenant to *Thos. Hayward*, and those 3 closes of pasture in par. of St. John, commonly called Haynes or Harveys closes, containing 9 acres more or less of Kings Highway lying to the East, and the grounds of the Burgesses of Huntingdon North and West and South, now or late in occ. of *John Perkins*, gent., *Thos. Patason*, and *John Mathews*, and all those six houses or tenements contiguous to each other in par. of St. John's, with yards, etc., all purchased of *Widow Stanford*, the house now in occ. of *Arthur Ashton*, called the Royal Oak, standing on part of the North side thereof, and a mess. of *Dr. Banson's*, and some outhouses and grounds belonging to the bakehouse late *Blain's* in the South part thereof, and a lane called Stone Lane, and a close of pasture belonging to Hospital of St. John's on the remaining part thereof on the North East thereof, and now or late in tenure or occ. of *Wm. Bugby, Tho. Turner, James Warrington, Winpenny widow, Edwd. Caldicott* and *John Standford*, or their assigns, and one other small tenement with appurts. in par. of St. Benedict, in a common lane there called Butcher Roe Lane and now or late in occ. of

Joseph Sitdown, and that piece of garden ground and the remainder of a house in Priory Lane, some time burnt down, containing in length 86 feet, in breadth 96 feet, a tenement now or late in occ. of *Fulk Blincoe*, on the West, with appurts. and well belonging, and all rights, claims, etc., of me the sd. *Edward Audley* to same, for their use and behoof for ever. To them also my contingency of a Fenn estate in Glasmore Fenn, nr. Whittlesea, called the Boarded House, formerly let to one *Jackson*, being one-third of the estate left to me and my heirs by *Mrs. Ann Maxey*, late of Hemmingford Abbots, in case her kinsman *Mr. Robert Currier*, of the same place, died without lawful male heirs; also all my two closes of pasture in par. of Great Stoughton, copyhold of *John Wildbore*, a tenement in occ. of sd. *John Wildbore* on the West and a common lane on the South. All rest of lands and tenements, goods, etc., not bequeathed I devise to sd. *John Pennington*, *Edward Ferrar* and *George Raitt*, their heirs and assigns for ever, and nominate them exors. Wits., *Tim Perkins*, *Dan. Hopkins*, *Favell Hopkins*. Proved 14 Oct. 1759, in Archdcy. of Hunts. [at Peterborough], before *Rev. Charles Jenner*, D.D., Archden. of Huntingdon, by oath of *Edward Ferrar* and *George Raitt*, power reserved to *Rev. John Pennington*.

CHANCERY PROCEEDINGS

EDWARDES v. AUDLEY

19 Apl. 1692. Complaint by *Charles Edwardes*, late of St. Giles-in-the-Fields, co. M'sex, labourer, that in 1667 *Edward Eiklestone*, of London, surgeon, made his will, and in 1670 made his last will bequeathing to complainant £12 a year to apprentice him and maintain him during his apprenticeship, and a further sum of £200, and appointing *Isaac Lambert*, of London, gent., and *William Utworth*, exors. He was not apprenticed, and being a minor could do nothing, and he now claims sd. money of *John Audley*, of Creechurch, London, clerk, and *John Topham*, of London, throwster, as exors. of will of *William Utworth*.

Answer, dated 13 May 1692, of *John Audley*, clerk, *John Topham* and *Mary Uthwat alias Utworth re sd. will* [no *Audley* particulars] (C.P. before 1714, C.8, Mitford 539/40).

LANDELL v. AUDLEY

18 Dec. 1724. Complaint by *Thomas Landell*, of Bugden, co. Hunts., yeoman, and *John Landell*, of same, yeoman, sons and exors. of will of *Thomas Landell*, late of Bugden, yeoman, decd., that latter became bound to *Edward Audley*, then of Huntingdon, gent., decd., in a bond of 3 Nov. 1686, in £200, on marr. of sd. bounden *Thomas Landell* with *Anne Bonham*, widow of *John Bonham*, of Buckworth, co. Hunts., yeoman, decd., that sd. *Anne* should dispose freely of £100 by her will. Soon after, marr. was solemnised, and *Anne Landell* made her will 9 May 1688, making various bequests (no *Audley* mentioned), with sanction of her husband, who died Nov. 1687, and his will was proved in Archdcy. Court of Huntingdon. After, *Edward Audley* died, making his three sons, *John*, *Edward* and *James Audley* his exors., and a year ago *Anne Landell* died. Sd. *John*, *Edward* and *James Audley*, though requested, refused to give up sd. bond, to damage of complainants.

11 Mch. 1725. Another complaint, bringing in *Williams Manning* and *Margaret* his wife, a legatee in *Anne Landell's* will (no further *Audley* details).

Answer, dated 16 Apl. 1725, of *John*, *Edward* and *James Audley*, that their father made his will [date left blank] and died 9 Dec. 1721, and they proved same, and among his papers found sd. bond, and are quite willing to settle *re* same.

Answer, dated 13 June 1726, of *Williams Manning* and *Margaret re sd. will* (C.P. 1714-1758, C.11, 670/16).

EXTRACTS FROM PARISH REGISTERS

B.A., who was ordained deacon 14 Nov. 1661 at Lincoln. Perp. Curate of St. Katherine Cree, 1672-92; a non-juror. Also that John Audley, born in Huntingdon, was admitted pensioner at Peterhouse 23 May 1696, aged 16, after being a colleger at Eton. Scholar 1696; matric. 1697; B.A. 1699-1700; M.A. 1703; LL.D. 1710. Fellow 1703. Taxor, 1707. Incorp. at Oxford, 1712. Adm. advocate, 1710. Vicar-General of the Province of York and Chancellor of the Diocese. Advocate-General of the Court of Chivalry, 1739. Foster's *Alumni Oxonienses* gives the date of his incorporation as 14 July 1712.

John Audley, of St. Catherine Cree Church, London, clerk, bach., 40, and Elizabeth Frampton, of "Cashorton" [*sc.* Carshalton], co. Surrey, 21, dau. of [blank] Frampton, of same, who consents, licensed 13 Dec. 1687, from Faculty Office of Archbp. of Cant., to marry at "Cashorton," Walton or Mitcham, co. Surrey (*Harleian Soc.*, XXIV., 188).

"John Audley, L.L.D. Vicar General of the Province of York, and Chancellor of that Diocese, appointed Deputy to *Tho. Stanley*, L.L.B. Official to the Archdeacon of London, in room of *Dr. Cotterell* decd: a Place of great Trust, and considerable Profit" (*Gent.'s Mag.*, 1738, May). "Doc. Audley" was burd. at Bath Abbey Church on 7 Apl. 1747 (*Harleian Soc.*, "Register Section," XXVIII., 436): I assume from the date that this was the Vicar-General, as I know of no other Dr. Audley to fit the entry.

Edward Montagu [1692-1775], of Allerthorpe, Yorks., wrote to his wife, the celebrated Mrs. Montagu (to whose brother Matthew Robinson [1713-1800], afterwards 2nd Baron Rokeby, Dr. Audley left his gold watch in 1746), in 1742: "Your Father went out of Town last Friday. The evening before I spent with him, Dr. Audley and your three brothers, who were all well" (*Elizabeth Montagu, the Queen of the Bluestockings*, by Emily J. Climensson, 1906, I., 129). And writing to her again, on 28 Sept. 1749, when she was staying with Lady Sandwich at Hinchinbrook, just outside Huntingdon, he remarked:—"The room where Oliver Cromwell was born I dare say Mr. Audley will be proud to show you" (*ibid.* I., 270). I presume this would be Dr. Audley's brother Edward.

The Rev. W. M. Noble tells me that Anne Fulwood, of Kimbolton, in her will of 13 Oct. 1668 (*Arch. Hunts.*, Register 24, fo. 261), mentions her cousin Elizabeth Audley of Huntingdon.

F. A. Blaydes's *Genealogia Bedfordiensis*, 1538-1700, gives these two extracts from the register of Sandy, Bedf.

1610. July 23. mard. Edward Audley and Mary Bromsall.

1611. Mch 31. bapt. William, son of Edward Audley.

In a list of Non-Jurors entered in a 1662 Prayer Book appears the name of Mr. Audley (John) as burd. at Cree Church (vicar there), died on 17 Dec. 1704 (*Notes and Queries*, 19 Jan. 1929, p. 40).
