This is rather a ragged and unfinished pedigree, and we would willingly exchange some of the numerous Chancery suits concerning the affairs of Joseph Audley [1628 ?-78], sword cutler to Charles II., for more definite evidence in regard to other less exalted members of the family.

It seems very probable that Thomas Audley of Buckingham, whose son Richard was father of the said Joseph, was identical with Thomas, son of John Audley of North Marston, which is only some nine miles to the south-east, and a little further away than Grandborough, where John's son Christopher lived. This Christopher, in his will of 1578, mentions his nephew Paul Audley, and as Thomas Audley of Buckingham had a son Paul, born in 1562, there seems every likelihood that the bearers of this uncommon Christian name were one and the same person. Perhaps William Audley, baptized at Buckingham in 1564, was another son of Thomas, and so the nephew William Audley mentioned in Christopher's will.

Another link between the Audleys of North Marston and Buckingham is that both used the name Henry.

Of John Audley, citizen and stationer of London, mentioned in the Chancery suit of 30 Nov. 1669 (then dead) as party to a bond with the brothers Paul and Joseph Audley, on 6 Jany. 1662/3, I have no other record, but conclude he was yet another brother. I have not, however, had the hardihood to include him in the pedigree.

The family petered out at Buckingham before the middle of the eighteenth century, and apparently at Fulham too, but there are numerous members whose careers are unaccounted for and who may have left descendants.

To bror.-in-law, *Richard Stevens*, my great bottle. To *Peter Fidge*, two sheep. To god-dau., *Margaret Happen*, a sheep. To godson, *William Corbye*, a sheep. To wife and her dau. *Mary Gouldby*, my messuage in Scalding Alley, near the Poultry, London, and after their deaths to my dau. *Anne Wilford*, wife of *Thomas Wilford*, and her issue, failing which to son *Paul Audeley*. To town of Buckingham, £100 for the poor there as a stock for them. To *William*, son of my brother *Henry Audeley*, 40s/- a year for life. To *Joseph*, son of said *Henry*, £100 at 21. To *Edward* and *Robert* and their brother, sons of *Robert Newton*, of New Market, Clements Inn, M'sex, £50 each at 21, and to *Mary*, wife of said *Robert*, £10 a year for life. To *Sarah*, wife of *Mr. Starre*, arms-painter, £25. To *Richard*, son of brother *Henry Audeley*, £50 at 21. To brother *Francis Audeley*, £25. To *Thomas*, son of my brother *Thomas Audeley*, £100. To *Samuel How*, of St. Brides, London, gent., and *Henry Lobb*, of St. James, Westminster, joiner, my title in two messuages at lower end of St. Bartholomews Lane, near Lothbury, London, and in those ground rents my late husband, *Joseph Audley*, held by lease of Jesus Coll., Camb., and a messuage in Scalding Alley, Poultry, London, in trust to pay my dau. *Mary Overs* the rents and profits thereof, she providing for my dau. *Rebecca Fletcher's* three children, that is *Robert*, *John* and *Millicent Fletcher*, which she had by *Robert Fletcher*; after dau. *Mary's* death said rents to be paid to her children, *Mary*, *Millicent* and *Francis Overs*. Resid. legatee and extrix., said dau. *Mary Overs*. Signed, mark. Wits., *Mary Warrin*, *Henry Green* and *George Pritchard*. Proved 5 Dec. 1696 by the extrix. [P.C.C., Bond 243].

PAUL AUDLEY, the younger, of Hammersmith, par. of Fulham, co. M'sex, gent. Will dated 10 July 1697. Whereas my house and garden at Hammersmith, and another house in Rose Street, Covent Garden, are mortgaged to *Mr. Francis Maulster*, the same are to be sold and to that end I bequeath to my wife *Elizabeth*, to *William Howard*, citizen and weaver of London, and to *Nathaniel Pigott*, of the Inner Temple, London, esq., all my messuages and garden in Brook Green, Hammersmith, and my messuage in Rose Street and ground rents in London, and all other my lands, etc., to sell same, to sole use of said wife, after debts are paid. Exors., said trustees. Signed, *Paul Audley*. Wits., *Rich. Pigott*, *Tho. Warren*, and *Will. Platt*. Proved 5 June 1706 by *Elizabeth Alton*, als *Audley*, wife of *William Alton*, relict and extrix. of decd., power reserved to the other exors. when they shall apply for same [P.C.C., Eedes 118].

RICHARD AUDLEY [no place given]. Will dated 27 Oct. 1714. To son *Paul Audley*, £5. To son *Richard Audley*, £5. To son *Thomas Audley*, £5. To son *John Audley*, £10. To son *Henry Audley*, £10. To son *Joseph Audley*, £10 and lease of my long close. To grand dau. *Susanna*, dau. of my son *Richard Audley*, £10 at 21. To grand dau. *Elizabeth Audley*, dau. of my son *Thomas*, £5 at 21. To son *William Audley*, my house and close after wife's death. Resid. legatee, wife. Exor., son *William*. Signed, *Richard Audley*. Wits., *Danby Pickering*, *William Harris* and *Thomas Woollams*. Proved 5 Mch. 1715/16 by the exor. [Commissary Court of London, Reg. 58, f. 61d., at Somerset House].

WILLIAM AUDLEY, of St. Andrews, Holborn, co. M'sex, victualler. Will dated 28 Mch. 1727. To nephew *Henry Audley*, £10 to put him out apprentice. To niece *Susanna Audley*, £10 at 21. To niece *Elizabeth Audley*, £5 at 21. All rest of estate to wife *Sarah Audley*, desiring her to be kind to her and my dau. *Mary Audley*. Extrix., wife *Sarah*. Signed, *Will. Audley*. Wits., *Will. Manlove*, *Danby Pickering* and *Jno. World*. Proved 8 Apl. 1727 by the extrix. [P.C.C., Farrant 81].

HENRY AUDLEY, of Buckingham, co. Bucks., glazier. Will dated 12 Mch. 1730/1. To kinsman *William Burley*, sen., my dwellinghouse in Buckingham, with the orchard and garden, the dwelling house of *Ralph Pursell* on the west and the dwelling house of *William Clarke* on the north east, he paying my bror. *Richard Audley* £60, and if he be dead then to his dau. To kinsman *Conoway Watts*, of Brackley, my stock of glass and lead. To poor of Buckingham, 40s/-. Resid. legatees, the nine children of my kinsman *Burley*. Exors., said kinsman, *William Burley*, sen. Signed, *Henry Audley*. Wits., *Will. Turpin*, *John Clogton*, and *Wm. Little*. Proved 12 July 1733 by the exor. [Archdeaconry Court of Bucks., 1733, No. 91, at Somerset House].

JOSEPH AUDLEY, of Brooke Green, Hammersmith, gardener. Will dated 10 Aug. 1749. To eldest dau. *Mary White*, wife of *John White*, 1s/-. Resid. legatee and extrix., wife *Mary*. Signed, *Joseph Audley*. Wits., *Elizabeth Devern*, *Frans. Clarke*. Proved 28 Aug. 1749 by the extrix. [Commissary Court of London, Reg. 74, at Somerset House].

CHANCERY PROCEEDINGS

AUDLEY v. BRIDEOAKE

17 Apl. 1662. Complaint of *Joseph Audley*, of St. Bartholomews Exchange, London, cutler, that one *Grant*, Dr. of Divinity, parson of St. Bartholomews Exchange, London, being seised in the right of the said church of a small shop in Bartholomew Lane, about 10 years ago demised same to *Sarah*, complainant's wife, at a rent of £5 a year, and soon after said lease was made complainant married said *Sarah* and the lease became invested in him and said lease was confirmed by the next parson and by the present one, *Ralph Brideoake*, D.D. (continues *re* said lease).

25 Apl. 1662. Answer by *Ralph Brideoake* and others concerning said lease: mention of *Sarah*, late wife of complainant [C.P. before 1714, C.10, Whittington 94/7].

AUDLEY *v.* WATTS

[*date torn away*]. Complaint by *Paul Audley*, citizen and painter-stainer of London, that *Richard Watts*, of Gray's Inn, co. M'sex, esq., being lawfully seised of a messuage and piece of garden ground in Covent Garden, co. M'sex, by deed bearing date 24 Sept. 1658 conveyed the same to complainant and his heirs and therefore he ought to enjoy the same. But now one *Barbara Wood* and *Richard Watts* have combined and got into their hands all the deeds and evidences concerning the same; he therefore desires they may be caused to appear to answer the premises [C.P. before 1714, C.10, Whittington 469/3].

AUDLEY *v.* WOOD

19 Feb. 1662/3. Answer of *Barbara Wood*, widow, to complaint of *Paul Audley*, saying she does not believe *Richard Watts* was seised of the messuage, etc., in bill named [see preceding], nor does she know of any conveyance to complainant. She says she is of right seised of the premises and complainant has no title therein, but that same were granted by the *Earl of Bedford* to *Andrew Wood*, who conveyed same to this defendant, which conveyance is all the deed or writing in her custody [C.P. before 1714, C.10, Whittington 93/2].

STATIONERS COMPANY *v.* AUDLEY

30 Nov. 1669. Complaint by the Master and Keepers or Wardens of the Mystery or Art of Stationers of London that *John Audley*, late citizen and stationer of London, decd., *Paul Audley*, citizen and painter of London, and *Joseph Audley*, citizen and blacksmith of London, by their bond bearing date 6 Jany. 1662/3 became bound to complainants in £100 for the payment of £50 on 7 Jany. 1665/6 at Stationers Hall, Paternoster Row. The said sum was not paid and the bond was burnt in the late dreadful fire in September 1666. Since the making of the said bond *John Audley* has died, and although often asked, *Paul* and *Joseph Audley*, knowing the said bond to be burnt, have always refused to pay, and they therefore desire *Paul* and *Joseph Audley* may be summoned to appear to answer the premises [C.P. before 1714, C.5, Bridges 560/40].

WALKER *v.* AUDLEY

10 Feb. 1675/6. Complaint by *William Walker*, of London, exor. of will of his late father, *William Walker*, decd., that in 1662 said decd. had procured *Joseph Audley* to be nominated sword cutler to the King and on 13 May 1662 they became partners in said business, to be managed in name of *Joseph Audley* only. And same continued until said *Walker's* death in August last, whereby much money is due to said *Walker*. The said *Audley* untruly alleges the partnership had come to an end some time ago, and as *Walker's* witnesses are dead he desires said *Audley* may be summoned to answer the truth of the premises (no answer attached) [C.P. before 1714, C.5, Bridges 572/90].

WILFORD *v.* AUDLEY

25 Oct. 1679. Complaint by *Thomas Wilford*, of St. Gabriel Fenchurch, London, apothecary, and *Ann* his wife, dau. of *Joseph Audley*, of St. Bartholomew Exchange, London, cutler, that said *Joseph* was seised of a good estate and died leaving one son, *Paul Audley*, and one dau. [*illegible*], and he mard. *Millicent Goldby*, widow, promising to leave her £600; (continues as in 439/20 and 440/9, etc., see *post* pp. 70-71).

8 Mch. 1679/80. Answer of *Millicent Audley*, widow, denying she procured her husband's signature to a deed to secure her £600 at his death, but when proposed to him he refused to sign it, saying it was too late, nor does she believe such a deed exists [C.P. before 1714, C.5, Bridges 579/4].

WILFORD *v.* MARTLEW and AUDLEY

25 May 1680. Complaint by *Thomas Wilford*, citizen and apothecary of London, and *Anne*, his wife, dau. of *Joseph Audley*, late of par. of St. Bartholomew Exchange, London, cutler, decd., that said *Joseph* was seised of a messuage called the Dolphin in High Holborn, near Fulwood Rents, and by his will bearing date 7 Sept. 1678 bequeathed same to said *Anne* in tail male, the same being now in possession of *John Martlew*. The said *Joseph Audley* died 26 Sept. 1678, and, going to take possession of said house, complainants found *John Martlew* there holding same by lease made 2 Dec. 1669 for 21 years, at a rental of £40 a year. He paid the rent of some years, but now confederating with *Paul Audley*, eldest son and heir of said *Joseph*, refuses to pay the rent and denies complainants have any title thereto.

22 June 1678 [*sic*]. Answer of *Paul Audley*, confirming complainant's bill and denying he has combined with *Martlew*, who refuses to pay his rent.

10 June 1680. Answer of *John Martlew* that he has not paid rent to complainants, because the relict of the said *Joseph Audley* claimed dower out of same [C.P. before 1714, C.10, Whittington 140/79].

AUDLEY, etc. v. NELTHROP, etc.

[no date] Complaint by *Paul Audley*, son and heir and residuary legatee of *Joseph Audley*, late citizen and sword cutler of London, decd., and *George Sterman*, citizen and clothworker of London, surviving exor. of said *Joseph Audley*, that said *Joseph* had great intimacy with *Sir George Wharton*, bart., Paymaster of the Ordnance in the Tower of London, since decd., and *Joseph* being sword cutler to the King delivered great quantities of arms to the Tower for his Majesty's use to said *Wharton*, and *Henry Nelthrop*, of London, goldsmith, having married a dau. of *Sir George Wharton*, the said *Joseph* was very intimate with him and in 1675 complainant was apprenticed to *Nelthrop*. *Joseph* made his will 7 Sept. 1678. Concerning a debt of £300 which complainant alleges *Nelthrop* and others owed his said father [C.P. before 1714, C.7, Hamilton 3/19].

AUDLEY v. NELTHORPE

22 Nov. 1680. Complaint by *Paul Audley*, son and heir and residuary legatee of *Joseph Audley*, late citizen and sword cutler of London, decd. (sets out as in 440/56). *re* debts owing to said *Joseph* by *Henry Nelthorpe*, goldsmith. 19 Jan. 1680/1. Answer of *Henry Nelthorpe* that he married a dau. of *Sir George Wharton*, and in that connexion he may have paid several sums for *Sir George* to said *Joseph Audley*, and he took complainant as his apprentice, and was to have had £100 with him, but never received same. He says he furnished several sums of money to *Audley* on his bond, and denies that he, defendant, is indebted to *Audley*. He believes *Joseph Audley* kept books of account, which defendant cannot discover, as same are concealed from him, but which would prove the truth of his statements [C.P. before 1714, C.5, Bridges 440/64].

MARTLEW v. AUDLEY

19 Mch. 1680/1. Complaint by *John Martlew*, of High Holborn, co. M'sex, victualler, that *Joseph Audley*, citizen and blacksmith of London, was in his lifetime lawfully seized of a messuage called the Golden Dolphin in High Holborn, near Fullers Rents, and promised complainant on payment of £100 to put same into good repair and to let same to him at a rental of £40, and afterwards arranged rental to be £30. *Audley* made his will 7 Sept. 1678, bequeathing to his dau. *Anne*, wife of *Thomas Wilford*, the said messuage, in tail male, in default to his son, *Paul Audley*, and his heirs for ever, his brother *Francis Audley* to have £10 a year out of said rent for life. Now the said *Paul Audley*, *Thomas Wilford*, of London, apothecary, and *Anne* his wife, *Millicent Audley*, relict of said *Joseph*, and *Francis Audley*, brother of *Joseph*, and *Nathaniel String*, *William Edwards* and *George Stirman*, exors. of will of *Joseph*, combine together to try and make complainant pay the arrears of £10 a year, saying the tenement was let at £40, not £30.

22 Apl. 1681. Answer of *Thomas Wilford*, his wife *Anne*, and *Millicent Audley*, relict of said *Joseph Audley*, that said rent was £40 a year and denying that any abatement was made of said rent [C.P. before 1714, C. 10, Whittington 139/71].

AUDLEY v. GOLD

23 May, 34 Chas. II. (1682). Answer of *Sir Thomas Gold*, bart., *Adrian Scrope*, *Thomas Townesend*, and *Stephen Evance*, to bill of complaint of *Paul Audley* and *George Sterman*, that they believe before *Joseph Audley's* death he had great intimacy with *Sir George Wharton*, bart., Treasurer of the Ordnance in the Tower of London, and that *Joseph Audley* was by trade a sword cutler and was also sword cutler to the King. *Joseph Audley* put complainant *Paul*, his son, apprentice to *Henry Nelthorpe*, goldsmith, in Lombard Street, and they know nothing of the conditions, or the behaviour of *Paul*. *Nelthorpe* and *Joseph Audley* had dealings in money, as may be seen by the former's book, but they know nothing as to whether *Nelthorpe* intended to defraud *Joseph Audley*. They know that without *Nelthorpe's* money *Audley* could not have carried on his trade. *Joseph Audley* could write and read very well and his name subscribed to his bonds is written in a plain and legible hand. They believe complainant, *Sterman*, was the only exor. named in *Joseph Audley's* will who took upon him the burden of exorship.

[1678] conveyed to *Nathaniel Kent* two closes of pasture in Shaldeston, called Old Wick and Further Hayes, for 500 years, the same to be void on repayment of certain money and aforesaid debt. *Mary Binyon* has married *Thomas Audley*, of Buckingham, and complainant has paid her £200 and interest due, and £150 still remains to be paid, but said *Thomas Audley* and *Mary* his wife and *Susanna Binyon* combine to extort money from him and put him to excessive charge [C.P. before 1714, C.7, Hamilton 576/107].

STERMAN *v.* AUDLEY

20 Apl. 1683. Answer of *Millicent Audley* to bill of complaint of *George Sterman*, that *George Sterman* was exor. to her late husband *Joseph Audley*, and she does not believe that he has done what he could to collect the debts due to her late husband for the benefit of her and her children. She confesses she has received divers of decd.'s household goods, but is not aware that she has received her full share. She has given a receipt to complainant for all sums of money received of him [C.P. before 1714, C.5, Bridges 561/4].

AUDLEY *v.* STERMAN, *etc.*

7 May. 1683. Complaint by *Millicent Audley*, of London, widow, relict of *Joseph Audley*, citizen and blacksmith of London, decd., that it is customary in city of London for the relict of freemen of that city to have a third of the residue of their husband's estate, the said *Joseph* made his will 7 Sept. 1678 and out of the third or testamentary part of his estate he devised to her and her dau., *Mary Goldby*, a messuage in . . . [illegible], near the Poultry, London, for their lives, and to his son *Paul* the messuage where he then lived in par. of St. Bartholomew Exchange, London, and a messuage in Lothbury, another in Redcross [? Redrose] Street, Covent Garden, and to his dau. *Ann*, wife of *Thomas Wilford*, in tail male, a messuage called the Golden Dolphin in Holborn, co. M'sex, and four messuages in Clerkenwell Green; he made his said son *Paul* residuary legatee and appointed *Nathaniel String*, *William Edwards* and *George Sterman* his exors. And he gave to complainant for life his messuage in Brook Green, Hammersmith, and by a codicil gave her and her dau. *Mary* £100. *Joseph Audley* died 27 Sept. 1678, and great part of his personal estate consisted of a debt of £4500 due from the King for swords, etc., delivered to the Tower of London. Deceased was a freeman of the Company of Blacksmiths. *George Sterman* alone proved will and she desires he and *Paul Audley*, *Nathaniel String*, *Thomas Wilford* and *Anne* his wife, and *Francis Overs* and *Mary* his wife may be summoned to declare value of estate of decd. and the reason they refuse to divide said houses and goods [C.P. before 1714, C.7, Hamilton 597/4].

AUDLEY *v.* STERMAN

[no date]. The demurrer of *George Sterman* to bill of complaint of *Millicent Audley*, that plaintiff's demand against defendant, as one of the exors. of *Joseph Audley*, is founded on the custom of the city of London, as she is widow and relict of said *Joseph Audley*, decd., who was a freeman of that city, yet she has not made *Paul Audley*, the residuary legatee, and *Ann Wilford*, another legatee, who are the children of said *Joseph*, parties to the bill as she ought to have done, nor has she made *Nathaniel String* and *William Edwards*, the other exors., parties to said bill. He desires to know therefore whether he is compelled to answer [C.P. before 1714, C.5, Bridges 439/20].

AUDLEY *v.* STURMAN

13 June 1683. Answer of *George Sturman*, one of the exors of the will of *Joseph Audley*, late citizen and freeman of London, to the bill of complaint of *Millicent Audley*, of London, widow, his relict. He says that said *Joseph* left a widow, the said *Millicent*, a dau. *Anne*, wife of *Thomas Wilford*, advanced in her father's lifetime, and a son *Paul*, wholly unadvanced. That by contract of marriage *Millicent*, on his death, was to have £600, in full as her dower, which has been paid her, and she was to give a general release for the same, and *Joseph* further gave her and her daus. by a former marriage, *Mary* and *Rebecca*, £10 each for mourning, and to complainant and her dau., *Mary Goldby*, a messuage in Sculding Alley, near the Poultry, London, for their lives, with remainder to *Anne Wilford* and her issue, in default to said *Paul*. He further bequeathed 40s/- a year to his nephew *William Audley*, and to *Joseph*, son of *Henry Audley*, £100, when of age, and to *Edward* and *Robert Newton*, and other sons of *Robert Newton*, of Newmarket, near Clements Inn, M'sex, £50 each when of age, and £10 a year to *Mary*, wife of said *Robert Newton*, to *Francis Audley* £25, to *Thomas Audley* £100, and to *Paul Audley*, testator's only son, a messuage in par. of St. Bartholomew Exchange and a house in Lothbury, and other messuages to *Paul* and

Anne Wilford. He has not yet collected all the debts due to testator, and the suit with *Nelthorp* is still pending, and when same are all settled will make the payments prescribed by same will [C.P. before 1714, C.5, Bridge 440/9].

AUDLEY v. AUDLEY

5 Nov. 1683. Answer of *Millicent Audley*, widow, relict of *Joseph Audley*, decd., defendant, to bill of complaint of *Paul Audley*. She denies she entered into an agreement before her marriage with *Joseph Audley*, either with *Mr. Griffin* named in the bill, or any other, as far as she can remember, but it is above 21 years since the said marriage took place. Her husband agreed she was to have £600 in six months after his death, in satisfaction of her thirds, according to the custom of the city of London [C.P. before 1714, C.9, Reynardson 108/8].

AUDLEY v. AUDLEY

27 Nov. 1683. Answer of *Paul Audley*, gent., to bill of complaint of *Millicent Audley*, widow. He says he is the eldest and only son and heir of *Joseph Audley*, decd., and that complainant is widow of said *Joseph*, who was a freeman and citizen of London and made a will as set forth in bill of complaint. At the time of her marriage to said *Joseph Audley*, complainant was a widow with children, but, being past childbearing age, was not like to have any by said *Joseph*, and it was agreed between them that if *Joseph* died before her she was to have £600, in lieu of a third of the estate [C.P. before 1714, C.5, Bridges 438/34].

WILFORD v. AUDLEY

4 Feb. 1684/5. Complaint by *Thomas Wilford*, citizen and apothecary of London, and *Ann* his wife, dau. of *Joseph Audley*, late citizen and blacksmith of London, decd., *Francis Audley*, of the Tower Hamlet, blacksmith, brother of *Joseph Audley*, *Robert Newton*, of St. Clement Danes, co. M'sex, oilman, and *Mary* his wife, and *Edward* their son, and their infant sons *John* and *Richard Newton*, that *Joseph Audley* was seised in his lifetime of considerable real estate and of divers leases of houses in London, and of debts upon tallies, and of goods belonging to the trade of a sword cutler, and made his will 7 Sept. 1678, bequeathing to *Ann Wilford* in tail male the freehold messuage called the Golden Dolphin in Holborn, and if *Ann* died without male issue, then same to his son *Paul Audley* and his heirs, *Francis Audley*, brother of *Joseph*, to have £10 a year out of same, and to said *Ann* he gave his four houses in Clerkenwell Green, and the bowling alley there, and a fourth part of his household goods; a moiety of said goods to his then wife *Millicent*, and remainder to his son *Paul*. He gave his brother *Francis* £25. He gave *Robert* and *Mary Newton* £10 each, and to said *Mary* £10 a year for life out of his houses and shops in St. Bartholomew Lane, London, and he gave *Edward*, *John* and *Richard Newton* £50 each at their ages of 21. He made his son *Paul* residuary legatee (the overplus amounting to some thousands of pounds), and *Mr. William Edwards*, now decd., *Mr. Nathaniel String*, & *Mr. George Sterman* his exors. Soon after *Joseph* died and *String* and *Edwards* renounced exorship, and *George Sterman* proved the will and entered into *Joseph's* estate, being £6000 and more. He ought to have paid *Joseph's* debts and said legacies, but, combining with said *Paul Audley*, has not paid said legacies, but alleges he has paid all to *Paul* who was not to have his residue until the legacies had been paid. They therefore desire that *Nathaniel String*, *Paul Audley* and *George Sterman* may be summoned to answer the premises [C.P. before 1714, C.8, Mitford 272/122].

WILFORD v. AUDLEY

17 Feb. 1684/5. Answer of *George Sterman*, exor. of will of *Joseph Audley*, to bill of complaint of *Thomas Wilford* and his wife, *Francis Audley* and others. He says he cannot obtain the money due from the King to said *Joseph Audley*, and has given a true account to *Millicent Audley*, relict of testator. He says it is true what is said of the will in bill of complaint; he has paid the debts, but has not sufficient assets in hand to pay said legacies to *Newton*, his wife and children, or to *Francis Audley*, and the lands were given by order of this court to *Paul Audley* and did not come into his hands. *Anne Wilford* had a portion of £500 in her father's lifetime, and a freehold house in Holborn by said will, which she has enjoyed since testator's death.

17 Feb. 1684/5. Answer of *Paul Audley*, only son and heir and residuary legatee of *Joseph Audley*, decd., in accordance with the above. He disclaims knowledge of legacies beyond what he knows of the will, and denies all combination and confederacy [C.P. before 1714, C.8, Mitford 272/125].

AUDLEY v. CAWTHORNE

13 Apl. 1687. Complaint by *Paul Audley*, the younger, of Hammersmith, co. M'sex, gent., son and heir of *Joseph Audley*, late citizen and cutler of London, decd., that *Richard Cawthorne*, of Mark Lane, London, about 12 years ago borrowed £100 of said *Joseph* and gave a bond for same (continues *re* said bond).

19 Apl. 1687. Answer of *Richard Cawthorne re* same [C.P. before 1714, C.5, Bridges 438/37].

Answer of *Francis Overs* and *Mary* his wife to bill of complaint of *George Stirman*, exor. of will of *Joseph Audley*, late citizen and cutler of London, deed., *Paul Audley*, son and heir and residuary legatee of deed., *William Channells*, *Jasper Latham*, *Thomas Watkinson*, *Andrew Danes*, and *Charles Browne*, creditors of deed., complainants, that they believe he made a will as is set forth in the bill, but do not believe an agreement was ever made as alleged between *Joseph Audley* and *Millicent* his wife that she should have £600 instead of the third part due to her, but they find the said *Millicent Audley*, 6 May 36 Chas. II. [1684], sued *George Stirman* and *Paul Audley* for her third or customary part, and a decree was made thereon, and they paid her £60 for her costs and put her in possession of a third part of her late husband's houses in Bartholomew Lane, London. *Millicent* died 13 Nov. last past, and she bequeathed to *Samuel How*, of St. Brides, London, gent., and *Henry Lobb*, of St. James, Westminster, joiner, all her right and title to houses in Bartholomew Lane, Lothbury, London, and her rents in Scalding Alley, near the Poultry, London, to pay the rents and profits to her dau. *Mary Overs*, she providing for testator's dau. *Rebecca Fletcher's* three children, viz. *Robert*, *John*, and *Millicent Fletcher*, which she had by *Robert Fletcher*, and after *Mary Overs's* death to her children, *Mary*, *Millicent* and *Francis Overs*. She made said *Mary Overs* her extrix. ; the will was dated 17 Sept. 1696. They do not consider themselves accountable to complainants for the personal estate of said *Millicent* [C.P. before 1714, Bridges 184/101].

Among the Skinners' Company apprenticeships is that of Paul Audcley, son of Thomas, of the town of Buckingham, cordwainer, to John Batten, at Michaelmas 1576, for 9 years (*Miscellanea Genealogica et Heraldica*, 3rd Series, I., 42).

The Bishop of London licenced Joseph Awdley, of St. Bartholomew Exchange, blacksmith, widower, about 34, on 24 May 1662, to marry Millicent Goldbey, of St. Vedast, widow, about 34, at St. Peter's, Paul's Wharf (Genealogical Society's Index). The Chancery suit of 27 Nov. 1683 described her as "past childbearing age" at the time of this marriage (see *ante*, p. 71).

A licence was issued from the Faculty Office of the Archbishop of Canterbury, on 14 Dec. 1677, for the marriage of Thomas Wilford, of St. Gabriel Fenchurch, London, bach., 25, and Anne Audley, spinster, 24, dau. of Joseph Audley, of St. Bartholomew by the Exchange, London, gent., who consents; at Tottenham, Edmonton, or Enfield, M'sex (*Harleian Society*, XXIV., 141).

William Audley, of St. Andrew, Holborn, M'sex, bach., 30, was licensed by Bishop of London, on 19 May 1720, to marry Sarah Bird, of same, spinster, 25, at St. Andrew (Genealogical Society's Index).

Henry, son of Richard Audley, of Hammersmith, M'sex, was apprenticed on 6 Oct. 1711 to Henry Howard, of St. James, Westminster, silk dyer; consideration, £5 (Genealogical Society's Index).

Mr. John White, of Stroud, Kent, and Mrs. Mary Audley, of Hammersmith, M'sex, were mard. 2 Feb. 1746/7 at St. George's Chapel, Mayfair (*Harleian Soc.*, "Register Section," XV., 76).

One "Jos. Audley" was apprenticed to Thomas Tompion, the clockmaker, in 1683 (F. J. Britten's *Old Clocks and Watches and their Makers*, 5th ed. 1922, p. 636).
