XXIII. 1942 23. THOMAS PERCY HENRY (TOUCHET-JESSON), LORD AUDLEY, distant cousin and h., being s. and h. (by Thomas JESSON), of Charlotte Anne (*d.* 1 Mar. 1912), yst. but only child to leave issue, of John Nicholas THICKNESSE-TOUCHET (*d.* 21 July 1861), by Elizabeth Montgomery, da. of John Henry BLENNERHASSET, of Tralee, co. Kerry, which John was 2nd s. of the 20th Lord Audley. He was *b.* 15 Sep. 1913; ed. at Lancing Coll. He *m.* 1stly, 15 Nov. 1952, June Isabel, only da. of Lieut. Col. Reginald CHAPLIN, and formerly wife of Rudolph Edgar Francis DE TRAFFORD. This marriage was diss. by divorce in 1957 and she *d.* in 1977. He *m.* 2ndly, 26 Apr. 1962, Sarah Millicent Hermione,

2nd da. of Rt. Hon. Sir Winston Leonard Spencer CHURCHILL and formerly wife of Vic Oliver of Vienna, and of Anthony Beauchamp. He *d. s.p.* 3 July 1963. His widow *d.* in 1982.

XXIV. 1963 24. ROSINA LOIS VERONICA, *born* TOUCHET-JESSON, sister and h., *b.* 10 July 1911. She *m.*, 24 Apr. 1943, John Archibald Joseph, yr. s. of Bernard MACNAMEE of Glasgow. He *d.* 1969. She *d. s.p.* 24 Oct. 1973.

XXV. 1973 25. RICHARD MICHAEL THOMAS (SOUTER), LORD AUDLEY, cousin and h., being s. of Sir Charles Alexander SOUTER (*d.* 9 Jan. 1958), by Charlotte Dorothy JESSON, which Charlotte Dorothy Jesson was 2nd da. of Charlotte Anne by Thomas JESSON – which see in the lineage of the 23rd Baron. He was *b.* 31 May 1914; ed. at Uppingham. He *m.*, 18 Oct. 1941, Lily Pauline, da. of Dallas Louis ESKELL of Exmouth, Devon.
