- I. Hen. III. 1. **{ZA5}** HENRY DE ALDITHLEY, living 1236.
- II. Hen. III. 2. **{ZA6}** JAMES DE ALDITHLEY, **son** and **heir**; ob.(**died**) 1271.
- III. Hen. III. 3. **{ZA7}** JAMES DE ALDITHLEY, **son** and **heir**; ob.(**died**) 1272, S. P.(**without issue**)
- IV. Edw. I. 4. **{ZA8}** HENRY DE ALDITHLEY, **brother** and **heir**; ob.(**died**) 1275, S. P.(**without issue**)
- V. Edw. I. 5. **{ZA9}** WILLIAM DE ALDITHLEY, **brother** and **heir**; ob.(**died**) 1281, S. P.(**without issue**)
- VI. Edw. I. 6. **{ZA10}** NICHOLAS DE ALDITHLEY, **brother** and **heir**; **summond** 26 Jan. 25 Edw. I. 1297; but it is doubtful if that writ can be considered as a regular **summons** to **Parliament** (*vide* FITZ-JOHN); ob.(**died**) 1299.
- VII. Edw. I. 7. **{ZA11}** THOMAS DE ALDITHLEY, **son** and **heir**; ob. (**died**) infra æt. 1307, S.P. (**without issue**)

- I. 1313. 8. **{ZA12}** NICHOLAS DE ALDITHLEY, **brother** and **heir**; he married Joane, daughter of William I. 6th Baron Martin, and sister, and eventually sole **heir** of William II. 7th Baron Martin; **summond** to **Parliament** from 8 Jan. 6 Edw. II. 1313, to 25 Aug. 12 Edw. II. 1318; ob. (**died**) 1319.
- II. 1330. 9. **{ZA13}** JAMES DE ALDITHLEY, æt. 14, 1326, the celebrated Lord Audley, **son** and **heir**; **summond** to **Parliament** from 25 Jan. 4 Edw. III. 1330, to 8 Aug. 10 Rich. II. 1386; K.G.; ob. (**died**) 1386.

Comment: the person above was NOT a Knight of the Garter

- III. 1387. 10. **{ZA16}** NICHOLAS DE ALDITHLEY, **son** and **heir**; **summond** to **Parliament** From 17 Dec. 11 Rich. II. 1387, to 12 Sept. 14 Rich. II. 1390; ob. (**died**) 1392, S. P. (**without issue**), leaving **{ZC2}** John Tuchet, **son** and **heir** of **{ZC1}** John Tuchet, **son** and **heir** of his sister **{ZA14}** Joan by **{ZT18}** Sir John Tuchet, then æt. 20; **{ZA15}** Margaret, wife of Sir Roger Hillary, another of his sisters, then æt. 40, but who died S.P.(**without issue**) 1410; and Fulk, son of Fulk Fitz-Warin, son of **{ZA20}** Margery, half-sister of the said Nicholas, his next heirs. The said,

- IV. 1405. 11. **{ZC2}** *JOHN TUCHET, was **summond** to **Parliament** from 21 Dec. 7 Hen. IV. 1405, to 26 Aug. 9 Hen. IV. 1408, as "Johanni Tuchet;" ob. **(died)** 1409.

*Comment The * before the name denotes that there is proof of Sitting in the Rolls of Parliament*

- V. 1421. 12. **{ZC3}** *JAMES TUCHET, **son** and **heir**, æt. 10, **summond** to **Parliament** from 26 Feb. 8 Hen. V. 1421, to 26 May, 33 Hen. VI. 1455, as "Jacobo de Audley;" slain at Blore Heath, 1458.
- VI. 1461. 13. **{ZC4}** *JOHN TUCHET, **son** and **heir**, **summond** to **Parliament** from 26 May, 1 Edw. IV. 1461, to 9 Dec. 1 Rich. III. 1483, as "John de Audley" ob. **(died)** 1491.
- VII. 1492. 14. **{ZC5}** *JAMES TUCHET, **son** and **heir**, **summond** to **Parliament** from 12 Aug. 7 Hen. VII. 1492, to 16 Jan. 12 Hen. VII. 1497; beheaded and attainted 1497, when his honours became **Forfeited**.
- VIII. 1512. 15. **{ZC6}** JOHN TUCHET, **son** and **heir**, restored in blood and honours 1512; **summond** to **Parliament** from 23 Nov. 6 Hen. VIII. 1514, to 21 Oct. 2 and 3 Phil. and Mary, 1556;¹ ob. **(died)** ante **(before)** 20 Jan. 1558.
- IX. 1558. 16. **{ZC7}** GEORGE TUCHET, **son** and **heir**, **summond** to **Parliament**, and took his seat in the House of Lords 20 Jan. 1558; ob. **(died)** 1560.
- X. 1560. 17. **{ZC19}** HENRY TUCHET, **son** and **heir**, never sat in **Parliament**; ob. **(died)** 30 Dec. 1563.
- XI. 1563. 18. **{ZC20}** GEORGE TUCHET, **son** and **heir**, æt. 12, 1563; **summond** to **Parliament** from 30 Sept. 8 Eliz. 1566, to 5 April, 12 Jac. 1614; created Earl of Castlehaven in Ireland, 6 Sept. 1617; ob. **(died)** 1617.

- XII. 1617. 19. **{ZC21}** MERVIN TUCHET, **son** and **heir**, Earl of Castlehaven, beheaded (having been attainted of felony) in 1631, when this Barony became Forfeited.
- XII. 1634-78. 20. **{Z56}** JAMES TUCHET, **son** and **heir**, restored to the name, style, state, degree, dignity, title, and honour of Baron Audley of Hely, and to his heirs for ever, by letters patent, 3 June 1634, subsequent to which his precedency in the House of Lords was that of the ancient Barony; but by an Act of **Parliament** 29 and 30 Car. II. 1678, "the said James Lord Audley, Baron Audley of Hely, Earl of Castlehaven, and the heirs of his body begotten, and immediately after them, Mervin Tuchet, 3rd son of the said Mervin Lord Audley, and the heirs of his body begotten, and after them, then the daughters of the said Mervin Lord Audley and their heirs, shall and may from henceforth have, hold, and enjoy, and shall be and are hereby restored unto the honour, dignity, state, authority, and title of Baron Audley of Hely, with all and every the privileges, rights, precedencies, and pre-eminences thereunto belonging, as fully, amply and honourably to all intents and purposes as the said Mervin Lord Audley at any time, or the said George Lord Audley at any time during his life, did or might hold and enjoy the same, any matter, cause, or thing whatsoever to the contrary notwithstanding, and as fully, amply, and honourably as if George Tuchet,² 2nd son of the said Mervin Lord Audley, now beyond the seas, were naturally dead without issue." This Act may have been occasioned by objections made to the right of James Lord Audley to precedence under the patent of 1634; for it is clear that in former instances it had been considered that the authority of the Legislature was necessary to restore a dignity lost by attainder. - XIV. 1684. 21. **{ZC24}** MERVIN TUCHET, **brother** and **heir**, Earl of Castlehaven in Ireland; ob. **(died)**

¹ The name of *John* Tuchet Lord Audley regularly recurs in Dugdale's *List of Summons* until 23 Jan. 1 Eliz. 1559, but, as it appears from the *Lords' Journals*, vol. i. p.514, that on 20 Jan. 1558, *George* Tuchet Lord Audley, having been summ. to that **Parliament**, took his seat in the House, it is manifest that Dugdale's statement is erroneous

- XV. 1686. 22. {ZC25} JAMES TUCHET, son and heir, Earl of Castlehaven in Ireland; ob. (died) 1700.
- XVI. 1700. 23. {ZC26} JAMES TUCHET, son and heir, Earl of Castlehaven in Ireland; ob. (died) 1740.
- XVII. 1740. 24. {ZC27} JAMES TUCHET, son and heir, Earl of Castlehaven in Ireland; ob. (died) 1769, unmarried
- XVIII. 1769. 25. {ZC69} JOHN TALBOT TUCHET, brother and heir, 8th and last Earl of Castlehaven in Ireland; ob. (died) 1777, S.P.(without issue)
- XIX. 1777. 28. {ZC70} GEORGE THICKNESSE (assumed in 1783 the name of) TUCHET, nephew and heir, being son and heir of Philip Thicknesse, by {ZC28} Elizabeth, sister and sole heir to the last Baron; ob. (died) 24 Aug. 1818.
- XX. 1818. 27. {ZC71} GEORGE JOHN THICKNESSE TUCHET, son and heir, ob. (died) 14 Jan. 1837.
- XXI. 1837. 28. {ZC72} GEORGE EDWARD THICKNESSE TUCHET, son and heir, present Baron Audley; his Lordship is also heir general of the Barony of Martin created by writ 23 Edw. I., and also of that of Traci by tenure.

- I. 1321. 1. {ZA23} Hugh DE ALDITHLEY, or AUDLEY, supposed to have been a younger brother of Nicholas, I. 8th Baron Audley; summons to Parliament, as "Hugh de Audley, Seniori," 15 May, 14 Edw. II.³ 1321; ob. .

- II 1317. 2. {ZA24} HUGH DE AUDLEY son and heir, summons to Parliament v.p.(in the lifetime of his father) From 20 Nov 11 Edw. II 1317 to 15 May, 14 Edw. II 1321 as "Hugh de Audley Juniori" and from 3 Dec. 20 Edw. II 1326, to 24 Aug. 10 Edw III 1336 as "Hugh de Audlie;" having married Margaret, daughter and coheir of Gilbert de Clare, Earl of Gloucester, he was created Earl of Gloucester, 16 Mar. 1337; ob. (died) 1347 S.P.M (without male issue) {Z25} Margaret, his sole daughter and heir married Ralph Lord Stafford, and this Barony is consequently presumed to have been merged in that of Stafford, of the descent and present state of which a full account is given under that title; and it is only necessary to observe, that on the attainder of Edward Duke of Buckingham in 1521, this Barony, together with his other honours, became Forfeited

- 1 1538 1. {ZW5} THOMAS AUDLEY; created Baron Audley of Walden, co. Essex, 29 Nov 1538; Lord Chancellor 1532; K.G.; ob (died) 1544 S.P.M. (without male issue), when the Barony became Extinct

³ Dugdale, v.i. p. 750, states that this Hugh was summons to Parliament 11 Edw. II. Nov. 1317; but on referring to his *Lists of Summons* it appears that it was to his son, "Hugh de Audele Juniori" that that Writ was directed.

That eminent author also asserts that there was a "James de Aldithley" of this family summons to Parliament from 8 Hen. V to 33 Hen VI, but of whom he gives no further information: it is almost certain, however that he confounds him with James Tuchet V 12th Baron of Audley, who was summons from 8 Hen. V to 33 Hen VI, as "Jacobus de Audley"
